### **Emphasis of Matter**

As discussed in Note I, recordkeeping changed during 2023. In 2024, the new recordkeeper recognized stale notes receivable from participants as assets, not deemed distributions, as was previously recorded by the former recordkeeper. As a result, the notes receivable balance at December 31, 2023 was restated by \$156,918. Our opinion is not modified with respect to that matter.

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024

#### NOTE A – DESCRIPTION OF PLAN

The following description of the Community Coordinated Care for Children 401(k) Plan (the Plan), as amended and restated effective July 1, 2015, provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions.

##### 1. General

The Plan, established on January 1, 1990, is a defined contribution plan covering all eligible employees of the Community Coordinated Care for Children, Inc. (the Company, Employer, or Plan Sponsor) who have reached the age of 21 and completed one year of service as of the next enrollment date (semi-annual). Collectively bargained employees are excluded from participating in the Plan. In general, one year of service is defined as a 12-month consecutive period after commencement of employment in which an employee works at least 1,000 hours. The Chief Executive Officer is responsible for oversight of the Plan and determines the appropriateness of the plan's investment offerings, monitors investment performance and reports to the plan's Board of Trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Minnesota Life Insurance Company (Minnesota Life) has been the plan's custodian since June 2, 2014 and is responsible for investing and managing the plan assets (subject to the direction of the plan participants).

##### 2. Contributions

Plan participants may voluntarily contribute, on a pre-tax basis, any amount of their qualified annual compensation, as defined by the Plan, up to the Internal Revenue Code (IRC) maximum limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained the age of 50 before the end of the plan year are eligible to make "catch-up" contributions. The maximum allowable pre-tax voluntary contribution, as determined by the Internal Revenue Service (IRS), was \$23,000 with a maximum "catchup" contribution of \$7,500 for 2024. All contributions are held in trust and invested by the plan's custodian in accordance with the options elected by the participants (i.e. all investments are participant directed).

The Company matches 25% up to the first 4% of the participant's qualified compensation, as defined in the plan document. The Company's match amounted to \$55,363 during the year ended December 31, 2024. The Company may also make discretionary matching contributions to eligible participants of the Plan who contribute to the Plan. This discretionary matching contribution may be made during the plan year or after the year-end and may be determined as a percentage of contributions or as a uniform dollar amount. The maximum Company's match will not exceed 4% of the base compensation. The Company did not make any discretionary profit sharing contributions for the year ended December 31, 2024. In addition, the Company also makes safe harbor contributions equal to 5% of the participants' annual compensation. The safe harbor contribution will be made whether or not the employee is making contributions to the Plan. The Company made a total of \$504,026 in safe harbor contributions during the year ended December 31, 2024. Any employer contributions made on behalf of a participant for which no investment direction is in effect shall be allocated to one of the Minnesota Life Target Age Funds based on the appropriate retirement fund for the participant, subject to the participant's right to transfer those funds in accordance with the Plan.

##### 3. Participant Accounts

Each participant's account is credited with the participant's contribution, Company's match, discretionary match, safe harbor contributions, plan earnings/losses, and charged with an allocation of administrative expenses. Allocations are based on participant's contributions or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### 4. Vesting

Participants are vested immediately in their voluntary contributions, Employer matching and discretionary matching contributions, and Employer safe harbor contributions plus actual earnings thereon.

##### 5. Investment Options

Upon enrollment in the Plan, a participant may direct all contributions in a variety of investment choices as more fully described in the plan's literature. Participants can change their contribution percentage the first day of each calendar quarter. Participants may change their investment options at any time.

##### 6. Payment of Benefits

Upon termination of service due to death, disability, or retirement, participants may elect to receive either a lump-sum amount equal to the value of their vested accounts, or receive regular installments over a period not to exceed their life expectancy. The normal retirement age, as defined by the Plan, is age 59 ½. Participants still employed who have reached age 70 ½ can defer payment of their benefits until their retirement date. If a participant terminates before retirement and has a vested account balance in excess of \$5,000, they may elect a lump sum payment or monthly, quarterly or annual installments over a specified period of time. Vested account balances less than \$5,000, will be distributed in a lump sum payment. In addition, hardship distributions are permitted if certain criteria are met. Hardship distributions are not allowed to be made from the Company's safe harbor contributions.

##### 7. Forfeitures

As participants are fully vested upon entrance to the Plan, there are no forfeited account balances.

##### 8. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of 50% of their vested account balance or \$50,000. A participant may have a maximum of five outstanding notes at any time. All notes are repaid within a period of five years, except notes for the participant's principal residence, which must be repaid in a reasonable period of time, not to exceed thirty years. The notes are collateralized by a portion of the balance in the participant's account and bear a fixed rate of interest based on the prevailing prime rate at the date of each note (6.25% - 9.50% as of December 31, 2024), and mature through April 2049. Principal and interest are repaid ratably through bi-weekly payroll deductions.

#### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Investment Valuation and Income Recognition

The Plan follows the fair value measurement requirements of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Plan Sponsor's Board of Directors determines the plan's valuation policies utilizing information provided by the investment custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold during the year as well as the change in the unrealized appreciation or depreciation on those investments during the year.

The Plan has invested in a fully benefit-responsive investment account with an insurance company. Fully benefit-responsive contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan invests in various investment securities. These investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the values of the investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Notes Receivable from Participants

In accordance with FASB ASU 2010-25, *Reporting Loans to Participants by Defined Contribution Pension Plans*, the Plan has classified loans to participants as notes receivable. The loans are recorded at principal plus any accrued and unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

4. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

5. Contributions

Contributions from plan participants and the matching and safe harbor contributions from the Plan Sponsor are recorded in the year in which the participant contributions are withheld from amounts paid. Employer discretionary matching contributions are recognized upon authorization of the Employer. All participant and Employer contributions are participant-directed.

6. Payment of Benefits

Benefits are recorded when paid.

7. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

8. Subsequent Events

The plan administrator has evaluated subsequent events through September 15, 2025, which is the date of the financial statements were available to be issued.

#### NOTE C – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive guaranteed investment contract with Minnesota Life. Minnesota Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Minnesota Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events, that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

#### NOTE D – FAIR VALUE MEASUREMENTS

FASB ASC 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts (PSAs): Valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities). While the majority of the underlying assets values are based on quoted prices, the NAV of the PSAs is not publicly traded. The NAV is reported by Minnesota Life as of the financial statement date based on recent transaction prices. The PSAs held by the Plan provide for daily redemptions at NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. There are no unfunded commitments. The investments in PSAs totaling \$10,665,437 and \$10,970,349 as of December 31, 2024 and 2023, respectively, are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient and, therefore, have not been categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE E – INVESTMENT INFORMATION CERTIFIED AND PROVIDED BY CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Minnesota Life, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31 and for the years then ended:

The Standard was the recordkeeper in 2024 and Securian Financial was the recordkeeper in 2023. Minnesota Life is the parent company of both The Standard and Securian Financial.

#### NOTE F – PARTIES-IN-INTEREST

Minnesota Life is the custodian of the Plan and Kestra Investment Services, LLC, and Stancorp Financial Group, LLC provided investment advisory services to the Plan; therefore, transactions with the custodian and investment advisor qualify as party-in-interest transactions. Total fees paid by the Plan for administration and investment advisory services amounted to \$42,865 for the year ended December 31, 2024. The Plan Sponsor also paid certain administrative expenses of the Plan that are not reflected in these financial statements of the Plan.

#### NOTE G – INCOME TAX STATUS

The Plan has adopted a standardized form of a volume submitter prototype plan sponsored by Minnesota Life Insurance Company. The volume submitter prototype plan has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service (IRS) as to the volume submitter prototype plan's qualified status. Although the Plan was amended August 1, 2021, the volume submitter prototype plan opinion letter has been relied upon by this Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that are more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE H – PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
