Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Longyear 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Longyear 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

1. Description of Plan

The following description of the Longyear 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a defined contribution plan pursuant to Section 401(k) of the Internal Revenue Code (IRC) covering substantially all full-time employees of JM Longyear, LLC; Longyear Harvesting and Transportation, LLC; Northern Hardwoods Lumber, LLC; and J.M. Longyear Manufacturing, LLC (collectively, Company, Employer, or Plan Sponsor) who have reached 18 years or older and are not a member of a collective bargaining unit (unless required under the terms of the specific collective bargaining agreement), nonresident alien, seasonal employee, intern, or a leased employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each employee who participates in the Plan is entitled to enter into a compensation reduction agreement with the Company. The amount of reduction shall be contributed by the Company on behalf of the participant into the Plan for allocation to the participant's account. These participant elective contributions are fully vested. The Plan also allows participants to make Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

Employees are enrolled on the entry date coinciding with the first of the month after hiring date or immediately following the date such employee reaches age 18.

The Employer makes safe harbor matching contributions which is equal to 100% of the first 4% of employee eligible compensation contributed to the Plan by the employee. The Employer may also make discretionary nonelective contributions. Participants who are employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year are eligible to receive Employer discretionary nonelective contributions. During 2024 and 2023, there were no discretionary nonelective contributions made to the Plan. Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

1. Description of Plan (continued)

Participant Accounts

Participant accounts are credited with participant contributions; Employer safe harbor matching contributions; and an allocation of Employer nonelective contributions, if any; and Plan investment results. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on compensation, participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants shall be permitted to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Such loans are secured by the balance of the participant's account and shall be charged an annual prevailing rate of interest to be fixed by the plan administrator. Such loans shall be fully repaid on or before five years from the date of disbursement unless the loan proceeds are used in connection with the purchase of a principal residence.

Vesting

Participants are immediately vested in their contributions and Employer safe harbor contributions, plus actual earnings thereon. Vesting in the Employer discretionary nonelective contributions portion of their account plus actual earnings thereon is based on years of credited service. A participant vests 25% each year and is 100% vested after four years of credited service, or upon termination of employment due to death or disability, or termination of the Plan.

Payment of Benefits

Upon attainment of retirement, termination, or other separation of employment (death, disability, or other reasons), participants may elect to receive their vested benefits as a lump-sum payment. In-service distributions at age 59½ are also allowed, as well as for financial hardship.

Forfeited Accounts

Forfeitures of non-vested Employer contributions shall be used to reduce the Employer's matching contributions or reduce administrative expenses under the Plan. As of December 31, 2024, the balance of forfeited non-vested accounts was \$72 and \$0 as of December 31, 2023. Forfeitures used during 2024 totaled \$0 and \$655 during 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract valued at contract value). Mutual funds are reported at fair value as determined using quoted market values as of the last day of the Plan year. The Plan holds an investment in a collective investment trust. The fund within the collective investment trust trades at the net asset value (NAV) which is based on the contract value of the underlying investments and approximates fair value (Level 1). The NAV per share is used as a practical expedient for determining the fair value of the investment. See Note 8 and Note 10 for discussion of fair value measurements and investment valuation and Note 9 for discussion on the fully benefit-responsive investment contract. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The change in the aggregate fair value and the cost of investments sold, purchased, and held is reflected in the statements of changes in net assets available for benefits as net appreciation in fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded as deductions upon distribution.

Administrative Expenses

Plan administrative expenses are paid by either the Plan or the Company, as provided in the plan document.

Use of Estimates

The process of preparing financial statements in conformity with U.S. GAAP requires management of the Plan to make estimates and judgments that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from estimated amounts.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Subsequent Events

The Plan has evaluated subsequent events for potential recognition and disclosure in the financial statements through August 11, 2025, the date which the financial statements were available to be issued.

3. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Income Tax Status

The Plan has adopted a Fidelity Management & Research Company (FMR) non-standardized pre-approved plan. FMR received an opinion letter for the non-standardized pre-approved plan on June 30, 2020, stating that the Plan is acceptable for use under the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Generally, tax years 2021 through the current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

5. Plan Termination

Although they have not expressed any intent to do so, Longyear 401(k) Profit Sharing Plan reserves the right under the Plan to terminate the Plan in whole or in part, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

6. Transactions with Parties-In-Interest

Certain Plan investments are shares of mutual funds, self-directed accounts, and a money market fund managed by Fidelity Management Trust Company or its affiliates (Fidelity), and the Plan paid fees to Fidelity and Kerber Rose Wealth Management (Plan advisor) in the amount of \$43,362 in 2024 and \$39,781 in 2023. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Administrative expenses are paid by the Plan sponsor for legal counsel and auditor for services to the Plan. These administrative expenses are considered party-in-interest transactions.

7. Financial Information Certified by the Trustee (Unaudited)

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule of assets held, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity (the trustee of the Plan). This certified information has not been audited by independent auditors.

8. Fair Value Measurements

As defined in the current authoritative guidance, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The guidance is applicable to all financial instruments that are measured and reported on a fair value basis. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.
- Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect an entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

8. Fair Value Measurements (continued)

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued using quoted market prices.

Self-directed brokerage accounts: Valued based on the fair value of the underlying investments. The underlying investments are carried at fair value based on quoted market prices.

Collective investment trusts: Valued using the NAV as a practical expedient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Group Annuity Contract

In 2022, the Plan entered into a benefit-responsive group annuity contract with Standard Insurance Company (Standard). Standard maintains the deposits in an unallocated general fund to which it adds interest at the contract rate and charges participant withdrawals and administrative expenses. The guaranteed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer on an annual basis, but may not be less than 1%. A market value adjustment may apply to amounts withdrawn at the request of the contract holder. Such interest rates are reviewed quarterly for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured violation of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, or (4) a material misrepresentation. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

Neither Standard nor the Plan may terminate the group annuity contract without 30 days advance written notice to the other party.

10. Investment in Collective Investment Trusts

Collective investment trusts are accounts maintained by an investment or insurance company that are used for the collective investment of plan funds from multiple employee benefit plans. Pooling plan funds of all plan sponsors who want to invest in the collective investment trust provides greater buying power.

As of December 31, 2024, the Plan held investments in collective investment trusts that are valued at NAV totaling \$189,904. As of December 31, 2023, the Plan held no investments in collective investment trusts.

Fidelity maintains plan contributions in individual accounts which are subsequently invested in one underlying mutual fund traded on an established market. The individual accounts are valued daily using publicly available quoted market prices, and participants bear the investment risks. The redemption frequency and redemption notice period are both on a daily basis. Participants may generally transfer units out of the collective investment trust at any time.

The NAV is the relevant measurement attribute for the collective investment trusts included in net assets available for benefits. NAV, as reported to the Plan by Fidelity, represents the principal invested plus investment gain or loss.
