## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
Allied Universal Corporation 401(k) Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Allied Universal Corporation 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(c) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Allied Universal Corporation 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Allied Universal Corporation 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Allied Universal Corporation 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

### 1. DESCRIPTION OF PLAN

The following description of the Allied Universal Corporation 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General* - The Plan is a defined contribution plan covering all full-time employees of Allied Universal Corporation (the “Company”) who have completed six months of service and are age 21 or older. The Plan was established in 1993 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended and restated on September 1, 2017, to allow for Roth contributions into the Plan.

*Contributions* – Participants may contribute up to the annual limit as allowed by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a fully-benefit responsive investment contract as investment options for participants. The Plan also has an after-tax Roth option.

The Company contributes a Safe Harbor matching contribution equal to 100% of participant contributions up to 5% of the participants’ eligible compensation each pay period. The Safe Harbor matching contributions are fully vested.

The Company also may contribute to each participant a discretionary profit-sharing contribution in addition to the Safe Harbor contribution. There were no such contributions in 2024.

*Participant Accounts* - Each participant’s account is credited with the participant’s contribution and allocation of (a) the Company’s contribution, (b) plan earnings (losses), (c) forfeitures, and (d) charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* - Participants are immediately vested in their voluntary contributions, including rollover contributions, the Company’s Safe Harbor match and actual earnings on such contributions. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service or while employed attains the age of 65, dies, or becomes disabled.

*Notes Receivable from Participants* – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance. Each participant is allowed to have a maximum of one loan outstanding. The notes are secured by the balance in the participant’s account and bear interest at 2% over the prime rate as of the loan issuance date. During 2024, the interest rates charged on the notes receivable from participants ranged from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

*Payment of Benefits* - Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account directly or a rollover to another qualified plan. The Plan also allows for hardship distributions based on a proven financial need, as defined by the Internal Revenue Code. The Plan automatically distributes participant accounts with balances less than \$5,000 upon termination of employment. If the participant’s account balance is between \$1,000 and \$5,000, the distribution will be made to an Individual Retirement Account (“IRA”) account.

*Forfeited Accounts* – At December 31, 2024 and 2023, forfeited accounts totaled \$152,608 and \$130,999, respectively. These accounts are used to pay administrative expenses. During 2024 forfeitures of \$34,273 were used to reduce administrative expenses.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of accounting* - The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates* - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded.

*Investment Valuation and Income Recognition* – Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation/(depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Excess Contributions Payable* – There were no excess contributions for the years ended December 31, 2024 and 2023.

*Payment of Benefits* – Benefits are recorded when paid.

*Administrative Expenses* – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

*Date of Management’s Review* – Subsequent events were evaluated through September 11, 2025, which is the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

Certain investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies and assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted prices in inactive markets for identical or similar assets or quoted prices for similar assets in active markets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

*Mutual Funds* – The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded with readily determinable fair values.

### 4. INVESTMENTS AT CONTRACT VALUE

The Plan offers a guaranteed interest account with Empower Annuity Insurance Company (Empower) which they maintain in a general account. Guarantees are based on the claims-paying ability of the issuing company. Under the group annuity insurance contract that supports this fund, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is affected directly between the plan sponsor (or their trustee) and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Given these provisions, Empower considers this contract to be fully benefit responsive. This contract value totaled \$7,560,917 and \$6,879,328 at December 31, 2024 and 2023, respectively. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. Plan management believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

### 5. PLAN TERMINATION

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

### 6. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. There were no uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by tax authorities; however, there are currently no audits in progress for any tax periods.

### 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 8. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The following information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule at December 31, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company, the trustee of the Plan:

### 9. FIDELITY BONDING

The Company maintains a fidelity bond of \$800,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA.

### 10. PROHIBITED TRANSACTIONS

During the year ended December 31, 2023, the Plan administrator did not timely remit certain employee contributions and loan repayments of \$53,385 in accordance with guidelines set forth by the United States Department of Labor ("DOL") and Employee Benefits Security Administration ("EBSA"). These nonexempt transactions were subsequently corrected in 2024.

### 11. PARTY IN INTEREST TRANSACTIONS AND ADMINISTRATIVE EXPENSES

Certain Plan investments are managed by Empower Annuity Insurance Company of America which is the trustee and recordkeeper for the Plan. Accordingly, these transactions qualify as party in interest transactions. During the year ended December 31, 2024, the Plan paid to third parties record keeping fees of approximately \$17,786, advisory service fees of approximately \$31,972, and consulting fees of approximately \$1,980. The amounts are included in administrative expenses in the statement of changes in net assets available for benefits.
