### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Brownsville Community Health Center Pension Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brownsville Community Health Center Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

**Note 1. Description of the Plan**

The following description of Brownsville Community Health Center Pension Plan (Plan) provides only general information. Participants should refer to the plan document and Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

**General**

The Plan is a defined contribution plan sponsored by Brownsville Community Health Clinic Corporation (Company) for the benefit of its employees who normally work 20 hours or more per week. Effective May 16, 2024, the Plan's sponsor assumed the name New Horizon Health Center. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

**Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual pre-tax or Roth contributions of up to 100% of eligible compensation. The Plan provides an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. For 2024 and 2023, the Company made a 3% Safe Harbor nonelective contribution to eligible employees who had one year of service. The plan also allows for discretionary nonelective profit-sharing contributions as determined by the Company's Board of Directors. Through April 2024, the Board of Directors approved 4% discretionary nonelective profit sharing contribution to eligible employees. Effective April 2024, the Board of Directors approved to change the discretionary nonelective profit sharing contribution to 1%. Contributions are subject to certain limitations.

**Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing contributions into any of the separate investment accounts selected by the Company and may change the allocation daily.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and are payable over a term not to exceed five years unless the loan is for the purchase of a primary residence, in which case, it is payable over a term not to exceed 30 years. The rate of interest will be commensurate with the rate of interest charged on similar commercial loans by persons or institutions in the business of lending money in the same geographical area as the employer.

***Vesting***

Participants are immediately vested in their voluntary contributions and in the Company's safe harbor contributions plus earnings thereon. Vesting in the Company's nonelective contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service.

***Payment of Benefits***

Upon termination of service, an employee may elect to receive either a lump-sum or partial payment amounts equal to the value of his account. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,132 and \$2,258, respectively. The forfeited nonvested accounts can be used to reduce employer contribution or used to reduce plan expenses. In 2024 and 2023, employer contributions were reduced by \$0 from forfeited nonvested accounts. During 2024 and 2023, plan expenses were reduced by \$12,931 and \$6,118, respectively, from forfeited nonvested accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Loans are considered in default and treated as a deemed taxable distribution if the borrower does not make a loan payment by the end of the calendar quarter following the quarter in which such payment was due.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the plan custodian, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

**Level 1** Quoted prices in active markets for identical assets or liabilities.

**Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics, or discounted cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

**Note 5. Investment Contract with Insurance Company**

The Plan has a fully benefit-responsive group annuity investment contract with Standard Insurance Company (Standard). Standard maintains the contributions in the Standard Stable Asset account where they are invested in accordance with Standard’s investment policy. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan, however it may not be less than 1.0%.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: corporate acts such as spin-offs, divestitures, corporate relocations, layoffs, retirement incentive programs, partial or total plan terminations, or the liberalization of plan withdrawal, or transfer rules. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

**Note 6. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan paid \$56,604 and \$47,153 of direct fees to Standard Retirement Services, Inc. during 2024 and 2023, respectively. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan earned \$4,459 and \$4,398 through a revenue sharing agreement with Standard Retirement Services, Inc. during 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 9. Tax Status**

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and custodial document sponsored by Standard Retirement Services, Inc. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued.

***Plan Restatement and Change in Custodian***

Effective August 1, 2025 the Plan was restated, renamed to New Horizon Health Center 403(b) Plan and a new custodian and recordkeeper were appointed. The conversion initiated a “Black Out” period beginning on July 24, 2025, and continued through August 7, 2025. During this period, funds could not be applied to the employee-selected funds with the custodian or withdrawn from the Plan until the custodian had time to accurately complete the conversion. During this period, employees’ contributions continued to be made through payroll deductions and contributions were deposited and held until the completion of the Black Out period. At the end of the Black Out period, these funds were transferred to the new custodian and invested in funds as requested by each participant.

Effective with the restatement, the Plan’s eligibility requirements were amended to reduce the service period for employer contributions from one year of service to three consecutive months of service.


