## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator, Participants and Beneficiaries of the Lannett Company, Inc. 401(k) Retirement Savings Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Lannett Company, Inc. 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with modified cash basis of accounting described in Note B [1].
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Basis of Accounting***

We draw attention to Note B [1] to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is the basis of accounting other than the accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B [1], and for determining that the modified cash basis of accounting is an acceptable basis for presentation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note B [1].

Note A - DESCRIPTION OF THE PLAN

The following description of the Lannett Company, Inc. 401(k) Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

[1] General

The Plan is a defined contribution plan covering all employees of Lannett Company, Inc., Cody Laboratories, Inc., Silarx Pharmaceuticals, Inc. and Kremers Urban Pharmaceuticals Inc. (collectively, the "Company" or "Employer") who meet the eligibility criteria, as defined in the Plan, and are not:

- A resident of Puerto Rico;
- Covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan;
- A nonresident alien with no United States source of income from the Company;
- A leased employee; and/or
- An intern.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The trustee of the Plan is Fidelity Management Trust Company ("Fidelity").

On May 3, 2023, the Company filed a plan for Chapter 11, the reorganization of Lannett Company, Inc. and its debtor affiliates. The plan was approved by the United States Bankruptcy Court on June 8, 2023 and the Company emerged from Chapter 11 bankruptcy.

[2] Contributions

Participants may contribute up to 100% of their allowable compensation up to Internal Revenue Service ("IRS") limits, as defined by the Plan. Participants may elect a Roth 401(k) contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Newly eligible employees and those employees that have a 0% deferral rate or a deferral rate of 5% or lower are automatically enrolled into the Plan at a 6% deferral rate once the eligibility requirements are satisfied. For such automatically enrolled participants, the deferral rate increases 1% each year to a maximum of 10%; however, employees may opt out of this automatic enrollment and escalation. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may make discretionary matching contributions and discretionary nonelective contributions. To be eligible for the discretionary nonelective contribution, a participant must have worked 1,000 hours during a Plan year and be employed on the last day of the Plan year.

[2] Contributions (continued)

Effective July 1, 2022, the discretionary match is 50% up to 8% of compensation. Participants direct the investment of participant and Company contributions into various investment options offered by the Plan.

Effective January 1, 2021, the Plan was amended to establish a Student Loan Repayment Program (the "Program"). Effective January 1, 2024, the Plan amended the Plan to remove this Program. Under the Program, the Company could have made a nonelective employer contribution ("SLR contribution") on behalf of an "Electing Participant," defined as a participant who made an election to participate in the Program. The following provisions applied to SLR contributions:

1. Participation in the Program was completely voluntary. Any participant could have elected to participate in the Program at any time, and revoke that election at any time, provided that each election and any revocation thereof may be made effective only on a prospective basis. Election to participate in the Program (and revocation of any such election) was made in a manner prescribed by the Company.
2. An Electing Participant was eligible to make deferral contributions and employee contributions during the period in which the election to participate in the Program was in effect (the "Election Period").
3. The amount of the SLR contributions made on behalf of an Electing Participant was equal the matching employer contribution the participant would have received, had the participant made deferral contributions to the Plan equal to his or her student loan repayments during the Election Period.
4. All eligibility and allocation requirements applicable for purposes of entitlement to matching employer contributions was equally applicable for purposes of entitlement to SLR contributions for a Plan year.

[3] Eligibility

In addition to the service requirements above regarding the discretionary nonelective contribution, employees can participate in the Plan and receive the discretionary match if they are 18 years of age or older.

[4] Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note A - DESCRIPTION OF THE PLAN (continued)

[5] Vesting and Forfeitures

Participants are immediately 100% vested in their contributions, plus actual earnings and losses thereon. Participants are 100% vested in the Company's matching and nonelective contribution portions of their accounts, plus actual earnings and losses thereon, after three years of service. Participants that have prior Cody Laboratories, Inc. matching contributions continue to vest in those contributions at a rate of 1 year 20%, 2 years 40%, 3 years 60%, 4 years 80% and 5 years 100%.

Forfeited nonvested accounts may be used to reduce future Company contributions and pay Plan expenses. During the year ended December 31, 2024, forfeitures of \$85,705 were used to reduce employer contributions and \$17,872 were used to pay Plan expenses, as defined. Forfeited nonvested accounts available to reduce future employer contributions and pay Plan expenses at December 31, 2024 and 2023 were \$100,129 and \$72,239, respectively.

[6] Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance reduced by the highest outstanding loan balance in the account during the prior 12-month period. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator.

Interest rates on outstanding loan balances ranged from 4.25% to 9.5% as of December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

[7] Payment of Benefits

Participants receive their benefits in several ways: cash distribution, direct rollover distribution, a combination of cash distribution and direct rollover distribution or installment payments equal to the value of the participant's vested interest in his or her account.

Employees are eligible to request a distribution of their vested account balance based on any of the following events: death, disability (as determined by a physician selected by the Plan administrator or eligible for Social Security disability benefits), retirement or termination of employment.

If a participant qualifies and the request is approved by the Plan administrator, the participant may obtain a withdrawal from the Plan while still an employee. The following types of withdrawals are available under the Plan:

1. Hardship withdrawal - To satisfy certain immediate and heavy financial needs as defined in the Plan.
2. Withdrawals after age 59½.
3. Withdrawals after age 70½ - Employees are required to receive a required minimum distribution from the Plan by April 1st of the later of the calendar year after reaching the age of 70½ or the year of retirement.
4. Withdrawals after normal retirement age as defined in the Plan document.
5. Withdrawals of rollover contribution as defined in the Plan document.
6. Partial withdrawals.

[8] Partial Termination

During 2023, the Company had workforce reductions of 26% of its employees. The Plan treated the reduction in workforce as a partial termination of the Plan and all of the participants involved in the reduction were made 100% vested in all employer contributions.

Note B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of Accounting

As permitted under the United States Department of Labor's Rules and Regulations, the accompanying financial statements and supplemental schedule have been prepared on the modified cash basis of accounting, which is a financial reporting framework other than accounting principles generally accepted in the United States of America ("GAAP"). Under this modified cash basis, investment assets are reported at fair value, interest and dividend income and contributions are recognized when received rather than as earned, and expenses are recognized when paid rather than as incurred. Accordingly, the accompanying financial statements are not intended to present net assets under the Plan and changes in net assets in conformity with GAAP.

[2] Subsequent Events

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

[3] Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Payment of Benefits

Benefits are recorded when paid.

[5] Plan Expenses

Substantially all expenses, incurred in connection with the administration of the Plan, are paid by the Plan, including recordkeeping fees paid to Fidelity.

[6] Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Note C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Fidelity Management Trust Company has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 - modified cash basis, the statement of changes in net assets available for benefits for the year ended December 31, 2024 - modified cash basis and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024 - modified cash basis.

Note D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust funds* – The Reliance Trust New York Life Anchor Account - Series I - Class 0 ("Reliance") is valued at the NAV of units of Reliance. The NAV, as provided by the trustee of Reliance, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by Reliance less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The investment objective of Reliance is to provide participants with a low-risk, stable value option that offers competitive yields, and limited volatility by investing in a group annuity contract issued by New York Life Insurance Company. Were the Plan to initiate a full redemption, Reliance requires twelve months' written notice; however, the trustee of Reliance, in its discretion, may waive the twelve months' notice requirement. Reliance prohibits the participants from making a direct exchange from Reliance to such competing investment. First, an exchange to a non-competing investment must occur at least 90 days before.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E - TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by FMR LLC. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

Note F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are shares of mutual funds managed by Fidelity. Fidelity is the Plan trustee and, therefore, transactions related to these investments qualify as party-in-interest transactions. Recordkeeping fees paid by the Plan were \$93,579, advisor and administrative fees paid by the Plan were \$151,303 for the year ended December 31, 2024.

Note G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits - modified cash basis.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

Note H - MUTUAL FUND FEES

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

Note I - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.
