## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Sargent & Greenleaf Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Sargent & Greenleaf Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate on the financial statements.

### **Opinion on the Financial Statements**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

## **1. DESCRIPTION OF PLAN**

The following brief description of the Sargent & Greenleaf Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's information. The Plan was adopted beginning April 15, 2019.

### **General**

The Plan is a defined contribution, profit-sharing plan covering eligible employees of Sargent & Greenleaf, Inc. (the Sponsor or the Company) who have reached 18 years of age and choose to participate in the Plan. Employees may register with the Plan as an active participant on the first day of the month on or after they become an eligible employee by filing an elective deferral agreement. Employees are eligible under the Plan unless they meet any of the following exclusions:

- A nonresident alien with no U.S. income, or all such income is exempt from U.S. income tax;
- A leased employee; or
- Considered an independent contractor who is later determined by the Internal Revenue Service (IRS) to be an employee of the Company.

Participants direct the investment of their accounts into various investment options offered by the Plan. Participants may modify or terminate an elective deferral agreement by filing a new elective deferral agreement which shall remain in effect until modified or terminated by the participant.

### **Plan Administration**

Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company (the Trustee) serves as the Trustee, and Principal Life Insurance Company Retirement Plan Processing Center (the recordkeeper) is the recordkeeper for the Plan.

### **Contributions**

Each year, participants may make elective salary deferral contributions subject to IRS limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to IRS limitations. The Plan will accept eligible rollover contributions on behalf of the participant from qualified plans. Participants may designate a portion or all of their contributions as Roth after-tax contributions.

Effective January 1, 2024, the Plan was amended to provide an automatic enrollment contribution arrangement, all employees who have satisfied the eligibility requirements of the Plan will be automatically enrolled at a 6% salary deferral rate. The automatic contribution percentages will increase each year at 1% per year with a maximum of 10%. The Plan was also amended to allow for Roth after-tax participant contributions and Sponsor true-up employer contributions.

The Plan has adopted a safe harbor matching provision formula whereby the Sponsor will contribute 100% of the first 3% of a participant's deferrals and 50% of the next 2% of a participant's deferrals. At its discretion, the Sponsor may also make a qualified nonelective contribution to the Plan. The Sponsor did not elect to make a qualified nonelective contribution for the 2024 Plan year.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of Sponsor contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Loans to a participant are permitted under the Plan. The number of loans approved for a participant in any 12-month period shall be limited to one, and the number of outstanding loans for a participant shall be limited to one. The minimum amount of any loan is \$1,000, and the maximum is determined by the lesser of: 1) 50% of the participant's vested account, reduced by any outstanding loan balance; or 2) \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The term of the loan shall be limited to five years. The participant's account will provide the security for the loan. The interest rate will be based on the rates available for similar loans from commercial lending institutions and will be described, along with the amount of the loan and any processing fees or late charges, in the promissory note signed by the participant upon being granted a loan.

**Vesting**

Participants are fully (100%) and immediately vested in their 401(k) salary deferral, safe harbor matching contributions, rollovers and any investment earnings on these amounts.

**Payment of Benefits**

Withdrawal payments are made in the form of partial, periodic or lump-sum payments upon termination, disability, minimum required, death or retirement. In addition, the Plan allows for hardship distributions if certain criteria are met. Active participants may also take distributions from the Plan upon attainment of age 59½.

**Forfeitures**

Forfeitures by nonvested participants are used to reduce Sponsor contributions or pay Plan expenses. At December 31, 2024 and 2023, there was no balance in the forfeiture accounts.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred..

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Expenses relating to specific participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment returns and included in the net depreciation in fair value of investments.

**Subsequent Events**

Management has evaluated events through September 15, 2025 which is the date that the financial statements were available to be issued, and has determined there are no subsequent events that require disclosure under Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 855, *Subsequent Events*.

#### **4. FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB, ASC 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual funds:* Valued daily at the closing price reported on the active market on which the funds are traded.

*Common collective trust (CCT) funds:* Valued at the net asset value (NAV) of units of the collective fund as provided by the custodian of the fund. The NAV is based on fair value of the underlying investments held by the fund, less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

**5. PARTY-IN-INTEREST TRANSACTIONS**

The Plan holds units of collective trust funds managed by the Trustee or an affiliate of the Trustee. These transactions qualify as party-in-interest transactions. The Plan paid the recordkeeper administrative expenses of \$25,878 for the year ended December 31, 2024.

The Plan also held notes receivable from participants which constitute party-in-interest transactions.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

**7. TAX STATUS**

The Sponsor adopted a prototype plan document sponsored by the recordkeeper which received an opinion letter from the IRS dated June 30, 2020, indicating that the prototype document is designed in accordance with applicable sections of the Internal Revenue Code (IRC); and therefore is tax-exempt. The Plan itself has not received a determination letter from the IRS. However, the Sponsor believes that the Plan is designed and currently operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and tax-exempt as of December 31, 2024 and 2023, and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
