Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Piedmont Healthcare, Inc. 401(k) TomorrowPlan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial Statements and certain additional procedures, including

comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial Statements or to the financial Statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Plan description:

The following description of Piedmont Healthcare, Inc. 401(k) TomorrowPlan (the Plan or the TomorrowPlan) provides only general information. Participants should refer to the summary plan description and Plan document for a more complete description of the Plan's provisions.

General and eligibility

Piedmont Healthcare, Inc. (the Company, Plan Administrator, or Employer) adopted the Plan effective January 1, 2009. Participants in previously existing 401(k) and 403(b) plans of certain subsidiaries of the Company automatically became participants in the Plan on January 1, 2009, and the assets of the Piedmont Medical Care Corporation and the Piedmont Heart Institute, Inc. plans were rolled into the TomorrowPlan on January 2, 2009, upon merger of the plans. Participants in the Piedmont Healthcare, Inc. Retirement Plan were given the option of remaining in the Piedmont Healthcare, Inc. Retirement Plan or entering the TomorrowPlan effective January 1, 2009. The Plan was amended December 12, 2012 to merge the Henry Medical Center Retirement Plan with and into the Plan effective December 31, 2012. The Plan was amended April 24, 2017 to merge the Piedmont Newnan Hospital, Inc. Retirement Plan with and into the Plan effective July 17, 2017. The Plan was amended on August 15, 2018 to merge the Athens Regional Health Services, Inc. Defined Contribution Retirement Plan with and into the Plan effective November 1, 2018.

The Plan was amended on December 23, 2022 to include University Health Services, Inc., University Medical Group, LLC, University Extended Care, Inc., University McDuffie Regional Medical Center, Inc., and University Cardiology Associates, LLC as affiliated Sponsors effective January 1, 2023. Further, any individual employed by the affiliated sponsors on January 1, 2023, shall become a participant under the Plan on December 18, 2022, provided he or she is eligible to participate.

The Plan is a defined contribution plan covering all employees of the Company subject to eligibility provisions of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may contribute on a pre-tax basis from 1% to 100% of compensation, not to exceed \$23,000 for the year ended December 31, 2024. Participants who have obtained age 50 are eligible to make catch-up contributions subject to Internal Revenue Code limitations. The Plan was amended effective January 1, 2015, to provide for auto-enrollment for new employees at a level of 3% of their compensation. Additionally, participants may elect to make after-tax contributions.

Note 1 - Plan description - continued:

Contributions - continued

Each pay period the Company makes contributions to the Plan based on a percentage of participant contributions to the Plan. Participant contributions are matched one dollar for each dollar up to 6% of compensation contributed as defined by the Plan.

In addition, the Employer may make a discretionary contribution to the Plan which is allocated to each eligible participant pro-rata based on their compensation. The Plan document specifies that the last day of the year rule be used for all participants receiving a discretionary contribution. The Employer did not make a discretionary contribution relating to the year ended December 31, 2024.

Vesting

Participants are immediately vested in their voluntary and rollover contributions and actual earnings thereon. Employer matching contributions are 100% vested at all times. Vesting in the Company discretionary contributions is based on years of credited service with 100% vesting after five years at a rate of 20% per year after the first year.

Participant accounts

A separate account is maintained for each participant. These accounts are credited with the participant's contribution, the Company's matching and discretionary contributions and an allocation of investment results. These accounts are charged with an allocation of expenses paid by the Plan. Allocations of investment results are based on each participant's account balance in relation to the total of all participants' account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Forfeitures of terminated participants' non-vested accounts are used first to restore any previously-forfeited amounts of people who previously left the Plan but have been rehired and then to reduce either future Company discretionary contributions to the Plan or pay administrative expenses of the Plan. The balance in the forfeiture account was \$49,948 and \$82,210 at December 31, 2024 and 2023, respectively. The Company used \$110,597 forfeitures to offset employer contributions or pay administrative expenses in 2024.

Note 1 - Plan description - continued:

Payment of benefits

Upon retirement, death, permanent disability, or termination of employment, a participant or a designated beneficiary will receive the vested balance in the participant's account as a lump sum. If the participant does not elect a distribution, and the value is between \$1,000 and \$5,000, the account will be automatically rolled over to an IRA.

Notes receivable from participants

Participants may borrow up to the lesser of \$50,000 or 50% of the vested portion of their account balances, subject to certain restrictions, in accordance with interest rates and collateral requirements established by the Plan document. The notes are secured by the balances in the participants' accounts and bear interest at a rate commensurate with market rates for similar loans. Note terms are generally not to exceed five years. Participants may select a repayment term up to 30 years for loans used to purchase a participant's principal residence. Principal and interest are repaid directly to the trustee. The participants are allowed one outstanding note.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and accounts will be distributed as soon as administratively possible.

Administrative fees

All administrative fees are paid by the Plan to the extent not paid by the Company.

Note 2 - Summary of significant accounting policies:

Basis of accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Valuation of investments and income recognition

The Plan's investments in mutual funds are stated at fair value which equals the quoted market price determined in an active market on the last day of the Plan's year. See Note 4 for further discussion of fair value measurements.

Investment in the stable value fund is reported at fair value. The stable value fund, at the fund level, is composed primarily of fully benefit-responsive investment contracts held by the fund's trustee. These contracts are not considered fully benefit-responsive to the Plan as the underlying contracts are not direct investments between the Plan and the issuer. The Plan has elected to value the stable value fund using net asset value (NAV) as a practical expedient.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants represents participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on loans receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits

Benefits are recorded when paid.

Recent legislative developments

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023.

Recent Accounting Standards

The AICPA Financial Reporting Executive Committee (FinREC) approved enhanceive accounting updates related to accounting for revenue sharing arrangements in accordance with Financial Accounting Standards Board (FASB) ASC No. 606, *Revenue from Contracts with Customers*. Revenue sharing amounts are not considered revenue under ASC No. 606 due to the fact that they are intended to reduce administrative costs for the plan and are not paid to the plan for delivering or producing goods, rendering services or undertaking other activities for the investment manager. A plan should consider all relevant facts and circumstances, including the terms of the agreement to determine the appropriate presentation of revenue sharing amounts. The presentation should be applied on a consistent basis. The adoption did not have a material impact on the Plan's financial statements.

Subsequent events

Management evaluated subsequent events for the Plan through September 5, 2025, the date the financial statements were available to be issued. During this period there were no subsequent events that required recognition in the financial statements. Additionally, there were no non-recognized subsequent events that required disclosure other than those noted below.

Note 3 - Investments and information certified by the trustee:

Fidelity Management Trust Company (Fidelity), the trustee of the Plan, provides certified statements for the Plan. Fidelity holds the Plan's investment assets and executes investment transactions. Management has determined that Fidelity, is a qualified institution and the information prepared and certified by Fidelity meets the requirements of ERISA Section 103(a)(3)(C). All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held, notes receivable from participants, other receivables, and other payables at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity.

Note 4 - Fair value measurements:

As defined in ASC 820, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy and a description of the valuation methodologies used for instruments measured at fair value are as follows:

- *Level 1* - Financial assets and liabilities whose values are based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access.
- *Level 2* - Financial assets and liabilities whose values are based on pricing inputs which are either directly observable or that can be derived or supported from observable data as of the reporting date. Level 2 inputs may include quoted prices for similar assets or liabilities in non-active markets or pricing models whose inputs are observable for substantially the full term of the asset or liability.
- *Level 3* - Financial assets and liabilities whose values are based on prices or valuation techniques that require inputs that are both significant to the fair value of the financial asset or financial liability and are generally less observable from objective sources. These inputs may be used with internally-developed methodologies that result in management's best estimate of fair value.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 5 - Income tax status:

The Plan has received a determination letter from the IRS dated October 14, 2014, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the Code) and; therefore, the related trust is tax-exempt. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Party-in-interest transactions:

Certain Plan investments are shares of funds managed by Fidelity. As the Plan's trustee, Fidelity is a party-in-interest to the Plan and is exempt from the prohibited transaction rules.

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Note 6 - Party-in-interest transactions - continued:

Fidelity receives revenue from investment fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such investment fund service providers exceeds the amount owed for its services, Fidelity remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

Revenue Share Income

The Plan maintains an unallocated ERISA budget account which holds ERISA budget account credits transferred to the Plan by the Plan's service provider in accordance with an ERISA Budget Account Agreement. For each year in which an ERISA Budget Account Agreement is in effect with a service provider, the Plan Administrator may, in its discretion, direct the service provider to either pay reasonable Plan administrative expenses with the ERISA budget account credits or allocate the ERISA budget account credits among the accounts of the participants with a balance in the Plan. December 31, 2024 and 2023, the balance of the ERISA budget account totaled \$812,523 and \$445,974, respectively.

During the year ended December 31, 2024, credits transferred to the ERISA budget account were \$333,019, and are recorded as a reduction of administrative expenses on the statement of changes in net assets available for benefits. The Plan used \$0 of the ERISA budget account to pay administrative expenses for the year ended December 31, 2024.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 7 - Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
