## **Independent Auditor's Report**

To The Administrative Committee and Plan Participants of the  
Premier Family Medical, LLC 401(k) Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Premier Family Medical, LLC 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets in liquidation available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets in liquidation available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Premier Family Medical, LLC 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to in the first paragraph of this report related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Premier Family Medical, LLC 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. ### **Emphasis of Matter**

As discussed in Note 1 to the financial statements, the Board of Directors of Premier Family Medical, LLC, the Premier Family Medical, LLC 401(k) Retirement Plan's sponsor, voted in November 2023 to merge the Plan into the RMI 401(k) Plan during 2024. The financial statements have been prepared using the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Premier Family Medical, LLC 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

## **Note 1 – Description of Plan**

The following brief description of the Premier Family Medical, LLC 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering qualified employees of Premier Family Medical, LLC (the Company) and affiliated/participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility** – Employees are eligible to participate in the Plan if they have completed six months of service and are 21 years of age or older. Employees are credited with six months of service at the end of the six month period beginning on the date of hire if they have been credited with at least 500 hours of service during such period. The eligibility period rolls to the next consecutive period until the employee has worked a full year at which time the eligibility period reverts to 1,000 hours of service in a 12-month period.

**Entry Date** – Employees may enter the Plan on the first day of the Plan year quarter coinciding with or next following the date they satisfy the eligibility requirements.

**Contributions** – Each year, participants may elect to contribute up to the maximum amount of compensation allowed by Code Sections 402(g) and 414(v) not to exceed the limits of Code Sections 401(k), 404, and 415 (for 2024 the limit is \$23,000). This amount is indexed periodically for changes in the cost-of-living index. This limit applies to all employee 401(k) contributions made during a tax year to any 401(k) plans maintained by a present or former employer. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company contributed a safe harbor matching contribution of 100% of employee deferrals up to 3% of annual compensation and 50% of employee deferrals of the next 2% of annual compensation. Additional amounts may be contributed at the discretion of the Company's board of directors. No such discretionary contributions were made during the year ended December 31, 2024. Amounts are funded each pay period and a true-up calculation and contribution for the safe harbor matching contribution is made after the Plan year-end (amount is accrued as an employer contribution receivable each year).

**Participant Accounts** – Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contribution, as well as an allocation of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## **Note 1 – Description of Plan (Continued)**

**Investment Options** – Upon enrollment in the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. A self-directed brokerage account option is offered whereby participants can choose to invest a portion of their accounts in investments outside of the Plan’s fund lineup. Special contribution, loan, distribution, withdrawal, and fee allocation rules apply to self-directed brokerage accounts. Participants may change their investment options daily.

**Vesting** – Participants are vested immediately in their contributions and safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts is based on years of continuous service. Vesting is based on years of credited service as set forth in the following table:

**Forfeitures** – At both December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. The Employer may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the year ended December 31, 2024, \$0 of non-vested participant funds were forfeited and \$0 were used to pay Plan expenses.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant’s account and bore interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates at the time funds are borrowed, as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years, unless the proceeds of the loan were used to acquire the participant’s residence. A participant may have no more than two outstanding loans at any one time.

**Payment of Benefits** – Participants may elect to receive either a lump-sum amount equal to the value of their vested interest, or annual installments as defined in the Plan document, upon retirement, termination of service, death, or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant’s election prior to termination, upon attainment of age 59 ½, or hardship as defined in the Plan document.

### **Note 1 – Description of Plan (Continued)**

**Death Benefits** – The designated beneficiary is entitled to a death benefit distribution equal to the participant's vested account balance.

**Plan Termination** – On November 7, 2023, the Board of Directors of Premier Family Medical, LLC approved the merger of this Plan into the RMI 401(k) Plan, effective January 1, 2024. As a result, all assets held by the custodian were transferred from the Plan into the RMI 401(k) Plan on January 16, 2024. There are two remaining accounts held outside of the custodian in self-directed brokerage accounts that remain under the plan as of December 31, 2024. The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

When the Plan terminates, benefits are not insured by the Pension Benefit Guaranty Corporation (PBGC). Under the law, PBGC insurance does not cover the type of plans called defined contribution plans. This Plan is a defined contribution plan and, therefore, is not covered.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting** – The Company determined that liquidation is imminent during the plan year ended December 31, 2023. As a result, the Plan has presented the financial statements as of and for the years ended December 31, 2024 and 2023 under the liquidation basis in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition** – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

## **Note 2 – Summary of Significant Accounting Policies (Continued)**

***Contributions Receivable and Allowance for Credit Losses*** – Contributions receivable consist of contributions from participants and/or the plan sponsor that have not yet been remitted to the Plan. The allowance estimate is derived from a review of the Plan’s historical losses based on the age of receivables and the type of receivable. This estimate is adjusted for the trustee’s assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. The Plan believes historical loss information is a reasonable starting point in which to calculate the expected allowance for credit losses. Actual credit losses could differ from the estimate. Assets are presented in the financial statements at the net amount expected to be collected. As of December 31, 2024 and 2023, the Plan has recorded no allowance for credit losses as it is not considered material to the financial statements.

***Notes Receivable from Participants*** – Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Payments of Benefits*** – Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but had not yet been paid as of December 31, 2024 and 2023.

***Administrative Expenses*** – The Plan’s expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

## **Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

***Level 1*** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to methodologies used at December 31, 2024 and 2023.

**Mutual Funds** – Valued at fair value based on quoted market prices.

**Self-Directed Brokerage Accounts** – Self-directed brokerage accounts consist of life insurance contracts that are valued at cash surrender value as well as mutual funds and exchange traded products which are valued at fair value based on quoted market prices.

**Interest-Bearing Cash** – The fair value of interest-bearing cash is based on cash value.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

### **Note 5 – Tax Status**

The Plan uses a Non-Standardized Pre-Approved Profit Sharing Plan document sponsored by CCH Incorporated, which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS, however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there were no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. Generally, three tax years remain subject to examination by tax jurisdictions.

### **Note 6 – Related Party and Party-in-Interest Transactions**

As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Party-in-interest balances include notes receivable from participants of \$0 and \$200,116 as of December 31, 2024 and December 31, 2023, respectively, and are considered exempt party-in-interest amounts.

### **Note 7 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8 – Nonexempt Party-in-Interest Transactions**

During the year ended December 31, 2023, the Company remitted participant contributions of \$65,200 and loan repayments of \$5,496 to the custodian of plan assets later than required by Department of Labor (DOL) Regulation 2510.3-102. The amounts were corrected as of December 31, 2024.

### **Note 9 – Subsequent Events**

Subsequent events have been evaluated through September 15, 2025, which is the date the financial statements were available to be issued.
