Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of York Capital Management 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of the Plan

The following brief description of the York Capital Management 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary plan description for a complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan covering substantially all employees of York Capital Management (US) Advisors, L.P., or any affiliate (the Company, the Employer, or the Plan Sponsor) who has adopted the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan's Fiduciary Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

John Hancock Life Insurance Company of New York (John Hancock) is the custodian and recordkeeper for the year ended December 31, 2023 through June 11, 2024. Capital Bank and Trust Company succeeded John Hancock and became the custodian and recordkeeper beginning June 12, 2024. Legacy Retirement Solutions, LLC (Legacy) is the third-party administrator of the Plan for the years ended December 31, 2024 and 2023.

Eligibility

Employees who are aged 21 or older and are not covered by a collective bargaining agreement are eligible to participate. Interns who are aged 21 or older and have at least 1,000 hours of service are also eligible to participate. Residents of Puerto Rico and non-resident aliens with no earned income from the Company that constitutes United States source income are not eligible to participate in the Plan. Effective May 15, 2024, employees who attain age 21 must complete 360 hours of service in a two-month period to be eligible to participate.

Contributions

Participants may contribute a percentage or fixed amount of their semi-monthly salary and/or bonus on a before and/or after tax basis; there is also an automatic enrollment for newly eligible employees at a rate of 1% with 1% annual escalation up to 5% (with an opt-out availability), as defined in the Plan. Contributions were subject to an annual limitation of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, as imposed by the Internal Revenue Service (IRS). The catch-up contribution for participants over age 50 was \$7,500 for the years ended December 31, 2024 and 2023. Participants also may roll over amounts representing distributions from other tax-qualified plans.

The Employer may contribute discretionary profit-sharing contributions, as defined in the Plan. The Employer contributed \$1,182,366 and \$1,290,504 for the years ended December 31, 2024 and 2023, respectively. Employer contributions are paid to the Plan in the first quarter following the Plan year-end.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer's discretionary profit-sharing contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on

participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in both their voluntary and Employer contributions, and actual earnings thereon.

Investment Options

Participants direct the investment of their voluntary and Employer contributions into investment options offered by the Plan. The Plan currently offers mutual funds, a money market fund, and a stable value fund.

Payments of Benefits

Participants are eligible to receive distributions from their accounts at the normal retirement age (age 65), disability, death, or termination of employment. Participants receive the value of their vested account balance in the form of a single lump-sum payment. Additionally, participants are entitled to apply for hardship withdrawals and, after attaining age 59½, receive in-service distributions.

Notes Receivable from Participants

Participants may borrow from their accounts. The loan must be a minimum of \$1,000 or up to a maximum amount equal to the lesser of (a) \$50,000 reduced by their highest outstanding loan balance during the previous 12 months or (b) 50% of their vested account balance. Interest is charged at the prime rate determined as of the date of the loan, plus 1%. The interest rate on outstanding loans as of December 31, 2024 and 2023 was between 4.25% to 9.50% and between 4.25% to 9%, respectively. The term of the loan shall not exceed five years, except for loans that are used to purchase a principal residence, which may be up to 30 years. Only one loan per participant may be outstanding. Principal and interest is paid through payroll deductions.

Administrative Expenses

Expenses related to processing fees for loans and distributions are deducted from the respective participant's account. Certain expenses incurred in the administration of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the Plan's financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on those investments purchased and sold, as well as held during the year.

Payments of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock and Capital Bank and Trust, qualified institutions.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for these items:

Mutual Funds - Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are actively traded.

Money Market Fund - The money market fund is valued at the unadjusted quoted market price, which represents the NAV of shares owned by the Plan at year-end.

Pooled Separate Accounts and Stable Value Fund - These assets are valued at NAV of the units owned by the Plan at year-end quoted by the fund, which approximates fair value. The NAV is based on the underlying funds and the separate account charges (i.e., the daily asset charges). There are no restrictions as to redemption of these investments, nor does the Plan have any contractual obligations to further invest in any of the individual funds. There were no unfunded commitments as of December 31, 2024 and 2023. These are direct filing entities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investments in pooled separate accounts and the stable value fund, which are valued at NAV, have not been leveled in the fair value hierarchy in accordance with Financial Accounting Standards Board Accounting Standards Update 2015-07, *Disclosures for Investments in Certain Entities That Calculate Net Assets Value per Share (or its Equivalent)*.

5. Tax Status

In June 30, 2020, the Company adopted the Legacy's Prototype Non-Standardized Profit-Sharing Plan with cash or deferred arrangement. Accordingly, the Plan is permitted to rely on the opinion letter from the IRS. The Plan is required to operate in conformity with the Internal Revenue Code (IRC) to maintain its qualification. The Plan administrator believes that the Plan has been designed and is being operated in compliance with applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Party Transactions

Certain investments are managed by John Hancock and Capital Bank and Trust Company. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Additionally, certain employees and officers of the Company, who are also participants in the Plan, perform administrative services for the Plan at no cost. Notes receivable from participants also qualify as exempt party-in-interest transactions.

7. Risks and Uncertainties

The Plan provides for investments in various investment securities that, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Further, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to amend or terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will continue to be 100% vested in the value of their accounts.

9. Subsequent Events

For purposes of determining the effect of subsequent events on these financial statements, management has evaluated events subsequent to December 31, 2024 and through September 17, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events which have occurred that would affect the information presented in the accompanying financial statements or require additional disclosure.
