Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Volunteers of America, Dakotas 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i—schedule of assets (held at end of year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Volunteers of America, Dakotas 401(k) Plan (the Plan) provides only general information. A complete description of the Plan can be found in the Plan document.

General: The Plan was established on January 1, 1998, and is a defined contribution plan covering all qualified employees of Volunteers of America, Dakotas (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees of the Company are eligible to participate in the Plan upon reaching the age of 18 and completing 1,000 hours within 12 months. Entrance dates are the first day of each month after meeting eligibility requirements. The Plan excludes employees classified as Agency with Choice and Choices Clients from eligibility.

Contributions: There are three ways participants may contribute to the Plan: pretax contributions, Roth contributions and rollover contributions from another qualified plan. The Company may make a discretionary matching contribution to the Plan. For the year ended December 31, 2024, the Company contributed a 50% matching contribution of the first 4% of compensation that a participant contributed to the Plan for each payroll period. Additional amounts may be contributed at the discretion of the Company's Board of Directors. No such additional discretionary contributions were made for the year ended December 31, 2024.

Participants electing pretax contributions contribute a portion of their compensation to the Plan on a pretax basis. Participants electing Roth contributions contribute a portion of their compensation to the Plan after income tax withholdings and are subject to federal income taxes in the year of deferral. Participants are able to defer between 1% and 100% of their compensation or a certain dollar amount. These contributions are defined in the Plan document and are subject to limitations imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participant accounts: The Plan maintains an individual account for each participant. Each participant's account is credited with the participant's and Company's contributions and Plan earnings, less an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contributions, plus actual earnings thereon, is based on years of service. A participant is 20% vested after two years, 40% vested after three years, 60% after four years, 80% after five years and 100% after six years of credited service. Participants also become 100% vested upon death or becoming permanently disabled.

Investment options: Upon enrollment in the Plan, a participant may direct deferrals and Company contributions into any of the funds offered by the Plan. Participants may change their investment options daily.

Notes receivable from participants: Participants are able to borrow from their individual accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. The note terms generally range up to five years. The notes are secured by the balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan Administrator. The rate of interest on existing notes at December 31, 2024, was 4.25% to 9.50%. The outstanding loans mature through May 2029. Principal and interest payments are received ratably from participants through biweekly payroll deductions.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Benefits paid to participants: Participants may elect to receive a lump-sum amount equal to the value of their vested interest in their account, or partial payment, as defined in the Plan document, upon retirement, termination, death, hardship or permanent disability. An employee with a balance of less than \$7,000 may be automatically paid out by the Plan upon termination, retirement, death or permanent disability. Distributions may be made at the participant's election prior to termination upon attainment of age 59½, or upon hardship, as further described in the Plan document.

Forfeitures: As of December 31, 2024 and 2023, forfeited unvested accounts totaled \$7,472 and \$5,675, respectively. These accounts are used to pay reasonable Plan administrative expenses or to fund the Company contributions. During the year ended December 31, 2024, \$8,010 of forfeitures were used to pay Plan administrative expenses and \$458 were used to reduce employer contributions.

Note 2. Significant Accounting Policies

Basis of presentation: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein, and disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Participant loans are classified as notes receivable from participants, which are segregated from Plan investments and measured at their unpaid principal balance plus any accrued interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, Line 4i—schedule of assets (held at end of year).

Excess contributions payable: Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2024 and March 15, 2023, respectively.

Contributions: Contributions from Plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Note 2. Significant Accounting Policies (Continued)

Benefits paid to participants: Benefit payments to participants are recorded upon distribution.

Administrative expenses: Administrative expenses are paid by the Plan or the Company as provided in the Plan document. The expenses paid directly by the Company are excluded from these financial statements. Investment-related expenses are charged against investment results.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Subsequent events: The Plan Administrator evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information provided by First Bank & Trust, the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate to the best of its knowledge. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There were no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the net asset value (NAV) of identical shares as determined in active markets, held by the Plan as of year-end.

Money market fund: The money market fund is valued at the NAV of shares held by the Plan as of year-end as a practical expedient, which approximates fair value.

Collective fund: The collective fund is valued at NAV, which is provided by the trustee and used as a practical expedient to estimate fair value. The NAV is based on the fair value of the observable market prices of the underlying assets held by the fund less liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Income Tax Status

The Plan adopted a non-standardized form of a prototype plan sponsored by First Bank & Trust. The prototype plan provider has received an opinion letter from the IRS dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Note 6. Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has no uncertain tax positions that require adjustment to or disclosure in the financial statements. Therefore, no provision or liability for income taxes is included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party and Party-in-Interest Transactions

At certain times during the year, the Plan invests in a money market fund managed by First Bank & Trust. First Bank & Trust is the trustee of the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. In addition, fees of \$39,927 were paid to service providers of the Plan for administrative and investment management services for the year ended December 31, 2024.
