We have performed audits of the financial statements of The Elanco US, Inc. 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Elanco US, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1. Description of the Plan**

The following description of The Elanco US, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator. The Plan was established on January 1, 2019.

### **General**

The Plan is a defined-contribution plan sponsored by Elanco US, Inc. (Company) and participating subsidiaries, for the benefit of its full-time employees who are not a member of a recognized collective-bargaining agreement (unless the agreement makes the plan applicable to its members such as the United Food and Commercial Workers Local 6 at Fort Dodge, Iowa agreement). Employees become eligible for participation in the Plan on the first day of employment. Seasonal, part-time, or other special status employees must complete 1,000 hours of service within a 12 consecutive month period to be eligible. Lohmann Animal Health International, Inc. is a participating employer of the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan. Fidelity is also the custodian of the self-directed brokerage accounts. The Financial Advisory Council of the Company is the Plan Administrator of the Plan.

### **Contributions**

The Plan allows for participant contributions from 1% to 50% of eligible compensation up to applicable regulatory limits. Participants have the option of enrolling in a program to increase their contribution rates automatically each year. Employee Roth and rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also includes an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase of 1% and is ultimately capped at 15%.

Company matching contributions are 100% of the participant's elective deferral up to 6% of participant's eligible compensation for non-union employees. Effective April 1, 2023, Company matching contributions are 100% of the participant's elective deferral up to 6% of participant's eligible compensation for union employees hired on or after April 1, 2023. Company matching contributions were 100% of the participant's elective deferral up to 5% of participant's eligible compensation for union employees hired prior to April 1, 2023. Catch-up deferrals are not matched. The Company made an annual non-elective contribution of 3% of the participant's eligible compensation for non-union employees and employed by the Company on the last day of the plan year. The Company made an annual non-election contribution of 3% of the participant's eligible compensation for union employees hired on or after April 1, 2023, and employed by the Company on the last day of the plan year. Effective January 1, 2024, the Plan was amended to change the Company's non-elective contribution of 3% of the participant's eligible compensation for union and non-union employees to a discretionary amount. Contributions are subject to certain limitations.

### **Participant Investment Account Options**

Investment account options available include various mutual funds, common collective funds, as well as self-directed brokerage accounts. Each participant has the option of directing their contributions into any of the funds and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

All participants are vested immediately in their own contributions. A participant of the Lilly US Plan as of December 31, 2018, who became a participant in the Plan on January 1, 2019, was vested in Company matching contributions as well. For all other participants, the Company's matching contributions and non-elective contributions vest after two years of continuous service. In addition, an employee of Eli Lilly and Company who was a participant in the Lilly US Plan as in effect on December 31, 2018 (a Prior Plan Participant), as well as an Eli Lilly and Company employee who was not a Prior Plan Participant and was hired or rehired by Elanco (or one of its subsidiaries or affiliated companies) on or before December 31, 2019, is eligible for vesting credit for his or her years of creditable service with Eli Lilly and Company.

***Payment of Benefits***

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of their account or roll the balance over into another qualified plan. Withdrawals other than for termination, such as hardship and age 59 1/2 withdrawals, are permitted under certain circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$475,500 and \$496,800, respectively. During 2024 and 2023, the Company used approximately \$199,600 and \$72,600 of forfeitures to pay the Plan's administrative expenses, respectively. During 2024 and 2023, approximately \$438,300 and \$223,000, respectively, of forfeitures were used to offset Company contributions.

***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may have no more than one loan outstanding at any one time. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing market rates.

Notes receivable from participants are reported at the amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. The majority of the self-directed brokerage account assets are mutual funds, money market funds and common stocks. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trusts are valued at the NAV of units for each trust. The NAV, as provided by the trustee, are used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

The Plan holds investments in the American Century Retirement Date Trust-I Funds, common collective trusts. The investment objective of these funds is to seek the highest total return consistent with each fund's asset mix. These funds are designed for retirement plan participants who will reach the retirement age of 65 at or near the target year or who have a risk of tolerance consistent with each fund's asset allocation. As the target year approaches, each fund's asset mix will become more conservative by decreasing the allocation of stocks and increasing the allocation of bonds and cash. By the time the fund reaches its target year, the asset allocation will become fixed and match that of the American Century in Retirement Trust.

The Plan holds investments in the Putnam Stable Value Fund, a common collective trust. A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued using the NAV practical expedient, an estimate of fair value. This NAV practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Plan Tax Status***

The Plan operates under a non-standardized submitter adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR, LLC. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter since March 31, 2014, due to the prototype receiving a favorable opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and self-directed accounts. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. Such securities are classified as Level 2 of the valuation hierarchy. There are no Level 2 securities held by the Plan. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 securities held by the Plan.

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of Fidelity. The Plan paid \$291,987 and \$271,716 of administrative and trustees fees to Fidelity during 2024 and 2023, respectively. The Plan paid investment advisory fees of \$250,084 and \$108,481 to Shepherd Financial Advisory and Strategic Advisors, Inc. during 2024 and 2023, respectively. The Plan paid other professional fees to various vendors of \$41,538 and \$19,294 during 2024 and 2023, respectively.

The Plan receives revenue credits from Fidelity based on certain investments held and terms of the agreement. This account can be used by the Company to pay Plan expenses or allocated to participant accounts. A total of \$165,397 and \$109,915 of credits were received during 2024 and 2023, respectively, and were used by the Company to offset Plan expenses.

The Company provides certain administrative services at no cost to the Plan.

**Note 6. Nonexempt Transactions**

Defined-contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15<sup>th</sup> business day of the month following the month in which the participant contributions are withheld by the employer. Contributions and loan repayments of \$1,459,858 were not remitted within the required time period for the year ended December 31, 2023. The contributions were remitted during the Plan year.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Subsequent Events**

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued.

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Elanco US, Inc. 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Elanco US, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Note 1. Description of the Plan**

The following description of The Elanco US, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator. The Plan was established on January 1, 2019.

### **General**

The Plan is a defined-contribution plan sponsored by Elanco US, Inc. (Company) and participating subsidiaries, for the benefit of its full-time employees who are not a member of a recognized collective-bargaining agreement (unless the agreement makes the plan applicable to its members such as the United Food and Commercial Workers Local 6 at Fort Dodge, Iowa agreement). Employees become eligible for participation in the Plan on the first day of employment. Seasonal, part-time, or other special status employees must complete 1,000 hours of service within a 12 consecutive month period to be eligible. Lohmann Animal Health International, Inc. is a participating employer of the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) is the trustee of the Plan. Fidelity is also the custodian of the self-directed brokerage accounts. The Financial Advisory Council of the Company is the Plan Administrator of the Plan.

### **Contributions**

The Plan allows for participant contributions from 1% to 50% of eligible compensation up to applicable regulatory limits. Participants have the option of enrolling in a program to increase their contribution rates automatically each year. Employee Roth and rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also includes an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase of 1% and is ultimately capped at 15%.

Company matching contributions are 100% of the participant's elective deferral up to 6% of participant's eligible compensation for non-union employees. Effective April 1, 2023, Company matching contributions are 100% of the participant's elective deferral up to 6% of participant's eligible compensation for union employees hired on or after April 1, 2023. Company matching contributions were 100% of the participant's elective deferral up to 5% of participant's eligible compensation for union employees hired prior to April 1, 2023. Catch-up deferrals are not matched. The Company made an annual non-elective contribution of 3% of the participant's eligible compensation for non-union employees and employed by the Company on the last day of the plan year. The Company made an annual non-election contribution of 3% of the participant's eligible compensation for union employees hired on or after April 1, 2023, and employed by the Company on the last day of the plan year. Effective January 1, 2024, the Plan was amended to change the Company's non-elective contribution of 3% of the participant's eligible compensation for union and non-union employees to a discretionary amount. Contributions are subject to certain limitations.

### **Participant Investment Account Options**

Investment account options available include various mutual funds, common collective funds, as well as self-directed brokerage accounts. Each participant has the option of directing their contributions into any of the funds and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

All participants are vested immediately in their own contributions. A participant of the Lilly US Plan as of December 31, 2018, who became a participant in the Plan on January 1, 2019, was vested in Company matching contributions as well. For all other participants, the Company's matching contributions and non-elective contributions vest after two years of continuous service. In addition, an employee of Eli Lilly and Company who was a participant in the Lilly US Plan as in effect on December 31, 2018 (a Prior Plan Participant), as well as an Eli Lilly and Company employee who was not a Prior Plan Participant and was hired or rehired by Elanco (or one of its subsidiaries or affiliated companies) on or before December 31, 2019, is eligible for vesting credit for his or her years of creditable service with Eli Lilly and Company.

***Payment of Benefits***

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of their account or roll the balance over into another qualified plan. Withdrawals other than for termination, such as hardship and age 59 1/2 withdrawals, are permitted under certain circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$475,500 and \$496,800, respectively. During 2024 and 2023, the Company used approximately \$199,600 and \$72,600 of forfeitures to pay the Plan's administrative expenses, respectively. During 2024 and 2023, approximately \$438,300 and \$223,000, respectively, of forfeitures were used to offset Company contributions.

***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. A participant may have no more than one loan outstanding at any one time. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing market rates.

Notes receivable from participants are reported at the amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. The majority of the self-directed brokerage account assets are mutual funds, money market funds and common stocks. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trusts are valued at the NAV of units for each trust. The NAV, as provided by the trustee, are used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

The Plan holds investments in the American Century Retirement Date Trust-I Funds, common collective trusts. The investment objective of these funds is to seek the highest total return consistent with each fund's asset mix. These funds are designed for retirement plan participants who will reach the retirement age of 65 at or near the target year or who have a risk of tolerance consistent with each fund's asset allocation. As the target year approaches, each fund's asset mix will become more conservative by decreasing the allocation of stocks and increasing the allocation of bonds and cash. By the time the fund reaches its target year, the asset allocation will become fixed and match that of the American Century in Retirement Trust.

The Plan holds investments in the Putnam Stable Value Fund, a common collective trust. A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued using the NAV practical expedient, an estimate of fair value. This NAV practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Plan Tax Status***

The Plan operates under a non-standardized submitter adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR, LLC. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter since March 31, 2014, due to the prototype receiving a favorable opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds and self-directed accounts. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. Such securities are classified as Level 2 of the valuation hierarchy. There are no Level 2 securities held by the Plan. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 securities held by the Plan.

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of Fidelity. The Plan paid \$291,987 and \$271,716 of administrative and trustees fees to Fidelity during 2024 and 2023, respectively. The Plan paid investment advisory fees of \$250,084 and \$108,481 to Shepherd Financial Advisory and Strategic Advisors, Inc. during 2024 and 2023, respectively. The Plan paid other professional fees to various vendors of \$41,538 and \$19,294 during 2024 and 2023, respectively.

The Plan receives revenue credits from Fidelity based on certain investments held and terms of the agreement. This account can be used by the Company to pay Plan expenses or allocated to participant accounts. A total of \$165,397 and \$109,915 of credits were received during 2024 and 2023, respectively, and were used by the Company to offset Plan expenses.

The Company provides certain administrative services at no cost to the Plan.

**Note 6. Nonexempt Transactions**

Defined-contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15<sup>th</sup> business day of the month following the month in which the participant contributions are withheld by the employer. Contributions and loan repayments of \$1,459,858 were not remitted within the required time period for the year ended December 31, 2023. The contributions were remitted during the Plan year.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Subsequent Events**

Subsequent events have been evaluated through September 8, 2025, which is the date the financial statements were available to be issued.
