Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Heritage Operations Group, LLC Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Heritage Operations Group, LLC Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1 - Description of Plan

The following description of the Heritage Operations Group, LLC (the Company) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Company and its representatives are administrators of the Plan.

General: The Plan is a defined contribution plan covering all employees of the Company who have completed 12 months of service and attained a certain age. Effective May 16, 2023, the Plan was amended to change the age requirement from 19 to 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions: Participants may contribute up to an annual dollar limit set by the IRS. For the years ended December 31, 2024 and 2023, the limit was \$ 23,000 and \$ 22,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The limit on catch-up contributions was \$ 7,500 and \$ 7,500, respectively, for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants who were automatically enrolled at 3% and have made no changes to their deferral percentage during the Plan year will see their rate increase by 1% each Plan year until the amount withheld from the participant's paycheck reaches 6% of eligible compensation. The Company may make discretionary contributions to participant's accounts at the end of each Plan year. For the years ended December 31, 2024 and 2023, the Company matched 2.5% of participants' contributions, respectively. The plan allows participants to make after-tax Roth contributions in addition to pre-tax contributions.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan trustee is Empower Annuity Insurance Company of America (Empower). Participants may invest their contributions in any of several investment options offered by the Plan trustee.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company's contributions is based on periods of service with 0% vesting up to three 12-month periods of service, and 100% vesting upon completion of three 12-month periods of service. See Note 7 regarding special 2023 vesting conditions.

Note 1 - Description of Plan, continued

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$ 1,000 up to a maximum equal to the lesser of 50% of their vested account balance of \$ 50,000. The loans are secured by the balance in the participant's account and bear interest at a rate of the prime rate plus 2%, which is commensurate with the prevailing interest rate charged on similar loans under like circumstances. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits: Once participants attain the age of 59½, they are entitled to receive an in-service distribution from accounts in which they are 100% vested. Upon termination of employment due to retirement (at normal retirement age), participants are entitled to receive distributions of their vested account balances. Accounts totaling \$ 1,000 or less are distributed automatically in a lump sum payment. Accounts totaling more than \$ 1,000 but less than \$ 5,000 will be converted into an Individual Retirement Account (IRA), unless a lump sum payment distribution is elected. Accounts exceeding \$ 5,000 can either be distributed in a lump sum payment or the participant can elect to take installments over a specified period not exceeding their life expectancy or the joint life expectancy of the participant and beneficiary participants. Participants who terminate employment due to disability become 100% vested under the Plan and will receive distributions in the same manner as participants who attain normal retirement age.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$ 3,283 and \$ 5,832, respectively. These accounts will be used to reduce future employer contributions. Also in 2024 and 2023, employer contributions were reduced by \$ 4,862 and \$ 1,851, respectively, from forfeited nonvested accounts.

Revenue Sharing: The Plan has a revenue sharing agreement in place. Under the terms of the agreement, the Plan earns revenue credits based upon the Plan's holdings that will be used to fund the Plan. Amounts are used to reimburse the Company for fees and expenses associated with services provided to the Plan, or pay vendors. Amounts unused for expenses may be allocated to participant accounts in accordance with the agreement. For plan years 2024 and 2023, \$ 500 and \$ 500, respectively, in revenue sharing credits were contributed to the Plan. The revenue sharing account earned interest in 2024 and 2023 totaling \$ 22 and \$ 12, respectively. At December 31, 2024 and 2023, the balance in the revenue sharing account was \$ 1,747 and \$ 1,225, respectively.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are expensed when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded.

Note 2 - Summary of Significant Accounting Policies, continued

Investment Valuation and Income Recognition: Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value, and certain investments in trusts, which are reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Administrative expenses consist of third-party administration, and investment and other advisory services.

Note 3 - Trustee Certifications

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, investment activities included on the Statement of Changes in Net Assets Available for Benefits and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Empower Annuity Insurance Company of America, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified included total investments of \$ 20,537,433 and \$ 22,967,234 at December 31, 2024 and 2023, respectively. The information certified also included notes receivable from participants of \$ 301,353 and \$ 314,952 at December 31, 2024 and 2023, respectively, and investment gains (losses) of \$ 2,333,973 and \$ 3,925,905 at December 31, 2024 and 2023, respectively.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Annuities: Valued at the daily closing price as reported by the annuity provider. Fixed annuities are reported based on the valuation method disclosed in the annuity contract.

Collective Trust Funds: Valued as reported by the fund house or other investment provider. The funds seek investment performance based on targeted investment into certain mutual funds and other common types of investments. Collective trust funds use a net asset value per share (NAV) practical expedient and therefore a fair value measurement level cannot be assigned. The use of the practical expedient requires that the NAV is not publicly available. The collective trust funds are redeemable without restrictions.

Note 5 - Guaranteed Annuity Contract with Insurance Company

The Plan is invested in a traditional fully benefit-responsive guaranteed investment contract (Key Guaranteed Portfolio Fund) with Empower totaling \$ 1,524,260 and \$ 1,920,461 at December 31, 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The average yield earned by the Plan for the Key Guaranteed Portfolio Fund can be derived by averaging the quarterly gross interest rates for the Fund over the year. The average for 2024 is 1.41% and for 2023 is 1.23%. The actual average yield earned by the Plan for the Fund can be derived by averaging the Plan's quarterly interest rates. That average for 2024 is 1.41% and for 2023 is 1.23%. The interest crediting rate may not be less than 0% and is reset quarterly.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Certain events might limit the ability of the Plan to transact at contract value with Empower. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

Either party to the Group Annuity Contract may terminate the contract with at least 90 days advance written notice to the other party.

Note 6 - Transactions with Parties-in-Interest

Certain Plan investments are managed by Empower. Empower is the record-keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Empower, or affiliates, for the recordkeeping services and related fees amounted to \$ 132,977 and \$ 213,120 for the years ended December 31, 2024 and 2023, respectively.

The plan trustees are employees of the plan sponsor, and participants in the Plan. Therefore, the contributions made to the Plan by the plan trustees qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

During the year ended December 31, 2023, the Company sold a significant portion of their operations, and as a result of this, the number of participants in the plan was reduced by 66.6% which triggered a partial plan termination event. As such, any participants that were terminated during the year ended December 31, 2023, except for those participants terminated for cause, became 100% vested in their accounts.

Note 8 - Tax Status

The Internal Revenue Services (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10 - SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Many of the significant provisions will become effective in 2025 and thereafter. There is no material impact to the Plan's 2024 financial statements.
