**NOTE 1 - DESCRIPTION OF PLAN**

The following description of Regeneron Pharmaceuticals, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement and Summary Plan Description for a more complete description of the Plan's provisions.

General: The Plan, which was established on January 1, 1993, is a defined contribution plan covering all United States employees of Regeneron Pharmaceuticals, Inc., and its participating U.S. subsidiaries (the Company, Regeneron, Employer, or Plan Sponsor). The Plan provides for immediate eligibility upon employment for employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute up to 50% of eligible compensation, as defined in the Plan. Participants may direct their deferrals as either pre-tax or after-tax (Roth) contributions. Newly eligible employees are automatically enrolled at a pre-tax default deferral rate of 3% and they may elect to change or discontinue deferrals at any time. The pre-tax default deferral rate for participants who are automatically enrolled will increase by 1% each year up to a maximum deferral rate of 10%, unless otherwise elected by the participant. Participants who will attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Plan allows for an after-tax contribution option and a Roth In-Plan conversion option. Participants can elect to either i) contribute on an after-tax basis, or ii) contribute on an after-tax basis and convert these contributions to a Roth 401(k). After-tax contributions are not matched by the Company.

The Company, in its sole discretion, may make discretionary matching contributions to the accounts of participants under the Plan. The employer matching contribution for a Plan year is paid quarterly, with the fourth quarter matching contribution recorded as a receivable at year end. The Company has the option to make the matching contribution in the form of Regeneron common stock or cash. In the event the Company makes a matching contribution of Regeneron common stock, such shares will be held in the Plan on behalf of the individual participants. Participants are allowed to direct a portion or all of the employer matching contribution made on their behalf out of shares of Regeneron common stock into any of the other plan investment options that are available at the time of transfer; once directed out of Regeneron common stock, participants may elect to transfer only amounts in their matching contribution account back into Regeneron common stock. Participants must be employed as of the last day of the quarter to qualify for the matching contribution for that calendar quarter.

For the year ended December 31, 2024, the Company made quarterly matching contributions of 50% of each participant's contributions, up to 10% of the participant's eligible annual compensation. All employer contributions were made in Regeneron common stock and classified as "nonparticipant-directed" (refer to Note 4). The number of shares contributed on a quarterly basis was calculated based upon the average quoted market price of the Regeneron common stock for the quarter in which the employer contribution applies. For plan year 2024, 82,028 shares of Regeneron common stock were contributed.

The Company may, at its discretion, make additional non-elective contributions to the Plan on an annual basis. There were no non-elective contributions for the current Plan year.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, and (b) Plan earnings and losses, and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Vesting in the employer matching contributions, plus earnings thereon, is calculated based on years of service with 100% vesting after four years of credited service.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts under \$7,000 are automatically rolled over to an IRA selected by the Plan unless the participant elects otherwise. Benefits under \$1,000 are automatically distributed to the participant. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. All loans are covered by demand notes and are repayable through payroll deductions.

Forfeitures: Participant forfeitures of employer matching and non-elective contributions may be used to offset future employer matching or non-elective contributions of the Plan, in accordance with the terms of the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 2, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the trustee of the Plan.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Company common stock: The fair values of Regeneron common stock are determined by obtaining quoted prices from a nationally recognized exchange (Level 1 inputs).

Collective trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1 inputs).

**NOTE 6 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Parties-in-interest are defined under the Department of Labor's regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds shares of a money market fund issued by Fidelity or its affiliates. Fidelity is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees to Fidelity qualify as party-in-interest transactions. The Plan also holds shares of Regeneron common stock (Note 4) and recognized net depreciation in fair value of investments of \$135,920,753 during 2024 from this related party investment. Notes receivable from participants also reflects party-in-interest transactions.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan is no longer subject to income tax examinations for years prior to 2020.
