### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying 2024 financial statements of Hadley 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certifications from the qualified institutions as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In accordance with ERISA Section 103(a)(3)(C) pursuant to CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated October 3, 2024, indicated (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental information, other than the information in the 2023 supplemental information that agreed to or is derived from the certified investment information, were presented, in all material respects in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA and the information in the 2023 supplemental information related to assets held by and certified to by a qualified institution, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements under ERISA Section 103(a)(3)(C).

### Emphasis of a Matter

As described in the Notes 1 and 7 to the financial statements, the Plan was merged into the Choice Pooled Employer Plan III effective December 31, 2024. Our opinion has not been modified with respect to this matter.

## NOTES TO FINANCIAL STATEMENTS

### Note 1 – Description of Plan

The following description of the Hadley 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General and eligibility

The Plan was established on January 1, 2001, as a defined contribution plan. The Plan covers substantially all eligible employees of Fort Smith 3, Inc., and its related affiliates (collectively, the Company, Employers or Plan Sponsor). The Plan has been amended and restated throughout the years to comply with certain tax legislation. Eligible employees are full-time employees who have completed one (1) year of credited service and have reached the age of twenty-one (21), as defined in the Plan document. Eligible employees enter the Plan biannually on the first day of the Plan year and the first day of the seventh month of the Plan year.

The Company is the Plan Administrator and is responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Change in trustee and recordkeeper

Effective June 1, 2024, the Plan was amended to replace Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, the former trustee) with Transamerica Financial Life Insurance Company (Transamerica), the Agent for Reliance Trust Company, (the Trustee), as the Plan's Custodian. Prior to the Plan merger, Transamerica held the Plan's investment assets. Effective June 1, 2024, the Plan Sponsor approved a change in recordkeeper to Transamerica Retirement Solutions (TRS).

#### Plan merger

Effective December 31, 2024, the Plan Sponsor executed an adoption agreement with Choice Pooled Employer Plan III (successor plan), a pooled employer plan, and transferred all the participant accounts and all of the Plan's assets totaling \$2,670,908 to the successor plan. The 2024 financial statements reflect activity in the Plan through the date of transfer, December 31, 2024.

#### Contributions

Each year, participants in the Plan may contribute up to 90% of their annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Roth 401(k) contributions are not permitted under the Plan's provisions.

The Employers make matching contributions equal to 25% of the first 4% of a participant's eligible compensation, as defined, that a participant contributes to the Plan. Participants must complete one (1) year of service in order to be eligible for the Employers' matching contributions. Company contributions are invested in funds in accordance with the participant's discretion and the Plan's provisions. For the year ended December 31, 2024, the Employers' matching contributions totaled \$34,236.

Contributions are subject to certain IRS limitations.

#### Note 1 – Description of Plan, Continued

##### Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of: (a) the Employers' contributions (if any) and (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All participant contributions are participant-directed and may be invested into various investment options offered by the Plan.

##### Vesting

Participants are immediately vested in their individual contributions, plus actual earnings or losses thereon. Vesting in the Employers' contributions, if any, plus any earnings or losses thereon, is based on years of credited service. Participants who become eligible and are enrolled in the Plan will receive vesting credit for years of service based on an hours-of-service method, as defined. A participant is fully vested after three (3) years of credited service, based on a three (3) year cliff vesting schedule. Participant accounts become fully vested upon reaching normal retirement age of sixty-five (65), death, disability, or upon termination of the Plan.

##### Forfeitures

Forfeited nonvested accounts may be used to offset Plan administrative expenses or reduce future employer contributions. For the year ended December 31, 2024, no forfeitures were utilized. At December 31, 2024 and 2023, unallocated nonvested forfeited account balances totaled \$0 and \$1,914, respectively.

##### Notes receivable from participants

Plan participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the vested account balance in the participant's account and bear interest at the Prime Rate plus 1% per year and is fixed for the term of the loan. Principal and interest are paid ratably through regular payroll deductions. All loans are required to be repaid within a period of five years, except loans to acquire the participant's principal residence which must be repaid in a reasonable period of time, not to exceed thirty years. Any delinquent notes receivable from participants are recorded as distributions under the Plan's provisions.

##### Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution. For termination of service due to other reasons, a participant may choose to leave the vested interest in the Plan if such amounts exceed \$5,000 or elect a lump-sum distribution. Participants with vested amounts less than \$5,000 must elect a lump-sum distribution. Participants may take in-service withdrawals upon attainment of age 59½, or for immediate and heavy financial hardship needs, as defined. The Plan does not have an early retirement feature.

##### Plan administration

The Company is the Plan Administrator, and as such, controls and manages the operations of the Plan. The Plan's investment assets were maintained by Transamerica, as agent for Reliance Trust Company, the trustee of the Plan. Transamerica invested cash received, interest and dividend income and made distributions to participants (subject to the direction of participants).

The Plan allows certain administrative expenses to be paid from Plan investment assets.

#### Note 2 – Summary of Significant Accounting Policies

##### Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

##### Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management and its advisor determine the Plan's valuation policies utilizing information provided by the investment advisor, former trustee and Transamerica.

Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from such estimates and those differences could be material.

##### Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the high level of risk associated with certain investment securities, including the uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances the amounts reported in the financial statements.

##### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual method. Related fees are recorded as administrative expenses and expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the note receivable is reduced and a benefit payment recorded.

##### Payment of benefits

The Plan records benefits when paid.

##### Contributions

Contributions from Plan participants and the matching contributions from the Employers are recorded in the year in which they are withheld from compensation.

#### Note 2 – Summary of Significant Accounting Policies, Continued

##### Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan investment assets. Certain administrative expenses are paid directly by the Plan Sponsor and are not reflected in the financial statements.

##### Uncertain tax positions

U.S. GAAP requires the Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan management has determined it does not have any positions at December 31, 2024 that it would be unable to substantiate.

#### Note 3 – Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Financial Life Insurance Company, the Agent for Reliance Trust Company, the trustee, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 3	Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the applicable methodology used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds* – are valued at the daily quoted closing price as reported by the fund. Mutual funds held by the Plan are deemed to be actively traded on national exchanges and transact at their published daily net asset value (NAV).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Note 5 – Investment Contract with Insurance Company

Prior to June 1, 2024, the Plan invested in a fully benefit-responsive investment contract through a guaranteed investment contract with Empower Annuity Insurance Company of America (EAICA, the issuer), with a contract value of \$0 and \$222,180, respectively, as of December 31, 2024 and 2023. EAICA maintained the contributions in a general account. The Guaranteed Portfolio Fund is a general account product offered through a guaranteed investment contract. Participants' principal and interest were fully guaranteed by EAICA.

The method for calculating the interest crediting rate was based on the earnings on the underlying investments, in the entire medium long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

EAICA was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was reviewed on a quarterly basis for resetting. The Guaranteed Portfolio fund contract did not permit EAICA to terminate the agreement prior to the scheduled maturity date.

#### **Note 5 – Investment Contract with Insurance Company, Continued**

The contract met the fully benefit-responsive investment criteria and, therefore, was reported at contract value. Contract value was the relevant measurement for fully benefit-responsive investment contracts, because it was the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Under the terms of the guaranteed investment, participants could direct withdrawal or transfer transactions of all or a portion of their balance in the investment option at contract value. Contract value, as reported to the Plan by EAICA, represented contributions made under the contract, plus earnings, less participant withdrawals and expenses.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value. Such events include, but may not be limited to, amendments to the Plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or premature termination of the contract.

#### **Note 6 – Party-In-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employers, and certain others. The Plan's investments include shares of mutual funds, pooled separate accounts and a guaranteed investment contract issued, managed, and/or administered by Transamerica. Transamerica is the Plan's Custodian, and its affiliate, Transamerica Retirement Solutions (TRS), is the Plan's recordkeeper, and therefore, these transactions with Transamerica and TRS, qualify as party-in-interest transactions.

Through June 1, 2024, the Plan's investments were maintained and managed by Empower Annuity Insurance Company of America, (EAICA), which served as the Plan's custodian, and therefore, these transactions with EAICA and its affiliate, Empower Trust Company, LLC, qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the Employers. No officer or employee receives compensation from the Plan for these services.

#### **Note 7 – Plan Merger**

On December 31, 2024, the Plan merged with the Choice Pooled Employer Plan III (successor plan). Participant account balances, along with all Plan assets and liabilities, were transferred to the successor plan on December 31, 2024. Subsequent to December 31, 2024, the Plan's investment assets continue to be managed by Transamerica under the successor plan.

#### **Note 8 – Tax Status**

On August 17, 2021, the IRS stated that the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC), and therefore, the Plan and its related trust is tax-exempt. The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the Non-Standardized Pre-Approved letter, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **Note 8 – Tax Status, Continued**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note 9 – Subsequent Events**

The Plan evaluated events occurring subsequent to December 31, 2024 through September 17, 2025, the date on which the financial statements were available to be issued, for matters that should be recorded in the financial statements or disclosed in the footnotes thereto.
