INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the accompanying financial statements of Forfeiture Support Associates, LLC Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

NOTE A – DESCRIPTION OF PLAN

The following description of the Forfeiture Support Associates, LLC Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

General. Forfeiture Support Associates, LLC (the “Company”) maintains the Forfeiture Support Associates, LLC Welfare Plan and its underlying benefit programs for the benefit of its eligible employees. The Plan provides medical, dental and vision benefits for all full-time employees and their spouses and dependents. FSA provides basic life and accidental death and dismemberment insurance to all eligible employees at no cost. The basic Life and AD&D insurance coverage amount is \$25,000 for SCA employees and \$50,000 for Non-SCA employees. In addition, the Plan provides for basic short-term disability coverage at no cost to the participant. A participant may elect additional life insurance, short-term disability and long-term disability coverage.

The benefits under the Plan are funded in part through the Forfeiture Support Associates, LLC Welfare Benefit Trust. This welfare benefit trust is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan and Trust effective date is April 1, 2005. The Plan was restated on May 28, 2024.

The funding for the payments is provided under the Forfeiture Support Associates, LLC Welfare Benefit Trust, a Voluntary Employees’ Beneficiary Association (VEBA) trust that filed for IRS exemption under IRC §501(c)(9).

The Plan Administrator is Forfeiture Support Associates, LLC, and the Trustee is Bank of America. The Forfeiture Support Associates, LLC Welfare Benefit Trust delineates the responsibilities of each party.

This Plan is a covered entity and performs covered functions under the Health Insurance Portability and Accountability act of 1996 (HIPPA).

Eligibility. Regular, full-time FSA employees shall be eligible to become a participant in the Plan after satisfying the eligibility requirements described in one or more of the Plan’s underlying Health and Welfare Programs based on a determination by the Plan Administrator.

Benefits. The benefits that a participant and his dependents may receive under the Plan shall be those that are provided under the Plan’s Health and Welfare Programs. COBRA continuation benefits shall be provided to a participant and his dependents under the terms of the Plan. If a participant ceases to be an employee, the health coverage for the participant and his dependents shall cease on the last day of the month in which the participant terminates; all other benefits cease at midnight on the date of termination, except as otherwise required by law.

NOTE A – DESCRIPTION OF PLAN (Continued)

Contributions. The contributions are made to the Plan by both the employer and the participant. The employer contributes to the Plan based on the McNamara-O'Hara Service Contract Act (SCA) rate times the number of paid hours per participant up to 2080 per annum. The participant contributes based on the benefits that they select. The contributions made by the participants are made on a bi-weekly basis, and the participants cost for each benefit plan is listed on the bi-weekly insurance premium rates sheet.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting. The Plan uses the accrual method of accounting.

Estimates. The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments. The Trust's investments are stated at fair value. At year end, the entire amount is maintained in cash.

Payment of Benefits. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the company. Expenses that are paid by the company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

NOTE C – BENEFIT OBLIGATIONS

Health costs incurred by participants and their beneficiaries and dependents are covered by insurance contracts maintained by the Plan. It is the present intention of the Sponsor and the Plan to continue obtaining insurance coverage for benefits.

NOTE D – TAX STATUS

The FSA Welfare Benefit Trust established under the Plan to hold some of the Plan's net assets filed to be qualified pursuant to Section 501(c)(9) of the Internal Revenue Code, and accordingly, the Trust's net investment income will be exempt from income taxes. By a letter from the IRS dated December 19, 2007, the Trust is exempt from federal income tax under §501(c)(a) of the Internal Revenue Code with an effective date of exemption as of April 1, 2005.

NOTE E – RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

There are no material reconciling items between the amounts reported in these financial statements and the amounts recorded on Schedule H, Form 5500.

NOTE F – CASH BALANCES

The Plan maintains cash balances at a bank in excess of Federal Deposits Insurance Corporation (FDIC) limits. The Plan had cash and cash equivalents held by a commercial bank totaling \$130,444 and \$59,752, respectively as of December 31, 2024 and 2023. The federally insured limit is \$250,000.

NOTE G – SUBSEQUENT EVENT

Management has adopted ASC 855, subsequent events (formerly SFAS No. 165) effective for interim and annual periods ending after June 15, 2009. Management has evaluated events occurring after the Balance Sheet date through July 16, 2025 and determined that no material transactions have occurred that would impair the financial position or results of operations as of December 31, 2024.

NOTE H – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Forfeiture Support Associates, LLC is the administrator of the Plan, and Bank of America serves as the Plan's trustee. Both are parties in interest.

The administrator engaged FCE Benefits to provide administrative services to the Plan. Fees related to these services are included in administrative expenses. This company is also a party in interest.

NOTE I – AMENDMENT OR TERMINATION OF THE PLAN

It is the intention of FSA to maintain the Plan indefinitely. However, FSA reserves the right to amend, discontinue, terminate, merge, consolidate, divide, or otherwise restructure the Plan at any time without notice.
