### 1. DESCRIPTION OF THE PLAN

The following description of the CSWW, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** The Plan is a defined contribution plan qualifying under Section 401(k) of the *Internal Revenue Code* (IRC) of 1986. It covers substantially all employees of CSWW, Inc. (the Company) who have one year of service (1,000 hours) and are age 18 or older except union employees, nonresident alien employees, leased employees, and reclassified employees. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan is a single-employer plan. The original effective date of the Plan is January 1, 2002.

**Contributions** Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, subject to statutory annual limits. Roth deferrals are also allowed. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers).

Participants direct the investment of their contributions into various investment options offered by the Plan. Annual participant elective deferral limits prescribed by the Internal Revenue Service (IRS) for December 31, 2024 and 2023, were \$23,000 and \$22,500 for those participants who have not attained age 50 before the end of the Plan year; and \$30,500 and \$30,000 for those participants who have attained age 50 before the end of the Plan year, respectively.

The Plan administrator provides a qualified automatic contribution arrangement (QACA) basic matching contribution to participants of the Plan. This amount is calculated as 100% of the participants' elective deferral amount, not to exceed 1% of compensation, plus 50% of participants' elective deferrals in excess of 1%, but not in excess of 6% of the participants' compensation. The Plan administrator made QACA matching contributions of \$764,608 and \$690,460, for the years ended December 31, 2024 and 2023, respectively. The Plan administrator may also make discretionary additional matching contributions. No discretionary additional matching contributions were made for the years ended December 31, 2024 and 2023.

**Automatic Enrollment** Employees eligible to participate in the Plan are automatically enrolled upon meeting the eligibility requirements noted above. Unless otherwise directed, the rate of deferral upon enrollment is 3% of eligible compensation on a pre-tax basis, to be invested in specific pre-selected investment offerings based on a participant's estimated time to retirement. Unless the participant elects otherwise, their deferral contribution rate is increased automatically by 1% each year, until reaching a maximum of 6%.

**Participant Accounts** Each participant's account is credited with the participant's contributions, Plan earnings, and the Plan administrator matching contribution. Participant accounts are charged with an allocation of the administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** Participants are immediately 100% vested in their elective deferrals and rollover contributions plus actual earnings thereon. Vesting in the Company's matching contribution is based on years of continuous service, with 1,000 hours equaling one year of service. Company matching, nonelective, and additional matching contributions vest on a six-year graded schedule, with a participant becoming 20% vested after two years and an additional 20% vested each year until their sixth year of service, at which time they become 100% vested. Company QACA safe-harbor contributions vest on a two-year cliff vesting schedule.

**Notes Receivable from Participants** Loans are not permitted by the Plan.

**Payment of Benefits** On termination of service for reasons other than death, such as retirement or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or partial payments as requested from time-to-time by the participant. On termination of service due to death, a participant's beneficiary(ies) will receive a lump-sum payment equal to the value of the participant's vested interest in his or her account. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the IRC. Distributions will occur within an administratively reasonable time after termination of employment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or partial payments as requested by the participant. Terminated participants with balances of less than \$5,000 will be paid out in a lump-sum payment within a reasonable time after the participant terminates employment. As of December 31, 2024 and 2023, there were no amounts allocated to participants who elected to withdraw from the Plan but have not yet been paid.

**Forfeitures** When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan agreement, represents forfeitures. The nonvested portion will be used to pay Plan expenses, reduce contributions, or restore forfeitures and/or additional contributions. Previously, forfeitures were used only to reduce future Company contributions. The total amount of forfeitures for the years ended December 31, 2024 and 2023, were \$17,232 and \$9,932, respectively. Forfeitures used to pay Plan expenses and reduce Company contributions for the years ended December 31, 2024 and 2023, amounted to \$18,329 and \$8,838, respectively.

**Plan Termination** Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, partially terminated, or if there is a complete discontinuance of contributions by the Company, all amounts credited to the accounts of participants shall vest and become non-forfeitable.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Fair Value Measurements** The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Pooled Separate Accounts:* The underlying assets of the pooled separate account consist of mutual funds known as sub-accounts. Each sub-account invests in shares of an underlying mutual fund. Sub-accounts are measured in terms of accumulation units. The sub-accounts are valued based on the quoted market prices of the mutual funds. Certain fund fees, expenses, and administration charges (if any) are deducted from the value of the mutual funds to arrive at the value of the sub-accounts. The accumulation units are valued at net asset value on a daily basis. Participant transactions (issuances and redemptions) may occur daily. If the Plan were to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal from the pooled separate account, in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2024 and 2023.

See note 4 for the classification of these assets within the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Payment of Benefits** Benefits are recorded when paid.

**Expenses** Certain operating expenses of the Plan are deducted from participant accounts and the remaining expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

**Evaluation of Subsequent Events** The Plan administrator has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN OF THE PLAN'S INVESTMENT ASSETS

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments included in the statements of net assets available for benefits, and the investment income (loss) included in the statements of changes in net assets available for benefits as of and for the years ended December 31, 2024 and 2023, were not subject to auditing procedures and have been certified as complete and accurate by John Hancock Life Insurance Company (John Hancock). John Hancock is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

There were no transfers into or out of level 3 investments for the years ended December 31, 2024 and 2023. The Plan's policy is to recognize transfers into and out of level 3 as of the actual date of the event or change in circumstances.

**5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Company is the administrator of the Plan. The Plan's administrator may designate other persons to carry out the day-to-day operations of the Plan.

Certain Plan investments are shares of mutual funds and investment contracts managed by John Hancock. John Hancock is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

John Hancock provides certain administrative services to the Plan pursuant to an agreement between the Company and John Hancock. John Hancock receives revenue from mutual fund services provided to the funds. This revenue is used to offset certain amounts owed to John Hancock for administrative services to the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. If the revenue received by John Hancock from investment providers exceeds the amount owed under the agreement, John Hancock remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan also paid administrative fees to John Hancock of \$128,718 and \$102,155 during the plan years ended December 31, 2024 and 2023, respectively, for administrative services not covered by revenue sharing. The Plan also paid \$13,101 and \$9,365 to JCCS, PC, the Plan's third-party administrator, for the years ended December 31, 2024 and 2023, respectively.

#### **6. TAX STATUS**

The Plan has adopted a pre-approved non-standardized profit sharing plan established by JCCS, PC. The pre-approved plan obtained an opinion letter on June 30, 2020, in which the IRC stated that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has been amended since adopting the pre-approved plan the Plan administrator believes that the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

#### **7. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the investment balances, and the amounts reported in the statements of net assets available for benefits.

#### **8. PLAN AMENDMENTS**

Effective January 1, 2024, the Plan was amended to lower the eligibility age requirement to age 18 from age 21. Additionally, the Plan was amended to allow long-term, part-time employees (LTPT) to make deferral contributions into the Plan. An LTPT employee is someone who has completed a minimum of 500 hours of work each year over a span of three consecutive years, beginning in 2021. LTPT employees will not be automatically enrolled or have their contributions automatically increased over time. LTPT employees will only be eligible for employer contributions if they fulfill a different criterion: completing at least 1,000 hours of service in a single year.
