### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Neighborhood Health Plan of Rhode Island 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP"); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

### ***Auditor’s Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of Plan

The following description of Neighborhood Health Plan of Rhode Island 401(k) Plan (the “Plan”) provides only general information about the Plan’s provisions. Neighborhood Health Plan of Rhode Island (the “Company”) is the plan sponsor. Participants should refer to the plan document for a more complete description of the Plan’s provisions, copies of which may be obtained from the plan sponsor.

#### *General*

The Plan was established by the Company on January 1, 1996. Company management is responsible for the general administration of the Plan. The purpose of the Plan is to accumulate retirement income for its employees which will supplement retirement benefits provided to them by Social Security. The Plan is a contributory single-employer defined contribution plan under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is a Safe Harbor Plan.

#### *Eligibility*

Employees are eligible to participate in the Plan coincident with or after the attainment of age 18 and as soon as administratively feasible. Employees are automatically enrolled in the Plan upon meeting the eligibility requirements at a deferral rate of 5%. An employee may elect to waive participation in the Plan. The Company will automatically increase the participant contributions by 1% on or about January 15 (unless automatically enrolled for less than six months) until they reach a maximum of 8%.

#### *Participant Contributions and Vesting*

Participants may elect to contribute to the Plan any dollar amount or percentage of eligible compensation, as defined in the Plan, including any bonuses received during the year from the Company (elective deferrals). Participants who are at least age 50 before the end of the plan year may make catch-up contributions equal to any whole number percentage of their eligible compensation or whole dollar amount. Participants may not contribute more than the maximum amount allowed by the IRC. Participants are fully vested in their contributions to the Plan and earnings thereon.

Rollovers and transfers of funds from other qualified plans in which employees cease to participate are permitted, subject to approval, and are fully vested.

#### *Employer Contributions and Vesting*

Employer contributions to the Plan are equal to 100% of the amount of the eligible participant’s elective deferrals that does not exceed 3% of the participant’s compensation, and 50% of the amount of the participant’s elective deferrals that exceeds 3% of the participant’s compensation but that does not exceed 5% of the participant’s compensation. Participants are entitled to the employer matching contribution after the completion of six months of service and are immediately fully vested.

### *Participant Accounts*

Contributions are paid to the trust, which is administered by the trustee's agent who is responsible for receiving contributions, making distributions, maintaining accounts and records, and rendering an annual report. Participants designate their desired allocation of contributions to the Plan's investment funds and retain the right to change their investment allocation on a daily basis. Participants' accounts are credited with their contributions and employer contributions made on their behalf and are charged with an allocation of administrative expenses. The earnings (losses) generated by the trust investments and administrative expenses are allocated to participants' accounts daily, based upon the proportionate value of all active accounts to accounts participating in the fund as of the valuation date, as defined in the Plan. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account balance.

### *Notes Receivable from Participants*

A participant may borrow from their vested account balance subject to the administrative rules of the Plan. Any note receivable will not be approved for a participant in an amount which exceeds 50% of a participant's account balance. The minimum note receivable amount is \$1,000 and the maximum note receivable amount is \$50,000, reduced by the excess of the participant's highest outstanding participant note receivable balance during the 12-month period ending on the date of the note receivable over the participant's current outstanding participant note receivable balance on the date of the loan. A participant can only have one note receivable currently outstanding from the Plan. Notes receivable will be permitted for any reasonable purpose, and loan refinancing is permitted. Notes receivable may only be made for accounts attributed to either salary deferral (pre-tax and Roth 401(k)) or rollover account balances from other plans. All notes receivable will be considered a directed investment from the account of the participant maintained under the Plan. As such, all payments of principal and interest made by the participant will be credited only to the account of such participant. The Plan also will charge the portion of the participant's account balances with expenses directly related to the origination, maintenance, and collection of the note.

The notes receivable bear interest at a rate determined by the plan administrator (prime rate plus 1%). The note receivable must provide at least quarterly payments under a level amortization schedule. The participant receiving a note receivable from the Plan is required to enter into a payroll deduction agreement or an ACH agreement to repay the note receivable. Note receivable terms may range up to five years unless the note receivable qualifies as a home loan. A home loan is a loan used to acquire a dwelling unit which, within a reasonable time, the participant will use as a principal resident. A home loan may be repaid over a period not exceeding 15 years.

### *Payment of Benefits*

Upon termination of employment by reason of normal retirement, death, or total and permanent disability, participants will be entitled to 100% of the amounts credited to their accounts. Upon termination of employment for other than normal retirement, death, or total and permanent disability, participants will be entitled to the vested amounts credited to their accounts. Benefits are payable in a single lump-sum payment. The Plan allows participants to withdraw all or any part of their vested account balance after attaining age 59½.

### *Hardship Withdrawals*

Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, in an amount up to 100% of the participant's account balance, as defined by the Plan.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value includes the Plan's gains and losses on investments bought, sold, and held during the year.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. The note receivable will be considered in default if any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the schedule payment or the participant makes or furnishes any false representation or statement to the Plan. When a note receivable is considered in default, the note balance is reduced and a benefit payment recorded.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation in fair value of investments. Total administrative expenses, including advisor fees, paid by the Plan totaled \$132,796 for the year ended December 31, 2024.

### ***Subsequent Events***

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

The plan administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan and qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the statements of net assets available for benefits as of December 31, 2024 and 2023 and, the supplemental schedule, Form 5500 - Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected on the statement of changes in net assets available for benefits for the year ended December 31, 2024. The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **4. Fair Value Measurements**

The Financial Accounting Standards Board Accounting Standards Codification ("ASC") Topic 820, Fair Value Measurement, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

### ***Mutual and Money Market Funds***

Investments in mutual and money market funds are valued at the daily closing price as reported by the fund. Investments held by the Plan are in registered investment companies that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value ("NAV") and to transact at that price. The investments held by the Plan are deemed to be actively traded.

### ***Common/Collective Trust***

Units of a collective trust are reported at NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(2) The common collective trust for December 31, 2024 and 2023, is invested in the Galliard Capital Management Stable Return Fund C (wholly owned subsidiary of Wells Fargo) and Wells Fargo Stable Value Fund Class C, respectively. The objective of this fund is to provide investors with a moderate level of stable income without principal volatility. There exists no unfunded commitments. Redemption can occur daily subject to certain restrictions or at the discretion of the investment advisor.

### 5. Related-Party Transactions and Party-in-Interest Transactions

All plan investments are in the custody of Charles Schwab Trust Bank as of December 31, 2024 and 2023, the trustee of the Plan; therefore, any transactions between Charles Schwab Trust Bank and the Plan qualify as party-in-interest transactions. The Plan made a direct payment to Charles Schwab Trust Bank in the amount of \$25,725, which is included in administrative expenses during the year ended December 31, 2024.

## Notes to Financial Statements

All plan investments are managed by iCapital, LLC, an investment advisor. Therefore, any transactions between the Plan and iCapital, LLC qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. Fees incurred by the Plan for investment advisory services were \$107,121, which are included in administrative expenses during the year ended December 31, 2024.

Total administrative expenses paid by the Plan during the year ended December 31, 2024, were \$132,796. The Company pays directly any other fees related to the Plan's operations. The Plan extends notes receivable to participants which are also considered party-in-interest transactions.

### **6. Plan Termination**

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would remain 100% vested in their employer contributions.

### **7. Tax Status**

The Charles Schwab Trust Bank pre-approved plan obtained an opinion letter dated September 21, 2020, in which the Internal Revenue Service stated the restated pre-approved plan documents were in compliance with applicable requirements of the IRC. The plan administrators timely adopted the restated pre-approved plan. Although there have been amendments to the Plan since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
