### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

#### **Other Matter—Supplemental Schedule Required by ERISA**

The supplemental schedule of Schedule H, Part IV, Line 4i – schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## 1) Plan Description

The following description of Presbyterian Medical Services Discretionary Contribution Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

### General

The Plan is a defined contribution plan covering employees of Presbyterian Medical Services (PMS). Employees become participants in the Plan on the 1st of January or July immediately following the employee attaining age 18 and completing 1,000 or more hours of service during the 12-month period beginning with original employment date. An employee must complete 1,000 hours of service during a Plan year and be employed on the last working day of the year in order to share in the allocation of PMS’s contribution for that year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). PMS serves as the plan administrator.

### Contributions

The Plan does not allow participant deferrals. PMS may decide to make a discretionary nonelective contribution to the Plan for any year in such amount and for such classification of employees as may be determined by the Board of Directors of PMS. Under the Plan, participants eligible to share in the nonelective employer contributions are separated into three classifications. During 2024 and 2023, PMS made the following nonelective contributions by classification based on the participants’ eligible compensation as defined by the Plan:

### Participant’s Accounts

Each participant’s account is credited with an allocation of PMS’s contribution and Plan earnings or losses. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

The Plan's vesting schedule is as follows:

A year of vesting service is defined as any Plan year in which an eligible employee is credited at least 1,000 hours.

## Investment Options

The Plan does not permit participant directed investments. PMS directs the investment of funds into several registered investment company options.

## Notes Receivable from Participants

The Plan does not permit notes receivable from participants.

## Payment of Benefits

Benefits are payable in the event a participant retires, dies, becomes disabled or otherwise ceases to be an employee of PMS. A participant may receive the value of the vested interest in his or her account as a lump-sum distribution or equal installments.

Payment of participant plan benefits normally may be made as soon as administratively feasible after the last day of the Plan year coincident with or next following termination of employment.

## Mandatory Cash-Out Provisions

If the amount of benefits is \$5,000 or less at the time of separation, the Plan automatically roll the funds into an IRA, without consent of the participant.

## Forfeited Accounts

Forfeitures of terminated participants' nonvested balances may be used to offset future PMS contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$136,731 and \$229,674 respectively. For the years ended December 31, 2024 and 2023, forfeitures totaling \$229,674 and \$401,236, respectively, were used to reduce PMS's contributions made in 2024 and 2023.

## 2) Summary of Significant Accounting Policies

### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Risk and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect the participants' account balances and amounts reported in the statements of net assets available for benefits.

### Benefit Payments

Benefits are recorded when paid.

### Administrative Expenses

The Plan permits, but does not require PMS to pay costs of plan administration. For the years ended December 31, 2024 and 2023, all administrative expenses were paid by the Plan. Investment management service expenses are included in net appreciation or depreciation in fair value of investments. Administrative expenses include recordkeeping and investment advisory services.

### Subsequent Events

Subsequent events were evaluated for recognition or disclosure in these financial statements through August 29, 2025.

**3) Investments and Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Quoted prices in markets that are not considered to be active or financial instruments without quoted market prices, but for which all significant inputs are observable, either directly or indirectly.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methodology described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4) Information Prepared and Certified by Trustees (Unaudited)

The Plan administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was obtained or derived from information provided to the Plan administrator by Ascensus, LLC, the parent entity of Ascensus Trust Company, the current Trustee effective November 13, 2024, and Newport Trust Company, the former trustee through November 12, 2024, qualified institutions, and certified as complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income reflected on the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments reflected on the supplemental schedule of assets held at end of year.

#### 5) Plan Termination

Although it has not expressed any intent to do so, PMS has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their account balance.

## **6) Income Tax Status**

The Plan is operating under a volume submitter document. The Internal Revenue Service (IRS) has determined and informed the Plan sponsor by letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

## **7) Concentrations**

The Plan's investment in iShares S&P Stock Index Fund represents approximately 16% of total investments as of December 31, 2024 and 2023. The Plan's investment in MFS International Value Fund represents approximately 12% of total investments as of December 31, 2024 and 2023.

## **8) Related-Party Transactions and Party-In-Interest Transactions**

Plan investments are held by Ascensus Trust Company, the current Trustee, and Newport Trust Company, the former trustee (collectively the Trustees). Therefore, these transactions qualify as party-in-interest transactions. In addition, PMS provides certain accounting, administrative, and management services to the Plan for which no fees are charged. For the year ended December 31, 2024 and 2023, fees paid by the Plan for administrative expenses, such as third-party administrative fees, were \$152,317 and \$148,813, respectively.
