### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Logitech 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the Logitech 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more specific provisions.

**A. General**

The Plan is a defined contribution plan established in 1987 to provide benefits to eligible employees of Logitech, Inc. (the “Company”). The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

**B. Eligibility**

The Plan specifically excludes certain groups including interns, leased employees, employees covered by a collective bargaining agreement and non-resident aliens. Substantially all other employees of the Company are eligible for the Plan on their date of hire with no age or service requirement.

**C. Participant Contributions**

Participants may elect to contribute their pre-tax compensation, elect to make Roth after-tax contributions and/or voluntary after-tax contributions to the Plan. Each participant’s pre-tax deferrals, Roth and after-tax contributions are limited to a maximum of 75% of eligible compensation subject to applicable Code limits. Participants of age 50 or older may elect to make additional catch-up contributions subject to applicable Code limits.

Newly eligible participants who do not make an affirmative election to defer compensation to the Plan, or an affirmative election to not defer to the Plan, are auto-enrolled in the Plan at a deferral rate of 6% of eligible compensation.

Participants are also permitted to make rollover contributions of amounts received from other tax-qualified retirement plans and to make in Plan Roth rollovers of their vested accounts. Such contributions are invested in accordance with participant directions and Plan provisions.

**D. Employer Contributions**

The Company may make discretionary matching contributions, as defined in the Plan, and approved by the Board of Directors. For the 2024 Plan year, the Company matched 50% of the first 6% of compensation deferred by participants, to a maximum of \$10,350 per participant. The Plan also allows the Company to make discretionary non-elective contributions. No non-elective contribution was made for the 2024 Plan year.

**E. Participant Accounts**

Each participant’s account is credited with the participant’s contributions, rollovers, an allocation of Company contributions and Plan earnings or losses and expenses. Participants may direct their investments among a diversified menu of core investment funds offered under the Plan, or they may elect to establish a self-directed brokerage account in which they may invest in any investment security approved by the Plan Administrative Committee. Assets of the Plan are invested based solely on participant directions.

**E. Participant Accounts (Continued)**

Contributions allocated to participants who decline to make an investment election are invested in the Schwab Indexed Retirement Fund appropriate for an individual's age and projected date of retirement.

**F. Vesting**

Participant accounts are immediately 100% vested in their accounts.

**G. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their account balance. A loan is secured by the participant's account balance, bears interest at a fixed rate similar to rates offered by commercial lenders under similar circumstances, and must be repaid to the Plan within a five year period unless the loan is used for the purchase of a principal residence, in which case the maximum loan term may be extended. Principal and interest are paid ratably through payroll deductions. Participants are permitted to have a maximum of one loan outstanding at any time. The plan administrator approves the specific terms and conditions of each loan. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with various maturities through December 2034 and are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan.

**H. Payment of Benefits**

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement or attainment of age 55, a participant or beneficiary may maintain his or her account in the Plan or elect to receive benefits in a lump sum or installments. Hardship withdrawals are permitted from accounts attributable to elective deferrals and rollovers under limited circumstances subject to approval of the plan administrator. Benefits are recorded when paid.

**I. Expenses**

Costs of administering the Plan may be paid by the Plan or the Company as provided in the Plan document. Investment funds charge indirect fees for fund management and other administrative services that are factored into a fund as a reduction in investment return. Participants pay an annual fee for recordkeeping and administration that is deducted on a quarterly basis.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and

assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**D. Risks and Uncertainties**

Plan investments include a variety of securities that are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - INCOME TAX STATUS**

The Company adopted a prototype plan that has received an opinion letter from the Internal Revenue Service stating that the form of the plan qualifies under applicable provisions of the Code. The Company believes that the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investment funds are managed by affiliates of the trustee. Purchases and sales of these funds and payment of expenses by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition against party-in-interest transactions under ERISA.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the trustee.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at closing market prices of shares held by the Plan at year end. Common stocks exchange traded funds and other publicly traded securities maintained in self-directed brokerage accounts are valued at the closing prices reported on the active markets on which the securities are traded. Although the plan administrator believes these valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date. The following tables summarize Plan investments at December 31 based on the inputs used to value them:
