## Independent Auditors' Report

To the Plan Administrator and Participants of  
Partners Information Technology 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit on the Financial Statements

We have performed an audit of the financial statements of Partners Information Technology 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 – SUMMARY OF THE PLAN**

Plan Description

The following description of the Partner’s Information Technology 401(k) Profit Sharing Plan (the “Plan”), formerly known as Partners Consulting Services, Inc. 401(k) Profit Sharing Plan, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was effective on January 1, 1992 and qualifies as a defined contribution retirement plan for Partners Information Technology, Inc. dba Calance (the “Company”), formerly known as Partners Consulting Services, Inc., eligible employees. On January 31, 2012, Partners Information Technology, Inc. took over the Plan and became the Plan’s sponsor. This Plan was established for the purpose of providing retirement benefits to eligible employees in accordance with the Plan. The Plan is intended to satisfy the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) of 1986, as amended. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administration

The Plan is administered by the Company. Voya Retirement Insurance and Annuity Company is the asset custodian of the Plan (“Asset Custodian”).

Participant Eligibility

Each of the Company’s employees is eligible to participate in the 401(k) Plan. Once the eligibility requirement has been met, employees may enroll in the Plan. In order to be eligible to receive an allocation of the discretionary employer contribution for the Plan year, the employee must have completed 1,000 hours of service during the Plan year.

Contributions

Participants may elect to contribute to the Plan, on a pre-tax basis, up to 50% of total annual compensation up to the 402(g) limit. The 402(g) limit for 2024 was \$23,000. In addition, all eligible employees who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions up to \$7,500 for 2024 in accordance with, and subject to the limitations of, Code Section 414(v). The Company may make a discretionary matching contribution equal to an amount determined by the Company. For the year ended December 31, 2024 there were no employer discretionary matching contributions.

Participant Accounts

Each participant’s account is credited with the participant’s allocation of (a) the Company’s matching contribution, (b) the Company’s discretionary contribution, (c) the participant’s contribution and, (d) Plan earnings.

Investment Options

All accounts are invested in accordance with the terms of the Plan document and investment options elected by participants. Participants direct the investment of their contributions into various investments offered by the Plan.

Amounts forfeited from terminating participants' non-vested portion of their Company matching contribution account and Company discretionary contribution account and earnings on Company contributions are used first to reduce administrative expenses, then to reduce matching and discretionary contributions. As of December 31, 2024 and 2023, the Plan held forfeited non-vested account balances of \$76,713 and \$37,704, respectively. These forfeitures represent unallocated assets which will be used to offset future administrative expenses and employer contributions. During 2024 and 2023, \$1,175 and \$0, respectively, were used to offset administrative expenses.

Payment of Benefits

In the event of retirement, death, disability, or termination, a participant or beneficiary may elect to receive a lump-sum payment, make partial withdrawals, or rollover the balance in their account to an eligible retirement Plan, equal to the value of the participant's vested interest in his or her account. Distributions will be made as soon as administratively feasible following termination of employment. If upon termination, the participant has not elected to receive or rollover their balance and, if the vested account balance does not exceed \$5,000, the Asset Custodian will follow the Plan's provisions for mandatory distribution. If the participant's vested account balance exceeds \$5,000, he or she may elect to keep the account in the Plan and maintain his or her account in any of the Plan's investment options.

Any withdrawals made upon terminating employment and prior to the participant attaining age 55 will be subject to the applicable federal and states taxes and/or penalties, unless it is a rollover into an eligible retirement plan or IRA. There is no penalty for withdrawals due to death or disability.

Hardship Distributions

A participant may elect a hardship distribution if it is deemed that the participant has an immediate and heavy financial need as described by the Plan. Any hardship withdrawals made prior to the participant attaining age 59½ will be subject to the applicable federal and states taxes and/or penalties.

**NOTE 1 – SUMMARY OF THE PLAN (CONTINUED)**

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of the participant's vested account balance, \$50,000, or the limitations set by the Tax Reform Act of 1986 and Section 408(b) of ERISA. The loans are to be repaid through payroll withholding over a period of five years or longer if the loan is used to acquire a principal residence under hardship circumstances. The notes are secured by the balance in the participant's account and bear interest at a rate based on the rates available for similar notes from commercial lending institutions as determined by the Plan Administrator.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Loans mature through February 2033 with interest rates ranging from 7% to 10.50%.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America ("GAAP"). A summary of the significant accounting policies applied in the preparation of the accompanying financial statements follows.

Accounting Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses

The Plan pays recordkeeping, maintenance and service fees. Other Plan expenses are paid by the Company. Investment manager fees are paid from participants' accounts. The Plan incurred \$ 43,680 in administrative expenses during the year ended December 31, 2024.

Payment of Benefit

The Plan does not accrue non-distributed benefits related to participants who have withdrawn from the Plan but recognizes such benefits as a deduction from net assets in the period in which such benefits are paid.

Non-Discrimination for Employee and Employer Contributions

The Plan, as required by the IRC, performs annual tests between highly compensated participants versus non-highly compensated participants to ensure that highly compensated participants are not disproportionately favored under the Plan. If the Plan fails the tests, it must refund excess deferral contributions or make a Qualified Non-Elective Contribution ("QNEC") for the non-highly compensated employees. Excess contributions that are refunded within two and a half months of the Plan year end are accrued as a liability on the statement of net assets available for benefits. For the year ended December 31, 2024, the Company made no QNEC.

Investment Valuation and Income Recognition

Investments are reported at fair value except for investments in the Voya Fixed Account and Voya Fixed Account A (“Fixed Accounts”). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Boards (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

- Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2            Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan's Fixed Accounts have underlying investments in guaranteed investment contracts (“GICs”) and is stated according to the ASC Section 962-325-50-3 (“ASC 962-325-50-3”), which states that contract value is the relevant measurement attributable for that portion of the net assets available for benefits as a defined-contribution Plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The accompanying financial statements have been adjusted to report fully benefit-responsive investment contracts at contract value for all periods presented. As of December 31, 2024 and 2023 the contract value of the fixed account investment GIC was \$5,645,532, and \$5,544,156, respectively. As of December 31, 2024 and 2023 the settlement value of the GIC was \$4,861,321, and \$4,856,506, respectively.

At December 31, 2024 and 2023, the Plan has investments in pooled separate accounts totaling \$32,547,339 and \$30,276,304, respectively. Fair value for the Plan's pooled separate account investments is measured using net asset value per share ("NAV") as a practical expedient. NAV of these investments is based on the fair value of the fund's underlying net assets divided by the number of units outstanding. In accordance with Financial Accounting Standards Board Accounting Standards Codification 820-10, since the Plan's pooled separate account investments are measured at NAV as a practical expedient, the disclosure of the fair value hierarchy information of these investments is not applicable. The Plan has no unfunded commitments related to the pooled separate accounts and redemptions and subscriptions are permitted daily.

For the year ended December 31, 2024, the net appreciation in fair market value of investments was \$4,847,182.

**NOTE 3 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. All of information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Asset Custodian. The contract value of the fixed account investment GIC was certified by the Asset Custodian.

**NOTE 4 – TAX STATUS**

The Internal Revenue Service made a favorable determination in a letter dated March 31, 2014 that stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The trustee, Plan sponsor, and Plan administrator are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 5 – OPERATIONAL DEFECT**

The Plan has various distributions payable on the statement of net assets available for benefits as of December 31, 2024. These payables consist of required corrective distributions resulting from employee contributions that exceeded permitted limits, which are distributed in accordance with the non-discrimination provisions of the Plan. Additionally, the payables include excess deferral contributions resulting from employees contributing more than their elected deferral amounts. For the Plan year ended December 31, 2024, corrective distributions of \$5,289, were recorded.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts.

**NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the Asset Custodian, therefore, these transactions qualify as party-in-interest transactions which there is statutory exemption under ERISA. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
