### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Retirement Savings Plan of Father Flanagan's Boys' Home, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

### 1. Plan Description

---

The following description of the Retirement Savings Plan of Father Flanagan's Boys' Home (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is sponsored by Father Flanagan's Boys' Home (the Organization) for the benefit of its full-time employees. The Plan was established on January 1, 1998, as a spin-off of the Pension Plan and Employees Trust of Father Flanagan's Boys' Home (Pension Plan). Prior to the spin-off, all employees covered under the Pension Plan had to elect to transfer to the new Plan or remain in the existing Pension Plan. For those employees who elected to remain in the existing Pension Plan, they irrevocably elected to waive participation in the Plan.

Full-time employees, excluding "on-call" employees are eligible to make salary deferral contributions and receive discretionary matching and profit sharing contributions immediately upon their hire date. Participants must have 1,000 hours worked during the year in order to receive discretionary profit sharing contributions. Part-time employees may be eligible upon completion of 1,000 hours worked during one year of service. Participants must be employed on the last day of the year to receive discretionary matching contributions made through a true-up calculation after the Plan's year end date.

#### ***Contributions***

Participants - Participants may make voluntary pre-tax and designated Roth after-tax salary deferral contributions up to 60% of their annual eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans. Participants are automatically enrolled with an initial 3% salary deferral contribution and their salary deferral contributions will annually increase 1% up to 6%. At any time, a participant may elect not to contribute or may increase or decrease their deferral rate as allowed under Plan provisions. All participants who are eligible to make deferral contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

Employer - The Organization may make discretionary matching contributions. For the years ended December 31, 2024 and 2023, the Organization's discretionary matching contribution equaled 100% of elective deferrals, including elective deferrals into the Father Flanagan's Boys' Home Tax Favored Savings Plan, up to 6% of eligible compensation. Subsequent to the Plan years ended December 31, 2024 and 2023, a true-up discretionary matching contribution of \$335,298 and \$331,090, respectively, was contributed to the Plan. The true-up contributions made for the years ended December 31, 2024 and 2023, were reduced fully through the use of forfeitures. The Organization may also elect to make annual discretionary profit sharing contributions as determined by the Organization's Board of Trustees. The Organization made no discretionary profit sharing contributions for the years ended December 31, 2024 and 2023.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocation of a) the Organization's discretionary matching contributions and discretionary profit sharing contributions and b) Plan earnings or losses. The Organization's discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Organization's discretionary profit sharing contributions are allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Vanguard Fiduciary Trust Company (Vanguard).

### ***Vesting***

Participants are immediately vested in their voluntary salary deferral contributions plus earnings thereon. Vesting in the Organization's discretionary matching and profit sharing contributions plus earnings thereon is based on years of continuous service. Participants are 25% vested after two years of credited service and vesting increases 25% per year until the participant is 100% vested after five years of credited service.

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All notes are repayable over a period not to exceed five years through payroll withholdings unless the participant is paying the loan in full. The notes are secured by the balance in the participant's account. Interest on loans is based on local prevailing rates as determined by the Pension Committee.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive a lump-sum, partial, or installment payments equal to the value of the vested funds allocated to the participant's account. The Plan requires mandatory distribution of payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement plan designated by the plan administrator in the event the participant does not elect a payout option. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. The Plan allows for in-service distributions for participants who have reached the age of 59 ½. Participants may also receive hardship distributions, as defined by the Plan document. Benefits are recorded when paid.

### *Forfeitures*

Upon termination of employment before normal retirement, disability, or death, the portion of their Organization's contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to pay administrative expenses or to reduce Organization's contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,049,904 and \$2,103,148, respectively. During 2024 and 2023, Organization's contributions were reduced by \$365,870 and \$668,059, respectively.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### *Presentation of Participant-Directed Funds*

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Other fees specifically incurred by or attributable to individual participants are paid from the applicable participant's account. Investment related expenses are included in net appreciation in fair value of investments.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Subsequent Events***

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 12, 2025, noting no items requiring disclosure.

### **3. Information Certified by Vanguard**

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Vanguard, except for comparing such information certified by the trustee and custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the funds. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. Funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* Valued at the NAV based on the market value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that these trusts meet those requirements. Participants can redeem the trusts at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023.

*Self-Directed Brokerage Fund:* The self-directed brokerage account includes investments in mutual funds and money market funds. The mutual funds and money market funds are valued at the closing price reported by the funds at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Tax Status

---

The Internal Revenue Service (the IRS) has determined and has informed the Organization by a letter to the Plan dated March 7, 2017, that the respective Plan was designed in accordance with the applicable regulations of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### 6. Plan Termination

---

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participants and distributed as soon as practicable after the termination date.

#### 7. Related-Party Transactions

---

Certain plan investments are mutual funds, common collective trusts, and a self-directed brokerage fund with underlying mutual funds managed by Vanguard. Vanguard is the trustee and custodian of the Plan, and therefore, these transactions qualify as party-in interest transactions. The Plan paid \$479,396 and \$516,981 of record-keeping fees to Vanguard for the years ended December 31, 2024 and 2023, respectively.
