1. Description of Plan

The following description of Lightspeed Commerce 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible full-time employees of Lightspeed POS USA Inc. and the adopting employers (collectively, the "Company" or "Employer") established on January 1, 2014. Full-time employees who have attained age 21 and completed 90 days of service are eligible to participate in the Plan. Part-time employees who have attained age 21 and completed 1,000 hours of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 90% of their plan compensation on a pre-tax or Roth basis, subject to limitations of the Internal Revenue Code ("IRC"). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set 4% of plan compensation on a pre-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount. Participants may also contribute amounts in form of a rollover from other qualified plans.

The Employer makes a matching contribution on behalf of eligible participants in an amount equal to 100% of the first 4% of plan compensation used for elective deferrals. Matching contributions are capped at \$5,000 per year for each participant.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. All investments are participant directed.

Vesting

Participants are immediately vested in their contributions and Employer matching contributions plus actual earnings thereon except for participants of the Lightspeed Commerce USA, Inc. 401(k) Plan whose accounts were transferred into this Plan and who did not complete an hour of service on or after January 1, 2022. Vesting for those participants' matching contribution account balances plus actual earnings thereon is as follows:

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,524 and \$1,501. These accounts may be used to reduce Employer contributions or pay Plan expenses. During 2024, no amounts were used to reduce Employer contributions or pay Plan expenses.

Plan Expense Account

The Plan and Empower Trust Company, LLC entered into a service based pricing arrangement whereby a portion of the revenue earned by certain Plan investments is passed through to the Plan for payment of permitted Plan expenses. The Plan Expense Account is a nonparticipant directed account within the Plan. At December 31, 2024 and 2023, the Plan Expense Account balance was \$0 and \$0. During 2024, the Plan Expense Account earned revenue of \$42,657 and Plan expenses amounting to \$42,657 were paid from the Plan Expense Account.

Payment of Benefits

The Plan provides for normal retirement at age 65. The Plan permits distributions to participants upon termination from the Company or due to death or disability. The normal form of payment is a lump sum. A participant may request an in-service distribution once they have reached age 59½. Upon heavy and immediate financial need, a participant is also eligible to take a hardship distribution. A participant may also take a distribution due to death or disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balances. The loans are secured by the balance in the participant's account and bear interest at rates at the prime interest rate as published by the Wall Street Journal plus 2 percentage points. A participant may only have one loan outstanding at any time. Principal and interest is paid ratably through payroll deductions over a period not to exceed five years unless the loan is for the purchase of a participant's principal residence, in which case the loan must be payable within a period not to exceed fifteen years.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the guaranteed investment contract, which is reported at contract value. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value ("NAV") and to transact at that price. Mutual funds are deemed to be actively traded. The guaranteed investment contract is valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on a trade- date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

Payment of Benefits

Benefit payments are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 10, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Life & Annuity Insurance Company of New York, qualified institutions.

4. Guaranteed Investment Contract

Participants have the option to invest in a fully benefit-responsive investment contract called the Empower Investments Fixed Account (the “Account”). The Account is a general account product of Empower Life & Annuity Insurance Company of New York. Principal and interest for participant-initiated benefit payments are fully guaranteed by the entire general account of Empower Life & Annuity Insurance Company of New York. The Account credits interest daily and may change quarterly. The crediting rate applies to all money deposited regardless of when it was deposited.

Upon termination of the group annuity contract, the Company may choose the following options associated with the Account depending on the provisions: (1) receive the payout of the Account in a lump sum with a market value adjustment; (2) receive the payout of the Account in 20 quarterly contract value installment payments or (3) mutually agree in writing to any other payout option allowable under the applicable law. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

5. Tax Status

The Plan’s prototype plan document preparer has obtained an opinion letter dated June 30, 2020 from the Internal Revenue Service (“IRS”) stating that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has since been amended, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

5. Tax Status (continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

During 2022, it was discovered that during multiple years, the Plan's written provisions were not all consistent with its operation or management's expressed intentions as communicated to participants. To correct these defects, the Plan is preparing to enter the IRS Employee Plans Compliance Resolution System ("EPCRS"). Plan management believes that under the EPCRS Voluntary Correction Program ("VCP") the identified defects will be corrected, and that the IRS will issue a compliance statement preserving the tax-exempt status of the Plan. Corrective Employer contributions for certain defects identified during 2022 were remitted to the Plan in 2024. Additional corrective Employer contribution amounts were identified and remitted to the Plan in May 2025. The proposed corrective Employer contributions are included in the corrective Employer contributions receivable amount on the statements of net assets available for benefits.

6. Party-In-Interest Transactions

Certain investments are managed by Empower Life & Annuity Insurance Company of New York and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Company, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

8. Prohibited Transaction

During the 2022 plan year, the Employer failed to remit to the Plan certain participant contributions and loan repayments amounting to \$346,999 within the period described by the Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Employer has made the necessary corrections to satisfy both the Department of Labor and IRS guidance for the delinquent contributions.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
