Opinion on the 2024 Financial Statements



Notes to Financial Statements

1. **Description of the Plan** The following description of the Group W Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Summary of Plan Provisions for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Group W Inc. (the "Company") who have attained age 21, except for part-time employees, employees covered by a collective bargaining agreement, and nonresident aliens. Employees may enter the Plan on the first day of the month coinciding with or subsequent to satisfying the eligibility requirements. The Plan was amended and restated effective January 1, 2024 ("Restatement"). Effective with the Restatement, leased employees are excluded from the Plan and employees must also complete at least one hour of service to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Each year, the Company makes contributions to the Plan at the discretion of the Company's Board of Directors. In addition, the Company contributes amounts necessary to pay benefits to participants. Participants must complete at least 501 hours of service during the Plan year or be active on the last day of the Plan year to receive an allocation of the Company's contributions. The Plan does not permit any contributions from its participants. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with allocation of the Company's discretionary contribution, if any, and investment earnings and losses. Allocations of investment earnings and losses are based on the account balances, as defined in the Plan document. Allocations of the Company's discretionary contributions, if any, are based on the ratio of the participant's compensation to total compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants vest immediately in the Company discretionary contributions plus actual earnings thereon.

Notes to Financial Statements

Payment of benefits: Benefits are payable upon retirement at age 65, disability, death or termination of employment. Effective with the Restatement, the retirement eligibility was modified to be the later of age 65 or the completion of five years of service. Distributions due to retirement, disability, and death shall commence no later than the subsequent Plan year. Distributions due to termination shall commence no later than the fifth Plan year following the termination. Effective with the Restatement, distributions due to termination shall commence no later than the third Plan year following the termination. Benefits are payable in equal annual installments over a period not exceeding five years. Effective with the Restatement, benefits are payable in lump sum or substantially equal annual installments over a period not exceeding three years.

Diversification: Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified; the sixth year the participant may diversify up to 50 percent.

Voting rights: Participants will be entitled to exercise voting rights attributable to the shares of Company stock allocated to their accounts in the Plan with respect to certain major corporate matters, such as mergers, consolidations, sale of all assets, or the liquidation of the Company. The Plan Trustee votes on all other corporate matters.

Put option: Under federal income tax regulations, any Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no active market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Administrative expenses: Substantially all administrative expenses of maintaining the Plan are paid by the Company.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments held during the year.

The Plan's sole investment consists of 24,903 shares of Company stock as of December 31, 2024 and 2023.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through September 15, 2025, which is the date the financial statements were available to be issued.

- 4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The Plan's investment in shares of the Company's common stock is reported at its fair value as determined by an independent appraiser retained for the purpose by the Plan's trustee. The independent fair value appraisal is dependent upon historical and forecasted operations of the Company as represented by management, and general industry and market conditions affecting the Company's business. The fair value appraisal was determined using the income approach. Within the income approach the discounted cash flow method was used.

- 5. Plan termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
- 6. Risks and uncertainties**

The Plan provides for investments in various securities that are exposed to both Company specific and general economic risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

7. Tax status

Prior to January 1, 2024, the Internal Revenue Service (“IRS”) has determined and informed the Plan administrator by letter dated October 23, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving that letter. Effective January 1, 2024, the Plan is a pre-approved plan of Transition Finance Strategies LLC, which received an opinion letter on December 29, 2020, in which the IRS stated that the form of the plan document was acceptable under the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
