We have performed audits of the accompanying financial statements of Seabury Hall/College Preparatory School 403(B) DC Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1: DESCRIPTION OF THE PLAN

The following description of Seabury Hall/College Preparatory School 403(B) DC Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Seabury Hall/College Preparatory School (the “Company”, “Employer”, or “Plan Administrator”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Each year, participants may contribute an elected amount of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Each Plan Year, the Employer will make to the Plan a nonelective contribution equal to 7% of the compensation of all Participants eligible to share in allocations. The nonelective contribution is invested as directed by the participant, in the same manner as elected for the participant deferrals. Employees who satisfy eligibility requirements of one year of employment and have attained the age of 21 are eligible for the nonelective contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's nonelective contribution, (b) Plan earnings or losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Employer nonelective contribution plus actual earnings thereon.

Loans to Participants

A participant may initiate a loan with Teachers Insurance and Annuity Association of America (“TIAA”) using their account balance as collateral for the loan and their account is not reduced by the outstanding loan balance. These loan repayments are made directly from the participant to TIAA. Loans transacted directly between the participant and TIAA using the participant's balance as collateral are not considered notes receivable from participants and are not reported on the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, there was \$13,047 and \$26,182, respectively, in such initiated loans.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their nonforfeitable account balance. The loans must be secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan administrator at the date the loan is granted based on the participant investments. Participants may have more than one loan at any time. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants were \$49,374 and \$51,032 as of December 31, 2024 and 2023, respectively.

The Plan follows the Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*. The Plan's management has evaluated and determined no allowance of credit losses is necessary at December 31, 2024 and 2023. Management estimates the allowance balance using relevant available information, from internal and external sources, relating to past events, current conditions, and reasonable and supportable forecasts. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

On termination of service due to retirement, disability, or termination of service due to other reasons, participant benefits shall be distributed either in the form of a single lump-sum amount or an amount consistent with the Specified Payments Option as outlined in the Plan Agreement equal to the value of the participant's vested interest in his or her account. On termination due to death, the beneficiary will receive a benefit equal to 100% of the participant's vested interest in his or her account which is distributed in a single lump-sum payment.

Hardship Withdrawals

Participants qualify to take a hardship withdrawal if a participant has an immediate financial hardship resulting from certain events as identified in the Plan Agreement.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

In preparing these financial statements plan administrators have evaluated events and transactions for potential recognition and disclosure through September 9, 2025, the date the financial statements were available to be issued. There were no recognized subsequent events, events that provide additional evidence about conditions that existed at the Plan's year end, or non-recognized subsequent events, or events that provide evidence about conditions that did not exist at the Plan's year end, which are necessary to be disclosed to keep the financial statements from being misleading.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. Management believes that the estimates utilized in preparing its financial statements are reasonable and prudent.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting using accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the Plan investment in an insurance company investment contract which is reported at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments held at year end. Interest income, dividend income and realized gains are recorded when earned.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Included in administrative expenses are investment management and other fees. Certain administrative expenses and investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ASC topic 820-10-50-1, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The fair value hierarchy consists of three broad levels:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation approaches used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at quoted market prices in an exchange and active market and are classified as Level 1 investments.

Pooled Separate Accounts: are valued at the quoted net asset value ("NAV") of units held by the Plan at year end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the Pooled Separate Accounts less their liabilities. This practical expedient is not used when it is determined to be probable that the Pooled Separate Accounts will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional benefit-responsive investment contract with TIAA. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed each calendar year.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the term of the Plan. Contract value, as reported to the TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023 was \$4,802,070 and \$5,181,623, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include amendments to the Plan documents and premature termination of the contract. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 5: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6: PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of mutual funds and an investment contract managed or offered by TIAA. TIAA is the asset custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additional fees paid to the custodian are netted with investment returns.

Several employees of the Company provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

NOTE 7: CONCENTRATIONS, RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024 and 2023, there were two and three investments, respectively, which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

NOTE 8: INFORMATION CERTIFIED BY ASSET CUSTODIAN

The Plan Administrator has elected the method of annual reporting and compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information provided by Teachers Insurance and Annuity Association of America was certified by them to be accurate and complete with respect to the following:

- a) The investments held by Teachers Insurance and Annuity Association of America as well as the transactions involving these investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024.
- b) The amount of investment income for the year ended December 31, 2024.
- c) The Form 5500 Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 9: TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. There were no uncertain tax positions taken as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
