## **Basis for Opinion**

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF THE PLAN

The following description of the American Psychiatric Association Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

#### General -

The Plan is a defined contribution Plan covering all eligible employees of the American Psychiatric Association (the Association). The Plan was established on February 1, 1985 under Section 401(k) of the Internal Revenue Code (IRC) and most recently amended effective January 1, 2025. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

#### Eligibility -

An employee is eligible to make elective deferrals into the Plan beginning on his or her date of hire. There is no minimum age an employee must attain to become a participant in the Plan for purposes of making elective deferrals.

An employee is eligible to participate in the employer portion of the Plan on the first of the month following the date of hire once he or she has attained age 21 and completed one year of service or 1,000 hours. Effective January 1, 2024, certain leased employees, interns and stipend recipients are excluded from plan participation.

#### Contributions -

Under the terms of the Plan, participants may make voluntary contributions to the Plan up to 50% of their annual compensation, as defined by the Plan, and up to 18% of compensation for participants designated as highly compensated employees. The Plan also includes an auto-enrollment feature with a default contribution rate of 4% and auto-escalation of 1% per year, up to a maximum of 10%.

All contributions are subject to certain IRS limitations. Employees who are 50 and older are eligible to make catch up contributions.

The Association contributes a matching amount equal to 100% of employee contributions, to a maximum of four percent of employee compensation. For the years ended December 31, 2024 and 2023, the Association's matching contributions totaled \$781,027 and \$722,703, respectively. An additional discretionary employer contribution may be made to the Plan limited to three percent of the participant's compensation. For the years ended December 31, 2024 and 2023, the Association's discretionary contributions totaled \$606,295 and \$573,595, respectively.

#### Vesting -

Participants are vested immediately in the full value of their account balance.

### 1. DESCRIPTION OF THE PLAN (Continued)

#### Participant accounts -

Each participant's account is credited with the participant's contributions and the Association's contribution, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specified participant transactions, as defined by the Plan. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's account.

#### Investment elections -

Contributions to the Plan are invested by the Trustee, John Hancock Trust Company LLC, according to participant instructions. The Association provides participants with current copies of the prospectus describing each investment option.

#### Payment of benefits -

Benefits provided by the Plan are paid from net assets available for benefits. The benefit to which a Plan participant is entitled is the benefit that can be provided by the contributions and net earnings thereon allocated to such participant's account. Benefit payments are made in the form of participant directed lump sum, installment, or annuity payments upon separation, retirement, total and permanent disability, or death, as applicable. Benefits are recorded when paid whether directly to or on behalf of a participant.

Participants with account balances less than \$1,000 will receive a lump sum payment in the amount of the participant's vested interest in his or her account.

Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

#### Notes receivable from participants -

Any Plan participant may apply for a loan from the Plan. There is a limitation on the loan amount that will be allowed. Participant loans may not exceed the lesser of 50% of the vested account balance benefit during the prior twelve-month period or \$50,000. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participants account and bear interest at the current prime rate plus 1%. Interest rates range from 4.25% to 9.50% with various maturities through 2034.

#### Plan termination -

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of the Plan termination, assets are to be allocated in a manner consistent with Section 404 of ERISA.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting -

The financial statements are prepared on the accrual basis of accounting and in accordance with FASB ASC 962, *Plan Accounting Defined Contribution Pension Plans*.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Use of estimates -

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Fair value measurement -

The Plan applies the provisions of FASB ASC 820, *Fair Value Measurement*. FASB ASC 820 defines fair value, establishes a framework for measuring fair value, establishes a fair value hierarchy based on the quality of inputs (assumptions that market participants would use in pricing assets and liabilities, including assumptions about risk) used to measure fair value, and enhances disclosure requirements for fair value measurements.

The Plan accounts for a significant portion of its financial instruments at fair value or considers fair value in their measurement.

Valuation of investments -

Investments are stated at their fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion on fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Investments in the fully benefit-responsive guaranteed investment contract are stated at contract value, which is the amount participants would receive if they were to initiate permitted transactions in accordance with the contract.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance, plus accrued interest.

Benefit payments -

Benefits are recorded when paid.

Administrative expenses -

Certain expenses of maintaining the Plan are paid directly by the Association and some are paid by the Plan, which are included in these financial statements. Investment-related expenses are included as a reduction in the net appreciation of fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits. Expenses that are paid by the Association are excluded from these financial statements.

### 3. INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing agreement which obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (the IRS) indicated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC and was qualified and tax-exempt. On January 1, 2025, the Plan adopted its most recent plan amendment. Management of the Plan, in consultation with its legal counsel, believes that the Plan continues to meet the requirements of Section 401 of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 4. INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan's Administrator instructed the Plan's independent auditors not to perform, and they did not perform, such auditing procedures with respect to the information certified by John Hancock Trust Company LLC. John Hancock Trust Company LLC issued Certification Statements, certifying the information presented in the Statements of Net Assets Available for Benefits, Statements of Changes in Net Assets Available for Benefits and Schedule of Assets (Held at End of Year) as of and for the years ended December 31, 2024 and 2023.

### 5. PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by John Hancock Trust Company LLC. John Hancock Trust Company LLC provides recordkeeping, Plan management, and day-to-day support to the Plan; therefore, these transactions qualify as party-in-interest.

### 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### 7. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

During the years ended December 31, 2024 and 2023, the Plan held fully benefit-responsive investment contracts with John Hancock Trust Company LLC which are maintained in a general account. The general account is credited with earnings on underlying investments and charged with participant withdrawal and administrative expenses.

#### 7. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (Continued)

*The John Hancock Guaranteed Interest Account* - is made available to participants through a group annuity contract as an "investment contract". The Guaranteed Interest Account, at all times, is equal to the contributions made to the contract plus interest and dividends credited, minus expenses and withdrawals. John Hancock Trust Company LLC guarantees the return of principal plus accrued interest under the group annuity contract. Interest is accrued daily and credited monthly, and reflects the crediting rate subject to a minimum rate provision, but never below 1% after deduction for any expenses.

Because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The Guaranteed Interest Account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### 8. FAIR VALUE MEASUREMENT

In accordance with FASB ASC 820, *Fair Value Measurement*, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). If the inputs used to measure the financial instruments fall within different levels of hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument.

Investments recorded in the Statements of Net Assets Available for Benefits are categorized based on the inputs to valuation techniques as follows:

**Level 1.** These are investments where values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

**Level 2.** These are investments where values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

**Level 3.** These are investments where inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**8. FAIR VALUE MEASUREMENT (Continued)**

Following is a description of the valuation methodology used for investments measured at fair value.

- *Mutual Funds (Registered Investment Companies)* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.
- *Money Market Funds* - This account consists of money market funds whose fair value is generally \$1 per share.
- *Fully Benefit-Responsive Investment Contract* - The fully benefit-responsive investment contract is reported at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the fully benefit-responsive investment contract represents contributions plus earnings, less participant withdrawals and administrative expenses. In determining the reasonableness of the methodology, a number of factors are considered, such as economic conditions, industry and market developments and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms, while others are substantiated utilizing available market data.

Certain investments that are measured at contract value have not been categorized in the fair value hierarchy; however, the contract value amounts presented in the tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the Statements of Net Assets Available for Benefits.
