We have performed audits of the accompanying financial statements of JCM American Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the JCM American Corporation 401(k) Plan provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

JCM American Corporation (the "Company") entered into the JCM American Corporation 401(k) Plan (a defined contribution plan) (the "Plan") with an effective date of October 1, 1996. JCM Commerce Mechatronics, Inc was entered into the Plan on May 15, 2023. The Plan agreement was written to comply with the requirements of the Employee Retirement Income Security Act of 1974 ("ERISA") and the provisions of the Tax Reform Act of 1986 and have been amended and restated since inception to comply with various changes in legislation and regulation. The administrative committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Eligibility**

All employees with three months of accredited service, who are at least 21 years of age, are eligible for participation in the Plan. Participation may occur on the first day of the quarter following the completion of the eligibility requirements.

**Auto Enrollment**

All eligible employees who were not currently participating in the Plan will be automatically enrolled with a 2% contribution rate. The employee can elect to increase, decrease or opt out of participation at any time. All newly hired employees will also be automatically enrolled at 3% upon their eligibility date. The rate will increase 1% at the beginning of every year for auto enrollments.

**Contributions**

Each year, participants may contribute up to the maximum percentage allowable by law, of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan (rollover). Currently, the Plan offers a number of investment options managed by John Hancock Life Insurance Company. The Company may make matching contributions equal to a discretionary percentage, as determined by the Company, of the participant's elective deferrals. For the year ended December 31, 2024, the Company elected to make matching contributions of \$207,941.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings, and may be charged with an allocation of administrative expenses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

**Forfeited Amounts**

Non-vested Company matching contributions forfeited during the year ended December 31, 2024, totaled \$8,088. This amount was used during the year to make Company matching contributions.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their accounts up to \$50,000 or 50% of their vested account balance, with a minimum loan of \$1,000. Loans to participants are secured by the balance in the participant's account and are charged a reasonable rate of interest, which is comparable to similar types of loans by other lenders as determined by the Plan administrator. Principal and interest is paid ratably through regular payroll deductions. Generally, the term of the loan may not exceed five years.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. In the event of participant default through nonpayment or other means, foreclosure on the promissory note and attachment of security may not occur until an event occurs that would allow or require a distribution of a participant's vested account balance.

**Distribution of Benefits**

Participants or their beneficiaries may begin receiving benefits upon termination of the participant's employment for any reason, including death or disability. Distributions may be made as either a single lump sum or a direct rollover to a qualifying institution. If neither of those options are elected by the participant or their beneficiary, and the account balance is between \$1,000 and \$5,000, the vested account balance will be rolled over to an IRA established by an IRA provider selected by the Company. If the vested account balance is greater than \$5,000, the participant may also request to receive installment payments, a partial withdrawal, or a deferral of payments until age 70½. Under certain circumstances permitted by the Plan, prior to termination, employees may receive hardship or in-service distributions for part or all of their vested account balance.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Valuation of Investments and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the valuation policies utilizing information provided by the investment advisors and the custodian of the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**NOTE 3 – INFORMATION CERTIFIED BY CUSTODIAN (UNAUDITED)**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule that was prepared by John Hancock Life Insurance Company (John Hancock) and furnished to the plan administrator. The plan administrator has obtained certifications from John Hancock that such information is complete and accurate:

- The value of investments as indicated in the statements of net assets available for benefits and notes to financial statements, including notes receivable from participants.
- All information indicated in the statement of changes in net assets available for benefits, with the exception of contributions, benefit payments and administrative fees, if any.
- All information indicated in the supplemental schedule.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

(a) Pooled-separate accounts are measured at fair value using the net asset value (or its equivalent) of the underlying investments and have not been categorized in the fair value hierarchy.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by John Hancock Life Insurance Company (“John Hancock”). John Hancock is the custodian of the Plan assets and, therefore, these transactions qualify as party-in-interest transactions. In addition, John Hancock provides recordkeeping services to the Plan and received fees, which are paid through revenue generated by Plan investments, for those services. These transactions are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan to John Hancock amounted to \$65,862 for the year ended December 31, 2024.

**NOTE 6 – PRIORITIES UPON TERMINATION**

Although the Company has established the Plan with the bona fide intention and expectation that it will be maintained indefinitely, nevertheless, the Company is not under any obligation or liability to continue the Plan for any given length of time. The Company may in its sole discretion discontinue or terminate the Plan in whole or in part in accordance with its provisions at any time without any liability for such discontinuance or termination.

In the event the Plan terminates, no further contributions will be made to the Plan and all amounts credited to the participants’ accounts will continue to be vested in accordance with the Plan document. The Company will direct the distribution of the participants’ accounts in a manner permitted by the Plan as soon as practicable.

**NOTE 7 – TAX STATUS**

The Plan is qualified under the provisions of the Internal Revenue Code (“IRC”) and is not subject to federal and state income taxes.

The Plan is relying on an opinion letter dated March 31, 2014, in which the Internal Revenue Service (“IRS”) states that the Volume Submitter Profit Sharing Plan with CODA, as then designed, was in compliance with the applicable requirements of the IRC. The Plan is currently designed and being operated in compliance with Section 401(a) of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan is no longer subject to potential income tax examinations by tax authorities for years for which the statute of limitations has expired.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9 – SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 4, 2025, which is the date the financial statements were available to be issued. No events were identified that would require disclosure.
