We have performed an audit of the accompanying financial statements of GP Mobile, LLC Retirement Plan, an employee benefits plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024

---

### 1. DESCRIPTION OF THE PLAN

The following description of the GP Mobile, LLC Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, covering all eligible employees of GP Mobile, LLC (the Company). The Company became the employer and sponsor of the Plan as of May 1, 2021. Before that date, the Plan was sponsored by Spark Wireless, LLC and was known as Spark Wireless, LLC 401(k) Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

Employees are eligible to participate in the Plan upon completion of six months of service. Eligible employees may elect to become participants on the first day of the quarter following completion of eligibility requirements.

#### **Contributions and investment options**

The Plan permits eligible employees, through a salary deferral election, to contribute up to 10% of their eligible compensation, as defined by the Plan, provided the contribution does not exceed limits established by law. Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Contributions of distributions to participants from another qualified plan are permitted as defined in the Plan and are reflected as rollover contributions. Company matching contributions are discretionary and are equal to a uniform percentage of the participants' salary deferral. Each year, the Company may make discretionary matching and profit sharing contributions. Participants must be employed on the last day of the plan year and have completed 1,000 hours of service to receive the discretionary matching and profit sharing contributions. For the year ended December 31, 2024 there were no discretionary matching contributions. The Plan offers various mutual funds and a common/collective trust fund as investment options for participants. Each participant has the option of directing their contributions into any of the investment options and may change their investment options daily.

#### **Participant accounts**

Each participant's account is credited with the participant's contributions, the Company's matching contributions, if any, and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested in the Company's matching contributions and earnings thereon after four years of credited service.

#### **Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$- and \$998, respectively. These accounts are used to reduce the Company contributions or to pay plan expenses. For the year ended December 31, 2024, there were no forfeitures used to reduce Company matching contributions.

## 1. DESCRIPTION OF THE PLAN - CONTINUED

### **Payment of benefits**

On termination of service, normal retirement, disability or death, a participant may elect to receive a lump-sum amount or a rollover to another qualified plan equal to the value of the participant's vested interest in the participant's account. Participants are allowed to take hardship withdrawals for medical expenses, purchase of principal residence, education expenses, to prevent foreclosure or eviction, pay for burial or funeral expenses and the repair of their principal residence.

### **Administrative expenses**

Certain administrative expenses, primarily audit fees, are paid by the Company for the Plan and are not reflected in the Plan's financial statements. Other administrative expenses, primarily contract administration and recordkeeping fees, are paid by the Plan and are reflected in the Plan's financial statements.

### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes can be made for a period not exceeding five years; however, in certain circumstances, terms can be extended beyond five years, as defined by the Plan. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Investments valuation and recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See note 3 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### 3. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefit.

The Common/collective trusts are measured using NAV as a practical expedient. In accordance with the guidance in ASU 2015-07 which has been adopted by the Plan, this investment has not been classified in the fair value hierarchy table. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

FASB ASC 820-10, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

#### *Level 1 Fair Value Measurements*

Level 1 inputs are quoted prices in active markets on the actual asset being valued. An active market has sufficient transaction activity to provide pricing information on an ongoing basis.

#### *Level 2 Fair Value Measurements*

Level 2 inputs are those other than quoted prices in Level 1 that are observable and include the following quoted prices on similar assets in active markets; quoted prices for identical or similar assets in markets that are not active; observable inputs other than quoted prices such as yield curves, volatilities, prepayment speeds, or inputs derived principally or corroborated by observable market data by correlation or other means.

#### *Level 3 Fair Value Measurements*

Level 3 inputs are unobservable inputs for the asset reflecting internal assumptions used to arrive at an estimate or exit price. Those inputs are based on the best information available in the circumstances.

#### **4. TAX STATUS**

The prototype plan sponsor has received an opinion letter dated October 6, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The plan administrator timely adopted the restated prototype plan. The plan administrator believes that the plan is currently being operated in accordance with the IRC.

GAAP requires plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **5. INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, ADP, the custodian of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Net appreciation in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### **6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits.

#### **7. PLAN TERMINATION**

The Plan was frozen in 2022. In alignment with that, all contributions were stopped. The Plan has the right to terminate or amend the Plan at any time. No amendment, however, may permit any part of the assets of the Plan, other than those required to pay taxes and administrative expenses, to be used for any purpose other than for the exclusive benefit of the participants.

**8. RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. ADP, Inc. is the recordkeeper and third party administrator of the plan and received direct fees from the Plan totaling \$2,828 for these services. These transactions are exempt from being prohibited transactions by ERISA. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**9. SUBSEQUENT EVENTS**

Management has evaluated subsequent events through July 3, 2025, the date on which the financial statements were available to be issued.
