Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Avineon, Inc. 401(k) and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Note 1 - Description of Plan

The following description of the Avineon, Inc. 401(k) and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document, as amended, for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1995 and was most recently amended on May 2, 2022. The Plan is a defined-contribution plan covering all employees of Avineon, Inc. (the "Employer" or "Company" or "Plan Sponsor") who have attained age 18. The Plan is intended to qualify under section 401(k) of the Internal Revenue Code ("IRC") and is subject to the provisions of ERISA. The Board of Directors is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings, monitors investment performance.

Eligibility

An eligible participant is an employee that is paid, employed and reported on the payroll and personnel records as an employee, who has a minimum age of 18. There are service requirements for employer match that differ from participant elective deferrals.

Participant contributions

Participants may make salary deferral contributions of up to 90% of their compensation each pay period, subject to the limitations of the IRC. Participants may also designate all or a portion of their elections as Roth elective deferrals. Participants are automatically enrolled in the Plan and the Company will automatically deduct 3% of their eligible compensation, as defined in the Plan, unless the participant elects otherwise. In addition, participants 50 years of age or older may elect to make catch-up deferral contributions per the IRC limits. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution. Participants are immediately fully vested in their salary deferral and rollover contributions. Participant contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer contributions

The Company shall make a matching contribution for each participant who has completed six months of service, attained the age 18, and elected to make elective deferral contributions. The matching contribution shall be equal to 50% of the participant's elective deferrals for each payroll period, up to a maximum of 6% of eligible compensation for such period. For the year ended December 31, 2024, the Company made matching contributions of \$148,620, net of forfeitures used to reduce the employer contributions. The Company may also make discretionary profit-sharing contributions to eligible employees who completed at least 1,000 service hours during the Plan year and were actively employed on the last day of the Plan year. The Company did not make any discretionary contributions for the year ended December 31, 2024. Employer contributions are subject to certain IRS limitations. Participants direct the investment of Company contributions.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the balance of Company matching and discretionary profit sharing contributions is based on years of service. A participant is 100% vested in Company matching and profit sharing contributions when the participant becomes eligible for early retirement or reaches the normal retirement age.

Participants vest in Company matching and discretionary profit sharing contributions as follows:

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions.

Investment options

The Plan allows its participants to diversify their holdings. Participants are afforded several investment options covering a wide range of investment objectives and risks and as such, participants may direct the Plan trustee as to the investment of their account balances in accordance with guidelines established by the Plan. The investment options include mutual funds and a common/collective trust. Participants also have the option to allocate up to 70% of their core assets to a self-directed brokerage account to invest in a wider range of options including U.S. equities listed on the New York Stock Exchange ("NYSE") and National Association of Securities Dealers Automated Quotations ("NASDAQ"), corporate and government bonds, and mutual funds. Participants may change their investment elections at any time. Transfers of account balances between elected investment options may also be made at any time.

Participants may allocate their assets among investment alternatives at their discretion.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a 10-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$170,938 and \$5,791, respectively. These accounts will be used to reduce Company matching contributions. Also in 2024, employer contributions were reduced by \$44,353 from forfeited nonvested accounts.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Investment valuation and income recognition

Investments are reported at fair. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Other income

The Plan has a revenue sharing agreement (the "agreement") with ADP Retirement Services ("ADP"), the recordkeeper of the Plan. The agreement establishes an administrative budget through a separate account, which can be used to pay Plan expenses. The administrative budget is credited quarterly with administrative fee payments received or accrued for receipt into the Plan that exceed an established revenue threshold for all investment options other than ADP funds for each calendar quarter. Any amounts credited to the administrative budget and not used in the calendar year shall be allocated as determined by the Plan's fiduciary. For accrued amounts, a true-up calculation is made the following calendar quarter to reflect amounts actually received from investment fund options other than ADP funds. Additional amounts required by the true-up calculation are credited to the Plan's administrative budget, while reductions required are made by reducing the amount of any future payment to the Plan's administrative budget. In the event administrative fee payments do not exceed the revenue threshold for the Plan in a calendar quarter, the negative amount may be carried forward for a maximum of four calendar quarters up to the end of the current calendar year, or to the termination of the agreement, if earlier, at which time the shortfall will be owed to ADP and billed to the Plan Sponsor. For the year ended December 31, 2024, no amounts were credited to the Plan's administrative budget in excess of the revenue threshold.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange

Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Related party transactions and party-in-interest transactions

During 2024, \$1,186 of recordkeeping fees were paid to the Plan's recordkeeper, \$6 of broker fees were paid to the Plan's broker, and \$41,054 of investment advisory fees were paid to the Plan's investment advisor; therefore, these transactions qualify as party-in-interest transactions. These fees are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6 - Tax status

The Plan Sponsor adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan which received a favorable opinion letter from the IRS dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.
