Opinion

NOTE 1 – DESCRIPTION OF PLAN

The following description of Mystic Stamp Company, Inc. Employee Pension Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) deferred savings plan covering all full-time employees of the Company. Effective October 1, 2016, the Plan covers employees who have completed one year of service, including 1,000 hours of service and attained the age of 21. Prior to October 1, 2016, the Plan covered employees who had completed six months of service and attained the age of 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan’s investment offerings and monitors the investment performance.

Contributions

The participants may elect to have their salary reduced by an amount not more than 75% of their compensation for the pay period, and have this deferred amount contributed to their account in the Plan, subject to the maximum allowable contributions under the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants. The employer will provide a 300% match on the participant’s salary reduction contributions of up to 2% of eligible compensation contributed to the Plan. The Company may also, at its discretion, make an additional profit sharing contribution. There were no additional profit sharing contributions during 2024 and 2023.

NOTE 1 – DESCRIPTION OF PLAN – Continued

Participant Accounts

Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as allocations of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their salary reduction contributions, rollovers from other plans and all earnings thereon. Vesting in the employer discretionary and matching amounts are based upon years of continuous service as follows:

Less Than 2 Years	0%
2 Years	20%
3 Years	40%
4 Years	60%
5 Years	80%
6 Years or More	100%

Payment of Benefits

Upon termination of service, the participant will be entitled to the vested balance of his or her account. The participant’s benefit will be paid in a lump sum, installments, or partial withdrawals as soon as administratively possible. In-service distributions are permitted to eligible participants, as defined by the Plan. Hardship withdrawals from the Plan are permitted and subject to certain limitations imposed by the Internal Revenue Service as specified in the Plan Document.

Forfeitures

Upon termination, participants’ non-vested account balances are forfeited. Forfeitures may be used to reduce employer contributions or pay Plan expenses. Forfeitures may be used to reduce employer contributions or pay Plan expenses. For the years ended December 31, 2024 and 2023, employer contributions were reduced by \$-0- and \$1, respectively. No forfeiture balance was used to offset Plan expenses in 2024 or 2023. Forfeited non-vested accounts totaled \$30 and \$22 for the years ended December 31, 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Recordkeeping and investment advisory fees may be paid from Plan assets. Certain other administrative expenses are paid directly by the Plan sponsor. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through September 10, 2025, which is the date the financial statements were available to be issued.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST
TRANSACTIONS**

Reliance Trust Company is the trustee of the Plan’s assets. As such, transactions between Reliance Trust Company and the Plan qualify as party-in-interest transactions. As described in Note 2, the Company or the Plan paid certain expenses related to Plan operation and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA and are exempt from prohibited transaction rules.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in the value of their account balances.

NOTE 7 – TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company, through a prototype plan letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable requirements of the Internal Revenue Code (IRC). Therefore, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risk includes global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
