Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the House Works LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the plan document.

General

HouseWorks, LLC, established the Plan effective October 1, 1998. HouseWorks, LLC is wholly owned by HouseWorks Holdings, LLC, which owns four affiliated entities: Caring Friends Home Care (HW), LLC, Extended Family (HW), LLC, EC Acquisition Co and Associated Home Care (collectively with HouseWorks, LLC, the “Company” or the “Employer”). Each of the affiliated entities are participating employers in the Plan. During 2024, the Plan was amended to add Care & Help Home Care, LLC, Companions and Homemakers LLC and Companions Forever LLC (related through common ownership with HouseWorks, LLC) as participating employers to the Plan. The Plan is a defined contribution plan covering substantially all employees of the Employer, except for nonresident aliens, leased employees, and residents of Puerto Rico (the “Participants”). No age and service are required. Upon meeting eligibility requirements, the employee’s entry date is the following first day of the month.

Reliance Trust Company (the “Trustee”) serves as the trustee for the Plan, while recordkeeping and administrative services are provided by Automatic Data Processing Retirement Services (“ADP”). The Plan is subject to the provisions of the Internal Revenue Code (the “IRC”) and the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are participant-directed.

Plan Merger

Effective May 24, 2024 the directors of the Employer elected to amend the Plan and merge AccordCare 401(k) Retirement Plan, another defined contribution plan, into this Plan. All participants with an account balance remaining in the AccordCare 401(k) Retirement Plan at the time of the merger were transferred into the Plan. In total \$2,240,938 in assets were transferred into the Plan.

Plan Administration

The Employer is the plan sponsor and named plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual participant accounts may be charged with an allocation of administrative expenses, if not paid by the Employer.

Participant Deferral Contributions

Participants may elect to make pre-tax or Roth deferrals up to 90% of their eligible compensation subject to a dollar limit established by the Internal Revenue Code (IRC). Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, Participants may also rollover amounts representing distributions from other qualified plans (“Participant Rollovers”).

1. Description of the Plan (*continued*)

Employer Contributions

The Plan made qualified non-elective employer contributions in the amount of \$8,556 and \$12,928 during 2024 and 2023. The Plan does not allow for other Employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the Participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest is repaid through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may not exceed 30 years. No more than one outstanding loan may be taken by a Participant at any time. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. If a Participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the Participant's loan balance is reduced, and a benefit payment is made upon the occurrence of a distributable event. Interest rates for outstanding loans ranged from 5.25% to 10.50% at December 31, 2024 and 2023 and mature at various dates through August 2034.

Payment of Benefits

Upon termination of service due to death, disability, termination or retirement, a Participant may elect to receive either a lump-sum distribution in an amount equal to the value of the Participant's interest in his or her account or installment payments over a certain period, or a partial withdrawal of the participant's account. Upon termination, if a Participant's account balance is less than \$1,000, the plan administrator, after notification, may distribute to the Participant his or her entire account balance. If a balance is less than \$5,000 but greater than \$1,000, the plan administrator, after notification, may deposit the balance into an IRA.

Payment of Benefits (continued)

In service withdrawals from a Participant's account balance are permitted upon reaching age 59 ½. In service withdrawals are also permitted due to financial hardship, as defined. Hardship withdrawals are subject to a \$500 minimum.

Expense Account

The Company has a revenue sharing arrangement with ADP that provides for an expense reimbursement to the Plan. These reimbursements are held in an ERISA expense account and are utilized to pay for certain Plan administrative expenses. During the year ended December 31, 2024, the Plan received \$19,845 of expense reimbursements, and the Plan utilized \$19,845 to pay Plan administrative expenses. There were no unallocated amounts in the ERISA expense account at December 31, 2024 and 2023.

Expenses

Certain expenses for maintaining the Plan are paid by the Employers and are excluded from these financial statements. Administrative fees for transaction charges are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Fair Value Measurements (continued)

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value (“NAV”) per share as a practical expedient is not categorized within the fair value hierarchy.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified as Level 1 within the fair value hierarchy.

Common collective trusts: Valued at the NAV of units in collective trust funds. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The common collective trust has no unfunded commitments as of December 31, 2024 and 2023. Each of these common collective trust funds files a Form 5500 as a direct filing entity. As such, significant investment strategies have not been disclosed for these investments.

Investments, Investment Valuation, and Income Recognition

Investments in mutual funds and common collective trusts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Interest income is reported on the accrual basis. Dividends are recorded on the ex-dividend date.

Unit Values

Individual Participant accounts for the common collective trusts are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units which are valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants’ accounts are charged or credited with the number of units properly attributable to each Participant.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative fees and expensed when incurred.

Benefits Paid

Benefit payments to Participants are recorded during the period in which they are paid.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date the financial statements were available to be issued, which date is September 12, 2025.

Effective January 1, 2025, the Plan was amended to add Bold Vision Career of Queens LLC, Bridge City Home Care, LLC, Elite Choice, Elite HHC and Hub at Elite as participating employers.

Also effective January 1, 2025, the Plan was amended to revise the definition of eligible employees. Specifically, union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining are now classified as an ineligible class of employees, unless the collective bargaining agreement specifically requires their inclusion in the Plan.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4(i) – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

4. Risks and Uncertainties

The Plan invests in investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. Tax Status

The Plan is a prototype 401(k) plan, qualified under Section 401(a) of the IRC. The Plan obtained its latest opinion letter on October 6, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed in compliance with the applicable requirements of the IRC and the Plan is qualified and the related trust is tax-exempt as of the date of this report.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of an entity is considered a tax position. No such uncertain tax positions have been recognized by the Plan.

6. Party-In-Interest Transactions

The Plan paid administrative expenses totaling \$13,150 to the Trustee and ADP for the year ended December 31, 2024, which qualifies as party in interest transactions. Notes receivable from participants qualify as exempt party-in-interest transactions as defined by ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan shall be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

8. Excess Contribution Liability

The Plan is subject to certain limitations on contributions under the Internal Revenue Code (IRC), including the actual deferral percentage (ADP) and actual contribution percentage (ACP) nondiscrimination tests. For the plan year ended December 31, 2024, certain participants' contributions exceeded these limitations. As a result, the Plan has recorded an excess contribution liability of \$103,078 as of year-end.

This liability represents amounts refundable to participants and/or amounts payable to the employer, as applicable, to comply with the IRC requirements. The refunds are expected to be made within the time frame prescribed by the IRC (generally by March 15 of the following year). The liability is reflected in the accompanying financial statements as Excess contribution liability.

9. Delinquent Participant Contributions

During 2024, \$25,262 of Participant contributions and loan repayments were not remitted to the Plan by the Employer on a timely basis as required under DOL 2510.3-102. Under ERISA, such delinquent contributions are considered prohibited transactions and are reported on Schedule H, Part IV, Line 4(a) of Form 5500. The Company funded the lost earnings on the delinquent contributions to the affected Participants' accounts in 2025.
