We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus.

We noted no significant transactions that have been recognized in the financial statements in a different period than when the transaction occurred.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was the Plan's valuation of investments.

Management has informed us that, in determining the appropriateness of the estimate of investment values, they have recorded the fair values based on market values provided by the investment custodian, plus any applicable valuation adjustments. We performed no specific procedures related to the valuation of the investments due to the scope and nature of an ERISA Section 103(a)(3)(C) audit.

The disclosures in the financial statements are neutral, consistent, and clear.

However, these discussions occurred in the normal course of our professional relationship, and our responses were not a condition of our retention.

We have requested certain representations from management that are included in the management representation letter dated September 9, 2025.

Our responsibility for Form 5500 does not extend beyond the financial statements, and we do not express an opinion or any form of assurance on Form 5500. However, we read the Plan's Form 5500 filing, and nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information or manner of its presentation appearing in the financial statements.



Note 1 - Plan Description

The following description of Joseph's Gourmet Pasta Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Joseph's Gourmet Pasta Company (the "Company"). Effective November 1, 2024, participants are automatically enrolled with a pretax salary deferral of 5 percent of eligible compensation upon hire date unless instructed otherwise. Prior to November 1, 2024, participants were automatically enrolled with a pretax salary deferral of 2 percent of eligible compensation upon hire date unless instructed otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee pretax salary deferral and Roth contributions up to a maximum of 100 percent of annual compensation subject to maximum limitations established by the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for an employer discretionary matching contribution on elective deferrals up to a percentage of pay chosen by the Company. Participants are eligible for the employer discretionary matching contribution upon 90 days of service. For the year ended December 31, 2024, the Company elected to make a matching contribution of 100 percent of the first 3 percent of eligible compensation that a participant contributed to the Plan and 50 percent of the next 2 percent of eligible compensation that a participant contributed to the Plan, with a maximum matching contribution of 4 percent.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings (or losses) and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee contributions, rollover contributions, and any income or loss thereon. Vesting in the Company's discretionary matching contributions, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company beginning at 25 percent after two years of continuous service, increasing by 25 percent for each year of continuous service thereafter. A participant is fully vested after five years of service.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their vested account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. The notes receivable must be repaid within five years unless the purpose is for a primary residence. Principal and interest are paid ratably through regular payroll deductions.

Note 1 - Plan Description (Continued)

Benefit Payments

Upon retirement, death, disability, or termination of employment, distributions are payable in the form of a lump-sum amount equal to the vested balance of a participant's account or installment payments. In-service withdrawals are also permitted for participants over the age of 59½, as well as from rollover funds at any time.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are first used to reduce future company contributions or to pay administrative expenses of the Plan. If any forfeitures still remain, such forfeitures will be reallocated to other participants. Forfeitures from other participants may increase the participant's account from the Company's additional contributions. During 2024, there was approximately \$54,000 of forfeitures used to pay plan expenses and reduce employer contributions. There was no significant forfeiture balance as of December 31, 2024 and 2023.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Principal Global Investors Trust Company (Principal Global) and Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust) or their affiliates. Principal Global and Principal Trust are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

Investments held by the Plan are stated at fair value.

The common collective trust fund is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability, with a corresponding reduction to contributions. As of December 31, 2024 and 2023, the Plan recorded a liability of \$49,227 and \$36,010, respectively. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants in 2025 and 2024, respectively.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company. During 2024, the Company paid approximately \$21,000 of administrative costs on behalf of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 9, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Principal Global and Principal Trust hold the Plan's investments and execute all related transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal Trust and Principal Life Insurance Company on behalf of Principal Global. Additionally, as of and for the year ended December 31, 2024, Principal Trust held participant notes receivable and executed related transactions. Related participant notes receivable balances and interest income as of and for the year ended December 31, 2024 were certified by Principal Trust.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
