## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the AESSEAL, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 - PLAN DESCRIPTION

The following brief description of the AESSEAL, Inc. 401(k) Retirement Plan (the Plan) is provided for general information only. Participants should refer to the Plan agreement for more complete information.

**General** - The Plan is a defined contribution plan established by AESSEAL, Inc. (the Company) to provide retirement benefits to officers and employees of the Company who have a minimum of one hour of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Contributions** - The Plan is funded by both participant and employer contributions. Participants are permitted to make elective deferrals up to 75% of eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The employer makes matching contributions at a discretionary percentage of the participants' compensation for the Plan year. The contributions are accounted for separately as to participant and employer contributions. At the discretion of the board of directors, the employer may annually make additional profit-sharing contributions. There were no profit-sharing contributions for 2024.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of any Company profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit which can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions and employer matching contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's accounts and bear interest at rates equal to the prime rate plus 1% per year. A maximum of one loan may be outstanding at any time. Principal and interest is paid ratably through payroll deductions from each regular paycheck.

**Payment of Benefits** - On termination of service due to retirement, death, or disability, a participant (or participant's beneficiary in the event of death) may receive the vested portion of the participant's account. A participant who has attained the Plan's normal retirement age and who has not separated from service may also request distribution of his or her vested account balance. In addition, hardship distributions are permitted if certain criteria are met. Distributions are made in the form of lump sum payments or installment payments.

**Forfeited Accounts** - At December 31, 2024 and 2023, there were no forfeited nonvested accounts. Forfeited accounts will be used to restore forfeitures or reduce Company contributions, or to pay reasonable Plan expenses. In the event that forfeitures exceed administrative expenses, they will be applied to offset the employer's contribution.

See Independent Auditor's Report.

## NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are stated at their estimated fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 3.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Delinquent receivables are recorded as distributions on the basis of the terms of the Plan agreement. Notes receivable from participants are considered to be party-in-interest transactions for which a statutory exemption from the prohibited transaction regulation exists.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/ depreciation of fair value of investments.

**Subsequent Events** - The Plan Administrator has evaluated subsequent events through August 20, 2025, which is the date the financial statements were available to be issued, and had determined that there are no subsequent events that require disclosure.

## NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets in active markets;
  - Quoted prices for identical or similar assets in inactive markets;
  - Inputs other than quoted prices that are observable for the asset;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)**

- If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* The Plan is invested in a stable value fund, Invesco Stable Value Trust (Federated Capital Preservation Fund in 2023) (the “Fund”). The Fund is a collective trust valued at the NAV of the units owned, and the NAV is used as a practical expedient to estimate fair value. This NAV represents the Plan’s fair value since this is the amount at which the Plan transacts with the fund. The Fund is a stable value fund, which seeks to provide investors stable principal and high current income and invests in guaranteed investment contracts (“GICs”), separate account guaranteed investment contracts (“SGICs”), synthetic guaranteed investment contracts (“SICs”), money market mutual funds, and other stable value products.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, plan participants would become 100% vested in their accounts.

**NOTE 6 - TAX STATUS**

The Plan Sponsor adopted a non-standardized pre-approved plan sponsored by The Trust Company of Tennessee. The Internal Revenue Service (IRS) had determined and informed the Plan's third-party administrator by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and third-party administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

As of December 31, 2024 and 2023, outstanding notes receivable from participants were \$210,704 and \$168,182, respectively, which qualify as party-in-interest transactions.

During 2024, the Plan paid \$58,078 in administrative fees to The Trust Company of Tennessee, the investment custodian, recordkeeper and third-party administrator, which qualify as party-in-interest transactions.

The Plan Sponsor provides the Plan with certain accounting, auditing and administrative services for which no fees are charged to the Plan.
