Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 And 2023

1. Description Of The Plan

The following description of the Tighe Warehousing & Distribution, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

Organization

Effective January 1, 1992, Tighe Warehousing & Distribution, Inc. established a defined contribution profit sharing plan under the provisions of Internal Revenue Code (the Code) Section 401(k). The Plan was restated effective January 1, 2007 when its investment and administrative functions were taken over by Ascensus LLC (Ascensus). The Plan was most recently restated on May 1, 2021 and amended on January 1, 2022. The participant-directed plan is for a controlled group of corporations which comprise Tighe Warehousing & Distribution, Inc. and Tighe Trucking, Inc. (collectively, the Employer or the Company); these companies share common ownership, operations and management.

General

The Plan is a defined contribution plan covering all eligible full-time employees of the Company, as defined. Participants are eligible to enter the Plan immediately upon attainment of age 18. Ascensus provides recordkeeping for the Plan, and also serves as agent for Ascensus Trust Company, the Trustee for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). All investments are participant-directed.

Participant Contributions

Participants may defer up to 100% of their eligible compensation, as defined by the Plan, up to a dollar limit established under Internal Revenue Service (IRS) guidelines. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and individual retirement accounts (rollover).

Employer Profit Sharing Contributions

The Employer, at its discretion, may make profit sharing contributions to the Plan as determined by its Board of Directors. Profit sharing contributions are allocated based on the ratio of a participant's eligible compensation to the total compensation paid to all participants in the Plan year. To be eligible for profit sharing contributions, a participant must have completed a year of eligibility service and be employed by the Company as of the last day of the Plan year. For the years ended December 31, 2024 or 2023, no discretionary profit sharing contributions were made.

Employer Matching Contributions

The Employer, at its discretion, may elect to make a matching contribution. Participants are eligible to receive an Employer matching contributions after completing six consecutive months of eligibility service. For the years ended December 31, 2024 or 2023, no matching contributions were made.

Employer Safe Harbor Matching Contributions

The Employer safe harbor matching contribution is equal to 100% of employee deferrals up to 3%, and 50% of employee deferrals in excess of 3% up to 5%. Participants are eligible for Employer safe harbor matching contributions immediately upon attainment of age 18. For the years ended December 31, 2024 and 2023, the Company made Employer safe harbor matching contributions totaling \$180,030 and \$174,552, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, the respective Employer contributions and an allocation of the Plan's net change in fair value of investments and is charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their respective deferral, Employer safe harbor and rollover contributions, plus allocated earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions is based on years of service. The Plan provides vesting in the Company's discretionary matching and profit sharing contributions of 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service and 100% after six years of service. Upon death, disability, or attainment of normal retirement age, a participant is fully vested in all of their accounts.

Forfeitures

At the Company's discretion, forfeited nonvested account balances may be used to reduce future Employer contributions or offset Plan expenses. Forfeitures, which were utilized to reduce Plan expenses for the years, ended December 31, 2024 and 2023 were \$4,184 and \$5,300, respectively. At December 31, 2024, available forfeited nonvested balances totaled \$2,981. At December 31, 2023, there were no available forfeited nonvested balance.

Notes Receivable From Participants

Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have two loans outstanding at a time. Loan terms may be for up to five years (or up to twenty-five years for the purchase of a primary residence). The loans are secured by the vested balance in the participant's account and bear interest at a fixed rate as determined by the Plan Administrator at the time the loan is made. Principal and interest are paid ratably through payroll deductions. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant's loan balance is reduced and a benefit payment is made in accordance with the Plan Agreement.

Payment Of Benefits

Upon termination of service due to death, disability, voluntary termination, or retirement, a participant or beneficiary may elect to receive a lump-sum distribution, partial distribution, or installment payments in an amount equal to the value of the participant's vested interest in his or her account. The payment can either be a cash distribution to the participant or a tax-free rollover to an individual retirement account or another qualified plan. If a participant's vested account is more than \$1,000 but less than \$5,000, the Plan Administrator, after notification, may distribute the account balance into an individual retirement account. If the vested account balance is less than \$1,000, the Plan Administrator, after notification, may distribute the account balance to the participant.

In service withdrawals from a participant's vested account balance are permitted upon reaching age 59½. In service withdrawals are also permitted due to financial hardship, as defined in the Plan Agreement. Hardship withdrawals may be taken from the participant's deferral contributions, vested Employer profit sharing contributions, vested Employer matching contributions or rollover account, without respect to earnings.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use Of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan Agreement. No allowance has been recorded as of December 31, 2024 or 2023.

Payment Of Benefits

Benefits are recorded in the period in which the participants are paid.

Administrative Expenses

Expenses incurred in the administration of the Plan are paid by the Company unless the Company directs that such expenses shall be paid by the Plan. Participant loan set-up and maintenance fees are paid directly by the participants through a reduction in their account. Other fees such as investment advisory and management fees and recordkeeping fees are paid by the Plan through a shared reduction to individual participant accounts.

Subsequent Events

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report

3. Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus as the agent of Ascensus Trust Company and Newport Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023;
- Investment information included on the supplemental schedule of assets held at end of year as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental information.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Common/Collective Trust

Valued at the net asset value (NAV) of units of the individual fund. The NAV, as provided by the trustee of the invested fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The common/collective trust held by the Plan is redeemable daily, and files an annual report on Form 5500 as a direct filing entity. There were no unfunded commitments at December 31, 2024 or 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

5. Risks And Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination, Participants will become fully vested in their accounts.

7. Party In Interest Transactions

Certain employees have outstanding loans with the Plan. These loans are considered exempt party in interest transactions as defined by ERISA.

8. Income Tax Status

The Plan adopted a pre-approved plan document, which received an opinion letter from the IRS dated June 30, 2020, stating that the pre-approved plan document was designed in accordance with the applicable sections of the Code. The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving this letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and that the related trust is exempt from taxation.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
