Opinion on the 2024 Financial Statements

We have audited the accompanying financial statements of Oneta Company Employee Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of November 30, 2024, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Oneta Company Employee Health & Welfare Plan as of November 30, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Oneta Company Employee Health & Welfare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. NOTES TO FINANCIAL STATEMENTS

NOVEMBER 30, 2024 AND 2023

Note 1 – DESCRIPTION OF PLAN

The following description of the Oneta Company Employee Health & Welfare Plan (the Plan) provides only general information about the Plan’s provisions. Participants should refer to the plan agreement for a complete description of the Plan’s provisions, copies of which may be obtained from the plan sponsor.

General

The Plan provides health benefits to eligible employees of Oneta Company (the Company) who have completed 60 days of service, and covered dependents. The Plan is subject to the provisions of the Employee Retirement Income and Security Act of 1974 (ERISA).

Benefits

The Plan provides health benefits (medical, dental, and prescription drugs), life insurance, and accidental death and dismemberment benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent) and the accidental death and dismemberment benefits (basic, supplemental, and spousal). The Company purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance and basic accidental death and dismemberment insurance programs are paid to the insurance company from the general assets of the Company. Premiums for all other insured benefits are paid from the assets of the Plan.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The stop-loss insurance arrangement applies to individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims.

Self-insured Benefits

All plan benefits other than those described in the “Insured Benefits” section above are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processor. The claims processor pays claims directly on behalf of participants and are then reimbursed by the Plan’s trust. Despite the Plan’s utilization of a third-party claims processor, ultimate responsibility for payments to providers is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.

Note 1 – DESCRIPTION OF PLAN – (Continuation)

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs based on the current group rate premium cost. The Company pays the full cost of basic life insurance, basic accidental death and dismemberment insurance, and stop-loss insurance.

Note 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by either the Company or the plan trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to the claim processor that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statements of net assets available for benefits.

Stop-Loss

Premiums for stop-loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. In 2023, stop-loss refunds totaling \$4,050 were netted with claims paid in the accompanying statement of changes. No stop-loss refunds were received in 2024.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a claim fund request, with the offset being netted against claims paid. Pharmacy rebates totaling \$21,520 and \$22,604 for 2024 and 2023, respectively, have been netted with claims paid on the accompanying statement of changes in net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events for the Plan through the date of the independent auditor's report. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

Note 3 – CONTRIBUTIONS

The Company contributes amounts monthly for their employees who are members of the Plan at a rate which is sufficient to pay reported claims and other expenses when due. Employees may contribute specified amounts determined by coverage elections.

As provided under the Consolidated Omnibus Budget Reconciliation Act (COBRA), terminated employees and their dependents may choose to continue to contribute specified amounts and file claims under the Plan for a limited time.

Note 4 – ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claims administrator. These expenses are reported on the statement of changes in net assets available for benefits as administrative fees and expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Note 5 – CLAIMS INCURRED BUT NOT REPORTED

Benefit obligations payable is the approximate outstanding claims liability at the end of the year. Claims incurred but not reported (IBNR) is calculated by determining the average monthly claims expense and applying a claims lag schedule based on the prior two years' experience of the Plan with a 13% increase in the claims trend. Such estimates may be more or less than the amounts ultimately paid when the claims are settled. IBNR at November 30, 2024 and 2023 was \$117,361 and \$105,766, respectively. These claims were paid in the subsequent periods.

Note 6 – TAX STATUS

The Plan has established a taxable trust (the Trust) to hold the Plan's net assets. This may require filing a Form 1041, U.S. Income Tax Return for Estates and Trusts. However, returns are not anticipated since taxable income is below the filing limit due to the nature of the Trust's operations.

Note 7 – TERMINATION OF THE PLAN

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, reasonable notice of discontinuance shall be given to all participating employees as to the date that such benefits and contributions shall cease. The remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on behalf of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 8 – CONCENTRATION

At November 30, 2024 and 2023, the Plan maintained a cash balance with Frost Bank that exceeded FDIC insured limits by \$523,744 and \$397,524, respectively. Management believes that the Plan is not exposed to any significant risk related to these accounts.
