## INDEPENDENT AUDITORS' REPORT

To the Participants and Pension Committee  
Central Investment LLC Thrift Savings 401k Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

**Basis for Opinion**

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Central Investment LLC Thrift Savings 401k Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matters - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment

information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTES TO FINANCIAL STATEMENTS**

December 31, 2024

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Central Investment LLC Thrift Savings 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement and the Summary Plan Description for a more complete description of the Plan's provisions.

**GENERAL-**

Empower Trust Company, LLC and its affiliate, Empower Retirement, LLC provide recordkeeping and custody services for the Plan's assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is a defined contribution plan covering eligible employees of Central Investment LLC and subsidiary companies (the "Company") who have attained the age of twenty-one and earned credit for six months of service.

**CONTRIBUTIONS-**

Generally, each year active participants may contribute up to one hundred percent (100%) of pretax annual compensation (or the maximum amount prescribed by law, whichever is less), as defined in the Plan. The Company may make contributions to the Plan subject to limitations imposed by law ("Employer Contributions"). For 2024, the Company made safe harbor matching contributions equal to one-hundred percent (100%) of the amount of a participant's elective contributions that do not exceed one percent (1%) of the participant's annual compensation and fifty percent (50%) of the participant's elective contributions that exceed one percent (1%) but do not exceed six percent (6%) of the participant's annual compensation.

All newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled employees have their deferral rate set at six percent (6%) of eligible compensation.

Contributions for automatically enrolled participants are invested in a default asset allocation until changed by the participant.

**PARTICIPANT ACCOUNTS-**

Each participant's account is adjusted by (a) the participant's contribution, (b) allocations of any Employer Contributions, and (c) allocations of the Plan's earnings or losses (including any administrative expenses paid by the Plan). Allocations are based on participant earnings or account balances in accordance with the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants have the ability to direct the investment of their contributions into the various investment options offered by the Plan.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

VESTING-

Participants are immediately vested in their contributions plus allocated earnings or losses less allocated expenses. Vesting in the Employer Contributions to a participant's account is based on years of continuous, credited service. Generally, a participant becomes one-hundred percent (100%) vested in Employer Contributions upon completion of three years of credited service. During the period prior to completion of the required credited service, a participant is zero percent (0%) vested in the amounts attributable to Employer Contributions. Participants become one-hundred percent (100%) vested in safe harbor matching qualified contributions upon completion of two years of credited service.

NOTES RECEIVABLE FROM PARTICIPANTS-

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% over the prime rate published in the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid ratably through payroll deductions.

FORFEITED ACCOUNTS -

Forfeitures are used to reduce future Employer Contributions. There were \$6,141 and \$15,630 of unallocated nonvested amounts at December 31, 2024 and 2023, respectively. Forfeitures in the amount of \$33,777 were used to reduce Employer Contributions in 2024.

PAYMENT OF BENEFITS-

Upon reaching age 65, termination of employment, death, total and permanent disability, or termination of the Plan, the participant's account may be distributed under several options. If the participant's vested interest is greater than \$5,000, the participant may choose to have the distribution delayed (in accordance with the participant's election) until the participant reaches retirement age. If delayed, the participant's account will continue to be credited with earnings or losses until a distribution is made. If the vested interest is less than \$5,000 but greater than \$1,000, the participant may elect to have the distribution paid directly to an eligible retirement plan or receive the distribution directly in the form of cash. Should such an election not be made by the participant, the distribution will be in the form of a direct rollover to an individual retirement plan designated by the plan administrator. If the vested interest is \$1,000 or less, the payment will be in the form of a lump sum payment, payable at termination.

In conditions of financial hardship, as defined by the Plan and applicable regulations, a participant may apply to the plan administrator for approval to withdraw that portion of their 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code ("IRC").

PLAN TERMINATION-

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

The financial statements of the Plan have been prepared in conformity with U.S. generally accepted accounting principles as applied to savings and retirement plans, and in accordance with the terms of the Plan agreement. A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

**BASIS OF ACCOUNTING-**

The financial statements are prepared using the accrual method of accounting.

**USE OF ESTIMATES-**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION-**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTES RECEIVABLE FROM PARTICIPANTS-**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged against the borrower's loan proceeds. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**PAYMENT OF BENEFITS-**

Benefits are recorded when paid.

**ADMINISTRATIVE EXPENSES-**

Substantially all of the Plan's administrative expenses are paid by the Company.

**SUBSEQUENT EVENTS-**

The Plan's administrator has evaluated the impact of events that have occurred subsequent to December 31, 2024 through September 4, 2025, the date the financial statements were available to be issued, for purposes of recognition and disclosure in the financial statements.

NOTE 3 - INCOME TAX STATUS

The Company adopted a volume submitter defined contribution plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (“IRS”) dated November 14, 2022. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, the custodian, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024, and to the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the plan's operations.
