Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hodges University Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 3, 2025 (in liquidation) and June 30, 2024 (ongoing), and the related statement of changes in net assets available for benefits for the period ended April 3, 2025 (in liquidation), and the year ended June 30, 2024 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hodges University Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 3, 2025 and June 30, 2024 and for the period ended April 3, 2025, and the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hodges University Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter

As discussed in Note 2 and Note 5 to the financial statements, the Board of Trustees approved in December 2024 to terminate the Plan effective June 30, 2024, and management determined liquidation is imminent. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2024 financial statements to the liquidation basis used in presenting the 2025 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Hodges University Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Hodges University (the University) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally adopted by the University effective January 1, 1997. The Plan has been amended throughout the years to comply with tax legislation and most recently restated effective July 1, 2022. The Plan is subject to ERISA as amended. The trustees are responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Effective June 30, 2024, the Board of Trustees of Hodges University, the Plan Sponsor, terminated the Plan as described in Note 5.

Eligibility

Prior to termination of the Plan, all nonexcluded full-time employees were eligible for the Plan after the completion of six months of service with at least 120 hours of service in each month. Excluded employees were those that were benefit ineligible staff, college work-study staff, adjunct professors, and English as a second language staff. For the year ended June 30, 2024, employees must have been employed as of March 31, 2024, and completed 1,000 hours in order to be eligible to receive the discretionary University contribution.

Contributions

Prior to termination of the Plan, the Plan included a discretionary University contribution, which was a percentage of the employee's compensation. For the year ended April 03, 2025, no discretionary contribution was provided as the Plan was terminated effective June 30, 2024. For the year ended June 30, 2024, a discretionary contribution of 15% calculated on annualized compensation was given for a total of \$406,881.

Prior to termination of the Plan, participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Prior to termination of the Plan, each participant's account was credited with the University's contribution and an allocation of Plan earnings or losses. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings or account balances, or participant transactions, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that could be provided by the participant's vested account.

Vesting

Prior to termination of the Plan, participants were immediately vested in their rollover contributions plus actual earnings thereon. Vesting in the University's contribution portion of their accounts, plus actual earnings thereon, was based on years of credited service. A participant was vested in accordance with a graduated schedule at 20% a year of credited service starting in the second year of credited service and is 100% vested after six years of credited service. On March 1, 2024, the Board of Trustees approved to fully vest active employees in anticipation of the plan termination.

Notes Receivable from Participants

Prior to termination of the Plan, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at the prime rate plus 1%. Principal and interest was paid ratably through payroll deductions.

Benefit Payments

Prior to termination of the Plan, upon termination of service, death, disability, or retirement, a participant could elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution, partial distributions, or installments. The Plan allowed for in-service distributions if a participant reached age 59½. If a participant terminated employment and the participant's account balance did not exceed \$1,000, the Plan administrator would authorize the benefit payment directly to the participant without the participant's consent. If the balance of the terminated participant's account was between \$1,000 and \$7,000, the Plan Sponsor could authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeited Accounts

Prior to termination of the Plan, forfeited nonvested accounts were used to reduce future University contributions or pay Plan expenses. Forfeited nonvested accounts as of April 3, 2025 and June 30, 2024, totaled \$-0- and \$29,670, respectively. There were no forfeitures used to fund the University contributions for the period ended April 3, 2025, or for the year ended June 30, 2024. There was \$29,670 and \$3,290 of forfeitures used to pay Plan expenses for the period ended April 3, 2025 and year ended June 30, 2024, respectively.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

In December 2024, the Board of Trustees authorized to terminate the Plan effective June 30, 2024, and management determined liquidation is imminent in 2025. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2024 financial statements to the liquidation basis used in presenting the 2025 financial statements.

Under the liquidation basis of accounting, assets are stated at their estimated cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities are stated at their anticipated settlement amounts. There were no assets or liabilities as of April 3, 2025, as the plan of liquidation was completed.

Use of Estimates

The Plan Administrator uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and reported revenues and expenses. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance companies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 03, 2025 and June 30, 2024. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the University and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Teachers Insurance and Annuity Association (TIAA) and College Retirement and Equities Fund (CREF), Newport Trust Company, LLC, and Ascensus LLC as agent for Ascensus Trust Company, the qualified institutions, have supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of April 5, 2025 and June 30, 2024, the statements of changes in net assets available for benefits for the period ended April 5, 2025, and for the year ended June 30, 2024.

The Plan changed qualified institutions from Newport Trust Company, LLC to Ascensus Trust Company effective April 18, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at April 03, 2025 and June 30, 2024.

Insurance Company General Account: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. In determining the reasonableness of the methodology, the investment advisor evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract items (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

Money Market Funds: Valued based on cost, which approximates fair value in a noninflationary economy.

Pooled Separate Account: Valued based on the net asset value (NAV) of units, which are based on market prices of the underlying investments held by the Plan at year-end.

Interest in Sub-Accounts of Variable Annuity Contracts: Valued at the NAV by CREF at accumulation unit value based on the estimated value of the underlying investments held by the Plan at year-end. CREF Money Market Account holdings are generally valued at amortized cost which approximates fair value.

Publicly Traded Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price.

NOTE 5 PLAN TERMINATION

In December 2024, the Board of Trustees approved the termination of the Plan effective June 30, 2024. As a result of the termination, active participants became 100% vested in their Company contributions. The Plan's termination also ceased new participant notes receivable from the Plan. The participants were provided the option to receive a lump-sum distribution or rollover their funds into an IRA or another plan. All Plan assets were distributed as of April 3, 2025.

NOTE 6 INVESTMENT CONTRACTS WITH INSURANCE COMPANY

Some participants maintain an individual annuity contract with TIAA. As part of the contracts, TIAA may maintain a portion of the contributions in a "guaranteed account," which is called the Traditional Fixed Account. These accounts are credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by TIAA. The guaranteed account is included in the financial statements at fair value (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses), because it is nonfully benefit responsive. The Traditional Fixed Accounts are subject to a 10-year withdrawal period under certain individual annuity contracts. Upon termination of the contract, the recurring annuity payment amount will be determined by the amount of the Traditional Fixed Accounts accumulation and the interest rates in the rate schedules under which any premiums, additional amounts, and internal transfers were applied to the account. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, the trustees evaluate a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms while others are substantiated utilizing available market data.

Upon plan termination, assets were converted to individual annuity contracts.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore, not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Teachers Insurance and Annuity Association (TIAA) and College Retirement and Equities Fund (CREF), collectively the insurance companies, Newport Trust Company, LLC, and Ascensus Trust Company, collectively the custodians. TIAA, CREF, Newport Trust Company, LLC, and Ascensus Trust Company, are collectively the insurance companies and the custodians, as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. The Plan Sponsor pays directly any other fees related to the Plan's operations.
