- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

Note 1. Description of Plan

The following description of the Aviation Manpower Solutions 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan adopted on January 1, 2013 under Section 401(k) of the Internal Revenue Code (IRC). Substantially all employees of Aviation Manpower Solutions (the Company) age 21 or older that have completed 60 days of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible participants are permitted to elect to have a portion of their annual compensation, as defined in the plan document, contributed as pre-tax and Roth contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes automatic enrollment provisions whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions are invested in a designated fund unless changed by the participant. The Plan does not provide for automatic deferral increases.

The Company makes a safe harbor matching contribution equal to 100% of the first 3% of the participant's contribution plus 50% of contributions in excess of 3% to a limit of 5%. The Company may also make a discretionary matching contribution. No discretionary matching contributions were made to the Plan for the year ended December 31, 2024.

All eligible employees may contribute amounts representing distributions from other qualified plans (rollover contributions).

Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRC limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions plus earnings and is charged with an allocation of administrative expenses and plan losses. Allocations are based on participant earnings, account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of Plan

Vesting

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution is based on years of continuous service as follows:

Notes Receivable from Participants

Notes receivable from participants are not allowed under plan provisions.

Payment of Benefits

Upon termination of services due to voluntary separation, death, disability, or retirement participants can receive the value of the vested interest in their account in the form of a lump sum payout. Partial or installment distributions are permitted to satisfy the required minimum distribution rules of the IRC. Normal retirement age for the Plan is 65 and the Plan does not have early retirement features.

In-service distributions are permitted at age 59 ½ in accordance with plan provisions. Hardship distributions are permitted under the safe harbor criteria of the IRC and in accordance with plan provisions.

Forfeited Accounts

Forfeited nonvested accounts can be used to pay administrative expenses or to reduce future Company contributions. During 2024, \$481 of forfeitures were used to pay plan expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$0 and \$460, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

Administrative Expenses

Certain administrative expenses are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the payment of benefits to a participant are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net change in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Note 3. Certification

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company (VRIAC), the custodian of the Plan. The Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this information.

- Investments at fair value
- Investments at contract value
- Net change in fair value and contract value of investments
- Interest income

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

Note 4. Fair Value Measurements

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: Funds that include units of an insurance company's pooled accounts valued at the net asset value (NAV) of units of the accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pursuant to Accounting Standards Update 2015-07, *Fair Value Measurement*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instructions could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used for the years ended December 31, 2024 and 2023.

Note 4. Fair Value Measurements

The Plan holds various pooled separate accounts that are not direct filing entities. A majority of these pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled account is named. Certain other pooled separate accounts are target date funds which seek capital appreciation and current income consistent with asset allocations that become more conservative over time to the specified target retirement date.

Note 5. Investment at Contract Value

The Plan entered into a stable value fund, the Voya Fixed Account, under a group annuity contract issued by VRIAC. VRIAC maintains the funds in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The credited rate is based on a formula established by the contract issuer and is reviewed monthly for resetting. The contract provides for a minimum guaranteed rate of 1.00%.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investments contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract values, as reported to the Plan by VRIAC, represent contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the premature termination of the contract by the Plan or the termination of the Plan. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include cessation of contributions to the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

Note 6. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan sponsored by Access Retirement Services LLC. The non-standardized sponsor has received an opinion from the Internal Revenue Service (IRS) as to the non-standardized plan's qualified status. The non-standardized plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Note 6. Tax Status

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to IRS examination for years prior to 2021.

Note 7. Related Party and Party-in-Interest Transactions

All plan investments are currently managed by VARIC , the custodian of the Plan. The Plan pays administrative fees to the custodian.

The custodian receives revenue from underlying mutual funds and stable value fund service providers for services the custodian provides to the funds. These revenues are used to offset certain fees owed to the custodian for its administrative services to the Plan. If revenue received by the custodian from fund services exceeds the amount owed, the custodian remits the excess to the Plan. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024, \$858 was used to pay plan administrative expenses. At December 31, 2024, no amounts were in excess and available to be used by the Plan. The Plan or the Company may make payments to the custodian for administrative expenses not covered by revenue sharing.

The transactions above qualify as party-in-interest transactions and are exempt from the prohibited transactions rules of ERISA.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9. Concentrations

As of December 31, 2024 and 2023, the Plan had concentrations of investments in one fund that represented 13% and 12%, respectively, of total investments.

Note 10. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan under the provisions of ERISA.

Note 11. Subsequent Events

Management has evaluated subsequent events through September 2, 2025, the date on which the financial statements were available for issuance.
