## Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Nebraska Urology 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

## Opinion

## A. Description of Plan

The following description of the Nebraska Urology 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering substantially all employees of Nebraska Urology (the Company or Plan Sponsor) who are age 21 or older. The Plan excludes residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
2. *Contributions.* Each year, participants may contribute up to 100% percent of pretax and after-tax annual eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor matching contributions in an amount not less than 100% of the first 3% of compensation contributed by the participant. Discretionary profit sharing contributions may also be made by the Company. Employees must also have one year of service (at least 1,000 hours) to be eligible for safe harbor matching contributions and discretionary profit sharing contributions. Highly compensated employees are not eligible for safe harbor matching contributions. The Company may make discretionary matching contributions to participants based on their elective deferrals. During the year ended December 31, 2024, the Company made no discretionary matching contributions. Contributions are subject to certain IRS limitations.

3. *Participant accounts.* Each participant's account is credited with the participant's contributions, Employer contributions, rollovers, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Vesting.* Participants are immediately vested in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Employer discretionary matching contributions and profit sharing contributions, if any, are subject to a six-year graded vesting schedule. Separate provisions apply in the event of death or disability.

5. *Notes receivable from participants.* Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of one percent plus prime. Principal and interest is paid ratably through monthly payroll deductions. Participants may have no more than one loan outstanding at any given time.
6. *Payment of benefits.* On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. For distributions of amounts of \$7,000 or less, no participant consent is required. In addition, the Plan allows for hardship distributions if certain criteria are met.
7. *Forfeited and unallocated accounts.* At December 31, 2024 and 2023, unallocated and non-vested accounts, which include any forfeited amounts (none during 2024), totaled \$329,527 and \$493,383, respectively, to be used. These accounts will be used in accordance with Plan provisions. For the year ended December 31, 2024, \$722,827 in available funds were used to reduce Employer contributions.

## B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. *Investment valuation and income recognition.* Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and custodian. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Notes receivable from participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.
5. *Payment of benefits.* Benefits are recorded when paid.
6. *Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to withdrawals are charged directly to the participant's account and are included in administrative expenses. Fees related to recordkeeping, investment advisory services, and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments. The Plan administrator has established an arrangement with the custodian in which a suspense account is maintained to hold any unallocated amounts related to investment fees that are returned to the Plan. The investment fees are reimbursed to participant accounts. In 2024, \$10,743 were used to reduce Plan expenses. The net credit balance at December 31, 2024 is included in net appreciation/depreciation of fair value of investments
7. *Subsequent events.* The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued. Effective August 1, 2025, the Plan increased the force-out maximum from \$5,000 to \$7,000 which is permitted under SECURE 2.0.

## C. Certified Investments

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations under ERISA. Accordingly, the Plan custodian, Ameritas Life Insurance Corp. (Ameritas), has certified that the following data included in the Plan's financial statements and supplemental schedule is complete and accurate as of and for the year ended December 31, 2024.

The Plan's independent accountants did not perform any auditing procedures with respect to the above information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Pooled separate accounts:* The underlying assets of the pooled separate accounts consist of funds known as sub-accounts. Each sub-account invests its shares or units in an underlying mutual fund or common/collective trust. Sub-accounts are measured in terms of accumulation units. The sub-accounts are valued based on the quoted market prices of the mutual fund or common/collective trust. Certain fund fees and expenses, mortality and risk charges, and administration charges are deducted from the value of the mutual fund or common/collective trust to arrive at the value of the sub-accounts. The accumulation units are valued at Net Asset Value (NAV) on a daily basis. The NAV is made publicly available by the issuer.

## E. Investment Contract with Insurance Company

The Plan has a fully benefit-responsive investment contract with Ameritas. Contributions are maintained by Ameritas in their general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed interest contracts are fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value is the relevant measure for benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain participant withdrawals from this investment (non-benefit event over a certain threshold, as defined) or the Plan sponsor's termination from the group annuity contract may trigger a market value adjustment.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Since the investment is an obligation of Ameritas, the occurrence of an event that limits the ability of the investment to transact at contract value between Ameritas and a participant holding the investment is not probable.

## **F. Party in Interest Transactions**

Plan investments are managed by Ameritas, therefore, these transactions qualify as party in interest transactions. The Plan also paid fees to Ameritas for recordkeeping services during the year ended December 31, 2024.

## **G. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

## **H. Tax Status**

The Plan adopted a prototype non-standardized profit-sharing plan with CODA that has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **I. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
