For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

## **Diamond Surface, Inc. 401(k) Plan Notes to Financial Statements**

### **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Diamond Surface, Inc. 401(k) Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan, under section 401(k) of the Internal Revenue Code (IRC), covering all full-time employees of Diamond Surface Inc. (the Company) who are at least 18 years of age, have completed 12 continuous months service, or alternatively, have completed 1,000 hours of service in a 12 month period, are not covered by a collective bargaining agreement, and are not a nonresident alien. Plan entry dates are the first day of the plan year quarter upon meeting the eligibility requirements. Plan management receives quarterly financial reports from the recordkeeper. They meet annually with the board of directors, and discuss at their annual employee meeting, and during those meetings they will devote time to discuss the investment performances of the Plan and other matters of significance.

Employees working on a public construction project that is subject to the Davis-Bacon Act, or a similar statute, shall be entitled to immediately participate in the Plan without regard to the service hour requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. There are no automatic deferrals for those who do not elect to defer any monies into the plan. If the participant is making catch-up contributions, the Company will take them into account in determining matching contributions. The Company made discretionary matching contributions equal to 50% up to the first 6% of employees' salary deferrals. The Company's contributions are invested in the same manner as participant contributions. Contributions are subject to certain IRS limitations.

The Company will make a Qualified Nonelective Contribution ("QNEC") to the Plan for "prevailing wage contributions" on behalf of each participant who performs services subject to the Service Contract Act, Davis-Bacon Act, or similar federal, state, or municipal prevailing wage statute that requires the Company to pay its employees working on that project at wage rates not less than those determined to be prevailing wage rates in the geographical area where that project is located, after deducting the cost of providing health and welfare and/or fringe benefits, including any differential payments.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings or losses. Participant's accounts may be charged with an allocation of administrative expenses, as defined. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### **Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's contribution is based on years of continuous service. A participant is 100% vested after six years of credited service.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and accrue interest at the prime rate, on the date of the loan, plus 1%. Principal and interest is paid ratable through payroll deductions.

#### **Payment of Benefits**

Participants may receive distributions from the Plan upon death, retirement, termination of service, hardship, or in certain "in-service" situations. A participant may elect to receive a lump sum amount equal to the vested value of their account or substantial equal installments. Participants may leave their account under the Plan if their vested account is more than \$7,000. Participants are allowed to withdraw rollover contributions at any time. Participants, who are still employed with the Company, may obtain hardship distributions from all vested balances.

#### **Forfeitures**

Forfeitures resulting from a terminated participant's failure to be fully vested in the Company's contributions to the Plan are used in the following order: reduce the Company's matching contribution, offset plan expenses, or allocated to the remaining participants. Forfeited nonvested accounts totaled \$8,093 and \$5,808 at December 31, 2024 and 2023 respectively. Forfeitures of \$5,808 and \$4,631 were used to reduce the Company's matching contributions during 2024 and 2023, respectively.

### NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reflected at fair value in the accompanying financial statements. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants valued as of the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the trustee and investment advisor.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation represents the Plan's gains or losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Contributions**

Contributions from Plan participants and the matching and profit sharing contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Funding Policy**

The Company is required to remit the Davis-Bacon contributions to the Plan throughout the year. The Company remits matching and profit sharing contributions on an annual basis, generally by March following the end of each plan year.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in administrative expenses and net appreciation in fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 15, 2025, the date which the financial statements were available to be issued.

**NOTE 3 - CERTIFICATIONS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including non-interest bearing cash, investments, and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial, N.A., the trustee of the Plan.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered investment companies: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - INCOME TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**NOTE 7 - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan may invest in funds managed by Alerus Financial, N.A., the trustee of the Plan. Certain fees totaling \$2,815 were paid by the Plan to RBC Wealth Management and Alerus Retirement Solutions during 2024. These transactions qualify as party in interest transactions.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that change in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
