**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Watson Friendship Academy 403(b) Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

**Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Watson Friendship Academy 403(b) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - The Plan is a defined contribution savings plan covering substantially all employees of the Watson Institute Friendship Academy (Academy), the Watson Institute and the Education Center at the Watson Institute (collectively, the Organization). Employees are eligible for salary deferrals on the first day of the month following their date of hire. Employees become eligible to receive employer matching and discretionary contributions upon reaching the age of 21 and having one year of service, which is defined as 1,000 hours of service during a consecutive 12-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may make unlimited elective deferral contributions, subject to Internal Revenue Code (IRC) limitations. Participants direct their contributions into various investment options offered by the Plan. The Organization matches \$0.50 per dollar up to 4% of employee contributions, as defined by the Plan. Employees who attain age 50 before the end of the Plan year are generally eligible to make catch-up contributions to the Plan. The maximum catch-up contribution amount was \$7,500 and \$6,500 in 2024 and 2023, respectively. In both 2024 and 2023, the Organization also made a discretionary contribution of 4% of a participant's eligible compensation to the Plan.

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of the Organization's matching contribution, the employer discretionary contributions and Plan earnings. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participant contributions, plus actual earnings thereon, vest immediately. The Organization's contribution portion of the participants' accounts vests based on years of continuous service. Participants vest 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service and 100% after six years of service.

Forfeitures - Forfeitures of terminated participants' nonvested accounts are used to reduce subsequent Organization contributions. At December 31, 2024 and 2023, forfeited nonvested accounts approximated \$47,800 and \$12,800, respectively. In 2024, employer contributions were reduced by approximately \$57,800 from forfeited nonvested accounts.

Notes Receivable from Participants - Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The Plan permits qualifying participants up to one outstanding borrowing from their account. Notes are collateralized by the balance in the participant's vested account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through biweekly payroll deductions. Notes are required to be repaid with five years.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits - On termination of service for any reason, a participant, representative or beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants become 100% vested upon death or disability. In addition, the Plan provides for in-service withdrawals from a participant's elective contribution account balances based on financial hardship. The Plan administrator may determine that a financial hardship exists based on several events outlined in the Plan document, including expenses for medical care; payment of tuition expenses; costs related to the purchase of a principal residence; and payments necessary to prevent the participant from being evicted from his or her principal residence. In addition, the Plan administrator must also determine if the participant has any other alternative resources available to him/her before granting a hardship withdrawal.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

Basis of Accounting - The accompanying financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates - The preparation of the financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. (See Note 4 for discussion of fair value measurement.)

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - Management has evaluated subsequent events through September 16, 2025, the date on which the financial statements were available to be issued.

NOTE 3 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Plan document and ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 are described below:

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023

Registered Investment Companies - Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

NOTE 4 - FAIR VALUE MEASUREMENT (Continued)

Fixed Plus Accounts - Investment contracts with insurance companies are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. The crediting interest rate is determined on a monthly basis by an actuarial formula, as designated by Voya Retirement Insurance and Annuity Company (Voya). The crediting interest rate is subject to a guaranteed minimum floor, as defined on an annual basis by Voya. For the Fixed Plus Account II, the floor rate was 2.65% as of December 31, 2023. The average yield and crediting interest rate was approximately 2.65% for 2023. For the Fixed Plus Account II A, the floor rate was 1.50% as of December 31, 2023. The average yield and crediting interest rate was approximately 1.50% as of December 31, 2023.

The method described might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair value. Further, although the Plan administrator believes that the Plan's valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Plan is a prototype plan that received an opinion letter on March 31, 2017, in which the Internal Revenue Service (IRS) stated that the form of the Plan document was acceptable under the applicable requirements of the IRC. The Plan has been designed to qualify under Section 403(b) of the IRC. Although the Plan has been amended since receiving this opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan utilizes investment instruments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company and Voya, the trustees of the Plan.

NOTE 8 - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment companies and fixed plus accounts managed by the Plan's service providers, which are the trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Capital Bank and Trust Company has outsourced certain transaction processing and related responsibilities to an affiliated company, American Funds, and also considers American Funds a party-in-interest. Certain administrative functions are performed by employees of the Organization at no cost to the Plan.
