In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter on the Financial Statements**

As described in Note 4, the financial statements include investments valued at \$49,308,280 (99% of total investments) and \$47,743,519 (99% of total investments) as of December 31, 2024 and 2023, respectively, whose fair value has been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by independent consultants. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Supplemental Schedule Required by ERISA**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The schedule of assets (held at end of year) as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. DESCRIPTION OF PLAN

The following description of the Hallmark Building Supplies, Inc. Employee Stock Ownership Plan (the “Plan”), provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### General

The Plan is an employee stock ownership plan designed to invest primarily in the stock of the Company. The Plan covers all employees of Hallmark Building Supplies, Inc. (the “Company”) who are age 21 or older and excludes collectively bargained employees, leased employees and non-resident aliens who receive no earned income from services performed within the United States. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986 (the “Code”), as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The loan from the Company is secured by the unallocated shares purchased with the note. Accordingly, the financial statements for the plan years ended December 31, 2024 and 2023, present separately the assets and liabilities and changes pertaining to: 1) the accounts of participants with rights in allocated stock (allocated) and 2) stock not yet allocated to participants (unallocated). Shares are released from collateral and become allocated generally in the period in which the debt service is paid.

#### Contributions

During 2024 and 2023, the Company could contribute, in either cash or stock, amounts as determined annually by the Trustees, subject to limitations established by the Code. For the years ended December 31, 2024 and 2023, the Company contributed \$581,626 each year in cash contributions. Plan shares purchased with debt proceeds are held in suspense. As debt service payments are made by the Plan, shares are released from suspense and allocated to active participants.

Contributions are subject to certain limitations as mandated by the Code. Contributions and forfeitures from the accounts of terminated participants are allocated to participants as of the end of the plan year.

The Plan does not allow for voluntary contributions by employees.

**1. DESCRIPTION OF PLAN (Continued)**

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustees from the unallocated account and from forfeitures of terminated participants' nonvested accounts, if any. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year.

Vesting

Participants are credited annually with Company contributions and related earnings (losses) thereon. Vesting in Company contributions and related earnings (losses) thereon is based on the following table:

Payment of Benefits

On termination of service, death, disability, or retirement, a participant may receive a lump sum amount equal to the vested value in his or her account or periodic installments over a period less than the participant's life expectancy. A participant that terminates employment whose vested account balance is less than \$7,000 (\$5,000 prior to 2024) will receive a distribution of their vested aggregate account balance without the consent of the participant. If the distribution is less than \$1,000 the distribution will be made in the form of lump sum cash. If the distribution is greater than \$1,000, but less than \$7,000 (\$5,000 prior to 2024), the Plan will pay the distribution in an automatic direct rollover to an individual retirement account ("IRA"). Distributions, which can be made in the form of cash or common stock, are based upon the value of the Company's common stock as of the valuation date immediately preceding the date of distribution.

**1. DESCRIPTION OF PLAN (Continued)**

Payment of Benefits (Continued)

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, if they are not purchased by the Plan first. For the years ended December 31, 2024 and 2023, the Plan distributed and repurchased 6,370.92 and 26.47 shares, respectively, from participants at the current appraised value. Repurchased shares were reallocated to the remaining eligible participant accounts. During the years ended December 31, 2024 and 2023, 29,919 and 43,408 shares, respectively, were distributed to participants and were not repurchased by the Plan. The Company repurchased the shares from participants pursuant to the provisions of the Plan.

Voting Rights

Each participant is entitled to direct the Trustees how to vote the shares of employer stock allocated to their account with regard to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets, or such similar transaction as the Secretary of Treasury may prescribe in regulations.

Each participant also has the right to direct the Trustees how to vote the shares of the employer stock in their account with regard to the approval or disapproval of any sale or transfer of Hallmark Building Supplies, Inc. held by the Plan to a person or entity (other than Hallmark Building Supplies, Inc.) outside of the Plan.

Put Option

Under federal income tax regulations, employer stock that is held by the Plan and its participants which is not readily tradable on an established market, or is subject to trading limitations, must include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in the employer's common stock into investments that are more diversified. Participants who are at least age 55 and have completed at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

Terminated Participants

Included in net assets available for benefits are amounts allocated to individuals who have elected to take a distribution from the Plan, including diversifications allowed by the Plan to other qualified retirement plans, but have not yet been paid. Vested plan assets allocated to these participants were \$1,059 for both the plan years ended December 31, 2024 and 2023.

Forfeited Accounts

Forfeitures for participants who terminate will be allocated after the expiration of a five year period during which the forfeiture balances are reinstated if the participants are rehired or subsequent to the terminated participant receiving a full distribution from the Plan, whichever is earlier. Forfeitures of both cash and stock, which were allocated to participants, totaled \$52,522 and \$132,477 for the years ended December 31, 2024 and 2023, respectively. Forfeitures of terminated nonvested account balances as of December 31, 2024 and 2023 totaled \$148,867 and \$62,793, respectively.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements is in conformity with accounting principles generally accepted in the United States of America (“US GAAP”) and requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Trustees determine the Plan’s valuation policies utilizing information provided by the investment advisers and trustee.

The investment in the Company common shares is valued as of December 31, 2024 and 2023 at \$49,308,280 and \$47,743,519, respectively, based upon an appraisal performed by an independent valuation firm, and approved by the Plan’s management. See Note 4 for discussion of fair value measurements.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Dividends

When declared, dividends paid by the Company on shares allocated to a participant's account are accrued and distributed quarterly to the participants unless a participant elects to reinvest his or her dividends. The election to reinvest some or all dividends paid with respect to the Company common stock is available to participants as soon as they become eligible under the Plan and may be changed 30 days prior to the beginning of a calendar quarter. Participants are fully vested in all reinvested dividends. There were no dividends declared or paid by the Company for the years ended December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Company pays substantially all of the Plan's administrative expenses.

Recent Accounting and Regulatory Pronouncements

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and awaiting additional regulatory guidance from the Internal Revenue Service ("IRS") and Department of Labor ("DOL"). The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements for the plan years ended December 31, 2024 and 2023. The Plan will be amended to reflect any changes made in response to SECURE 2.0 prior to the deadline set by law or applicable regulations.

**3. INVESTMENTS**

The original average cost of shares allocated was \$3,942,392 and \$4,173,013 as of December 31, 2024 and 2023, respectively. The original average cost of unallocated shares was \$12,855,157 and \$13,369,362 as of December 31, 2024 and 2023, respectively.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets,
- b. Quoted prices for identical or similar assets or liabilities in inactive markets,
- c. Inputs other than quoted prices that are observable for the asset or liability,
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

**4. FAIR VALUE MEASUREMENTS (Continued)**

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023:

*Common stock:* Fair value of Hallmark Building Supplies, Inc. common stock is based upon an annual appraisal by an independent appraiser. This appraisal was based upon a combination of the market and income valuation techniques. The appraiser took into account historical and projected cash flow, net income, return on assets, return on equity, market comparables, and estimated fair value of company assets and liabilities. Company management accumulates data for the appraiser. The appraiser prepares a preliminary report which the Trustees review, discuss and approve.

*Money market mutual fund:* Valued at the daily closing price as reported by the fund. The money market mutual fund held by the Plan is an open-ended mutual fund that is registered with the US Securities and Exchange Commission. The fund is required to publish its daily net asset value and to transact at that price. The money market mutual fund held by the Plan is deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. LOANS PAYABLE**

In 2020, the Plan entered into a \$17,730,928 term loan agreement with the Company. The proceeds of the loan were used to purchase Company common stock. The term loan is secured by the unallocated shares purchased with the original proceeds from the loan. The agreement provides for the loan to be repaid over 30 years due in annual principal and interest payments of \$621,835 through December 31, 2049 and bearing interest at a rate of 1%.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

**7. TAX STATUS**

The IRS has determined and informed the Company by letter dated September 26, 2013, that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments, which include 926,673 and 956,592 shares of the Company's common stock as of December 31, 2024 and 2023, respectively, are held by the Trustees of the Plan. Transactions involving the funds administered by the Company are considered party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations. Certain administrative expenses are paid by the Plan or the Company. These transactions qualified as party-in-interest. Employees of the Company provide administrative services to the Plan for which no fees are charged.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
