### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Sentinel Peak Resources Management LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

### Note 1 - Plan Description

The following description of Sentinel Peak Resources Management LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***Administration***

Sentinel Peak Resources Management LLC (the "Company") is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Fidelity Management Trust Company (Fidelity) functions as the trustee and investment manager. Fidelity offers plan participants a variety of investment options through various mutual funds and a common collective trust. Individual accounts are invested in various investment options at the direction of the participants.

#### ***General***

The Plan is a defined contribution plan covering all full-time employees of the Company who have completed one month of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Eligible employees are automatically enrolled in the Plan with a deferral election of 6 percent of compensation unless the eligible participant makes a contrary election on or after 30 days' notice.

All usual and reasonable expenses of the Plan may be paid in whole or in part by the Company. Any expenses not paid by the Company will be paid by the trustee with assets of the Plan. In 2024, all expenses were borne by the Company except for monthly investment management service fees charged to the funds, loan application fees charged to the participants who obtained a loan, and transaction fees charged to participants.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and withdrawals, as applicable, and allocations of the Company's contributions and plan earnings or losses, forfeitures, and plan expenses. Allocations are based on participants' compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Contributions***

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions limited by the IRC. The Plan allows participants to contribute up to 100 percent of their compensation on an after-tax basis as Roth 401(k) deductions. Provided requirements are met, withdrawals of contributions and any earnings are tax free. A participant's combined pretax and Roth 401(k) contributions cannot exceed the maximum annual amount allowed by law. The Plan also permits rollover contributions from other qualified retirement plans. Employee contributions to the Plan are made through regular payroll deductions.

The Company will make a matching contribution of 100 percent of elective deferrals up to 6 percent of eligible compensation. Matching contributions are funded each pay period. The Company has the right to designate all or a portion of the matching contributions, as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½. The Company also has the right to make discretionary nonelective contributions.

**Note 1 - Plan Description (Continued)**

The Plan is operating pursuant to the safe harbor provisions of IRC Section 401(k)(12). The Company's safe harbor matching contributions are on an annual basis and will equal 100 percent of compensation deferred by the participant up to 6 percent of a participant's eligible annual compensation. The Company has the right to designate all or a portion of the matching safe harbor contributions, as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½. Safe harbor contributions were not made for the year ended December 31, 2024.

***Vesting***

Participants are immediately 100 percent vested in their voluntary contributions, allocated earnings or losses thereon, qualified nonelective contributions, and any safe harbor matching contributions. Any employer discretionary contributions (including forfeitures) that are not qualified and the earnings or losses thereon not fully vested when contributed will have a vested interest of 0 percent until year three and, then, will be 100 percent vested after three years of service. Any nondiscretionary employer matching contributions (including forfeitures) that are not safe harbor matching employer contributions or qualified nonelective contributions and the earnings or losses thereon not fully vested when contributed will have a vested interest of 0 percent under two years of service and, then, will be 100 percent vested after two years of service.

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65), retirement due to disability, or termination of the Plan.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account shall be placed in a separate account. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. During the year ended December 31, 2024, forfeitures of \$86,382 were used to offset employer matching contributions. The forfeitures account had a balance of \$123,591 and \$101,260 as of December 31, 2024 and 2023, respectively.

***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals. The Plan allows in-plan Roth conversions. Furthermore, the Plan allows for terminated participant vested account balances of \$5,000 or less to be automatically distributed out of the Plan.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances, reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period. Participants may have a maximum of one loan outstanding at any given time. The loans are secured by the balances in the participants' accounts and bear interest at rates ranging from 4.25 to 9.50 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at loan origination. Loans have a maximum term of 5 years, unless such loan is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 30 years from the date of the loan origination. Principal and interest are paid ratably through payroll deductions. Upon termination of a participant from employment, the participant's loan shall continue to be payable in accordance with the provisions of the participant's loan or be due in full.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. If the Plan is terminated for any reason, all participants become 100 percent vested, and the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value.

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company, which qualify as party-in-interest transactions.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities that, in general, are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Additionally, some investments held by Fidelity are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

***Concentration of Investments***

At December 31, 2024, three investments accounted for approximately 40 percent of net assets available for benefits. At December 31, 2023, four investments accounted for 49 percent of net assets available for benefits. During the year ended December 31, 2024, four investments accounted for 55 percent of net investment gains. A significant change in the market value of these investments would significantly affect the net assets available for benefits and related investment income of the Plan.

***Subsequent Events***

The plan administrator has evaluated all subsequent events through August 6, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended to allow participants to make voluntary, nondeductible after-tax employee contributions and to allow for an in-plan rollover of eligible participant account balances to be designated as Roth contributions.

**Note 3 - Certified Information**

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter dated June 30, 2020 from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### Note 5 - Fair Value Measurements (Continued)

##### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

##### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
