INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the
Nelson Irrigation Corporation 401(k) and Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Nelson Irrigation Corporation 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Nelson Irrigation Corporation 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Nelson Irrigation Corporation 401(k) and Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Nelson Irrigation Corporation (the Company) 401(k) and Profit Sharing Plan (the Plan) provides only general information. The Plan has been amended and restated to comply with current legislation and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Plan agreement, available from the Benefits Department of the Company, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that includes an employer basic non-elective feature and a qualified thrift 401(k) feature.

The basic non-elective feature covers all employees of the Company who are at least 18 years of age and have completed one year of service (at least 1,000 hours) and are employed on the last day of the plan year. Eligible employees are qualified for the basic non-elective feature on the first day of the Plan year in which they meet the one-year service requirement.

Employees are eligible for the qualified thrift 401(k) feature upon reaching 18 years of age. Under the 401(k) feature, participants can elect to defer a portion of their compensation within statutory limits. The Company matches a portion of the employee deferrals.

The 401(k) Board of Trustees is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

The Company makes an annual basic non-elective contribution for each qualified employee. The amount of the contribution each year is 5% of the first \$10,000 of the employee's annual compensation (excluding miscellaneous special compensation) and 4% of the compensation in excess of \$10,000, as defined in the Plan document; limited to \$4,100 per participant. The basic non-elective contribution for 2024 is \$703,603, and was funded by the Company, net of available forfeitures, in the following Plan year in accordance with Internal Revenue Service (IRS) regulations.

The 401(k) feature of the Plan provides for automatic enrollment of eligible employees at a deferral rate of 6% of eligible compensation, as defined in the Plan document, with a step-up rate of 1% each subsequent year, up to a maximum of 15%. Participants may elect to change or stop the payroll deductions at any time.

Effective July 1, 2024, the Plan was amended to increase the automatic savings increase arrangement maximum from 15% to 20%.

NOTE 1 – DESCRIPTION OF THE PLAN (continued)

Contributions (continued)

The 401(k) feature also allows participants to elect to defer up to 100% of their pre-tax or after-tax annual compensation, as defined in the Plan document and within statutory limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company matches 50% of the first 8% of compensation that a participant contributes to the Plan, limited to \$4,000 per participant, per year. These employee and employer contributions are paid to the Plan at the end of each pay period and placed in participant directed investments.

Participant Accounts

Individual participant accounts are maintained by Schwab Retirement Plan Services (Schwab Retirement), the Plan's third-party administrator. Each account is credited or charged with the participant's contribution, the Company's matching and non-elective contributions, allocations of investment income and losses on the individual account balances, and administrative and investment advisory fees. Loan fees are deducted from the respective participants' accounts. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct employee and employer contributions among various mutual funds and one collective trust fund.

Vesting

Participants are immediately vested in voluntary contributions plus actual earnings thereon. Vesting in the employer contributions plus actual earnings thereon is based on years of credited service, as defined in the Plan document, at a rate of 20% per year of service, with full vesting after five years. Upon normal retirement (65), death, or disability, participants become fully vested in all benefits.

Notes Receivable from Participants

Participants may borrow from their account up to the lesser of \$50,000 or 50% of their vested account balance under certain hardship circumstances. Terms of the notes receivable may not exceed five years, except for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Notes receivable outstanding at December 31, 2024 bear interest ranging from 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions.

NOTE 1 – DESCRIPTION OF THE PLAN (continued)

Payment of Benefits

Upon retirement, death, disability, or other termination of employment, a participant or beneficiary may elect to receive a lump-sum amount equal to the value of his or her vested account or installments over a period of time, as described in the Plan document. Upon attaining age 59½, participants may request a partial distribution, payment stream option, or a lump-sum distribution of their vested profit sharing and 401(k) account balances or a Joint and Survivor Annuity prior to retirement. Under certain hardship circumstances, participants may request a lump sum distribution of their voluntary contribution accounts.

Forfeited Accounts

Upon termination with no vested balance in the Plan, the date a participant's vested account balance is distributed from the Plan, or the date a participant incurs five consecutive one-year breaks in service, the participant's non-vested account balances are forfeited. The Plan Administrator may use forfeitures to pay Plan expenses and any remaining forfeitures are used to reduce future employer contributions. Forfeited non-vested accounts totaled \$789 and \$7,629 at December 31, 2024 and 2023, respectively. During 2024, forfeitures of \$11,859 were used to reduce the 2023 basic non-elective contribution funded in March 2024 and forfeitures of \$21,783 were used to pay Plan expenses.

Subsequent Events

The Plan has evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are significant accounting policies used by the Plan:

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus accrued but unpaid interest, if any. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Advisory Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for individual transactions such as loans are deducted from the respective participant's account. Investment related expenses, and revenue sharing fees or credits, are included in net appreciation in fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 3 – FAIR VALUE MEASUREMENTS (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund – A stable return fund that is composed primarily of fully-benefit responsive investment contracts that is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the collective trust will sell the investment for an amount different than the reported NAV.

NOTE 4 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends and interest, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (Schwab Trust), the trustee of the Plan.

NOTE 5 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Schwab Trust is the trustee of the Plan; therefore, transactions with Schwab Trust and its affiliates qualify as party-in-interest transactions. Fees are paid by the Plan to these parties for administrative services. Revenue sharing fees are collected from various mutual fund companies by Schwab Trust and are credited back to participant accounts based on the related investments.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 7 – TAX STATUS

The Plan operates under provisions of a Schwab Retirement Plan Services, Inc. Pre-Approved Plan which received an opinion letter from the IRS dated September 21, 2020, which stated that the Pre-Approved Plan, as then designed, was acceptable under the applicable sections of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan allows participants to invest in investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
