Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MOL Retirement & Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Note 1 - Description of Plan

The following description of MOL Retirement & Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees who have completed two months of service with MOL (Americas) LLC (the "Plan Sponsor"), MOL (Americas) Holdings, Inc., MOL Chemical Tankers America, LLC, MOL Consolidation Services (America), Inc., and MOL Worldwide Logistics (America), Inc. (collectively, the "Company"). Eligible employees may enroll in the Plan on the first day of each month of any Plan year, following the satisfaction of the service requirement, as defined. The Plan does not cover persons employed on temporary assignment such as summer, leased, work study or intern employees or employees on temporary assignment from Mitsui O.S.K. Lines, Ltd. and other foreign subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Sponsor is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Sponsor.

Contributions

Each year, participants may elect to contribute a portion of their pre-tax annual compensation, as defined by the Plan, up to an annual limit determined by the Internal Revenue Service ("IRS"). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated age-appropriate lifecycle fund until changed by the participant. The deferral rate of automatically enrolled participants is automatically increased by 1% each year unless such participants elect to defer at a specified rate. The Company contributes 50% of the first 6% of compensation that a participant contributes to the Plan. In addition, the Company has agreed to make profit-sharing contributions to the Plan. The Company's profit-sharing contributions are equal to 5% of each participant's pre-tax base compensation. The Company may, at its sole discretion, change the contribution percentage for a particular Plan year. Contributions are subject to certain IRS limitations.

A participant may, with the consent of the Plan, make a rollover contribution to the Plan at any time. Rollover contributions are assets transferred to the Plan from other qualified savings plans in which employees participated prior to their employment with the Company.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options

Participants direct their contributions, as well as Company contributions, into any of several mutual funds, a money market fund and a common/collective trust offered by Fidelity Management Trust Company ("Fidelity" or the "Trustee"). In the absence of an initial investment election, the participant's account shall automatically be invested in the age-appropriate lifecycle fund until the election is changed.

Each participant may elect to change the percentage invested in each fund with respect to the participant's account daily. The percentage elections for investment funds must be in increments of 1% and the same percentage shall be applied equally to each of the participant's accounts.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants become fully vested in Company contributions based on years of employment according to the following schedules:

Notes receivable from participants

Participants may borrow from their individual account balances in accordance with the Plan's provisions. The minimum amount of any loan shall be \$1,000 and shall not exceed the lesser of (i) \$50,000 reduced by the participant's highest outstanding loan balance during the one-year period immediately prior to the date in which such loan is made or (ii) 50% of the value of the participant's vested account. The loans are secured by the balance in the participant's account and bear interest at the prevailing rate for similar loans. Principal and interest are paid ratably through bi-weekly payroll deductions.

The entire unpaid principal balance of a loan is due immediately either upon the participant's death or default in payment of either principal or interest, as defined. Should a participant's employment be terminated for reasons other than death, the balance of the loan is not immediately due and will continue to be payable in accordance with the terms of the original loan agreement. If any amount of a loan is unpaid at the end of the repayment period, the unpaid amount will be treated as a distribution from the Plan and may be taxable as income to the participant. A participant is permitted to have only one loan outstanding at any time.

Payment of benefits

Distributions under the Plan are made upon a participant's death, total disability, retirement, or other termination of employment. On termination of service, participants whose vested account balance exceeds \$5,000 may elect to receive a lump-sum, periodic installments or have the vested interest of his or her account transferred to an individual retirement account, or a qualified retirement plan maintained by another employer. If a participant's vested balance is between \$1,000 and \$5,000 and the participant is younger than normal retirement age, as defined, the participant may elect to

receive a lump-sum distribution, or the Plan administrator may roll the vested balance to an individual retirement account. If a participant's vested account balance is \$1,000 or less, the participant will receive a lump-sum distribution. Upon the death of a participant, death benefits are payable to a surviving spouse or other beneficiary.

The Plan provides for in-service withdrawals to participants in the event of hardship, at age 59 1/2, upon attainment of the normal retirement age, and in other qualified circumstances, as defined by the Plan.

Forfeited accounts

Upon termination of employment and withdrawal from the Plan, the nonvested portion of a participant's account will be forfeited. Forfeitures are retained in the Plan and will either be used to pay administrative expenses under the Plan, as directed by the employer, or to reduce future employer contributions payable under the Plan. At December 31, 2024 and 2023, the amount of forfeited nonvested accounts amounted to \$134,747 and \$160,694, respectively. In 2024, employer contributions were reduced by \$79,339 from forfeited nonvested accounts.

Note 2 - Summary of significant accounting policies

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the Trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Contributions

Contributions from Plan participants and the matching and profit-sharing contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are also included in administrative expenses.

Subsequent events

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual and money market funds: Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-end mutual and money market funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common/collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

Note 5 - Related party and party-in-interest transactions

Certain Plan investments were invested in funds managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Trustee provides certain administrative services to the Plan pursuant to an Adoption Agreement ("AA") between the Company and the Trustee. The Trustee receives revenue from mutual fund and collective/trust fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan.

If the revenue received by the Trustee from such mutual fund or common/collective trust exceeds the amount owed under the AA, the Trustee remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, approximately \$145,000 of revenue credits were used to reduce administrative expenses. The Plan or the Plan Sponsor may make a payment to the Trustee for administrative expenses not covered by revenue sharing.

Note 6 - Plan termination

The Company has not expressed the intent to terminate the Plan. However, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 7 - Tax status

The underlying nonstandardized pre-approved plan obtained its latest opinion letter dated June 30, 2020 in which the IRS stated that the form of the Plan, as then designed, was in compliance with applications sections of the Internal Revenue Code (the "IRC") and, therefore, the related trust was tax-exempt. The Plan is eligible and has opted to rely on this opinion letter. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
