### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ascentage Pharma Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

#### NOTE 1. DESCRIPTION OF THE PLAN

**General** - The following description of the Ascentage Pharma Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established to provide benefits to substantially all employees of the Ascentage Pharma Group, Inc. (the Company). Eligible employees 21 years of age or older may participate in the Plan immediately upon employment with the Employer. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Administration** - Ascensus Trust Company has been engaged to serve as the trustee and holds the assets of the Plan. The Plan Administrator is Compass 360 LLC and official recordkeeper of the Plan that processes and maintains the records of participant data. The investment line-up and investment advice is provided by an outside certified financial professional.

**Investments** - Upon enrollment in the Plan, a participant may direct contributions in any or all of the investment options offered under the Plan.

**Vesting** - Participants are immediately vested in their elective deferral contributions, rollover contributions, and related earnings upon entering the Plan. Year of Vesting Service means a 12-month period beginning on date of hire.

Interest in employer contributions will vest based on years of vesting service with the following schedule:

<u>Years of Vesting Service</u>	<u>Percentage</u>
Less than one year	0%
One year but less than two years	25%
Two years but less than three years	50%
Three years but less than four years	75%
Four or more years	100%

Participants will become fully (100%) vested upon attainment of Normal Retirement Age while an employee, death while an employee, or becoming disabled while an employee.



## NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Participant Contributions** - Participants may elect to contribute a 100% of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Participants who elect to contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Contributions withheld are invested in accordance with the participant's election into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Internal Revenue Code (IRC). Participants are permitted to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such rollover contributions are deposited in the appropriate investment funds in accordance with the participant's election and the Plan's provisions.

The Plan also includes an automatic enrollment provision where 6% of eligible compensation is automatically withheld from participant compensation and invested on behalf of the participant unless the participant elects a different deferral percentage, including 0%. For participants automatically enrolled on or after May 15, 2019, the automatic deferral amount will increase by 1% each year, up to a maximum of 15% of compensation.

**Employer Contributions** - The Company may, at its sole discretion, make a matching contribution on behalf of a participant if they make a "Matched Employee Contribution". A "Matched Employee Contribution" is any Elective Deferral Contribution, Catch-up Contribution or Voluntary Contribution that is made during the Plan Year. If a "Matched Employee Contribution" the Company may contribute to the participants Employer Matching Contribution Account in an amount and allocation formula as determined by the Company in its sole discretion. The employer matching contribution for the year ended December 31, 2024 was \$1,386,459.

**Participant Accounts** - Each participant's account is credited with the participant's contributions, the employer's matching contributions, allocations of the employer's discretionary profit sharing contribution, if any, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Payment of Benefits** - Benefit payments are available to participants upon retirement (age 65), termination of employment, death, total and permanent disability, attainment of age 59½ or qualified financial hardship. Participants are entitled to a benefit equal to the vested portion of their account, which will be distributed in the form of a lump sum payment unless the participant elects another option provided by the Plan. In addition, upon termination, the Plan allows for automatic lump sum distributions of participant vested account balances that do not exceed \$5,000. Distributions are subject to the applicable provisions of the Plan agreement. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59½.



## NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

**Notes Receivable from Participants** - The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$100,000 or 50% of their vested account balance. Such notes bear interest at 3% above the prime rate and must be repaid to the Plan within a five-year period unless the note is used to purchase a principal residence. Notes mature at various dates through July 2027. As of December 31, 2023, the interest rates on these notes range from 5.50% to 10.50%. The specific terms and conditions of such notes are established by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Quoted market value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan's investment in the common collective trust is valued based on the net asset value (NAV) of the units held by the Plan at the end of the year. The NAV is determined by Voya and is not publicly quoted. The NAV is primarily based on the quoted market prices of the underlying mutual funds and is adjusted for certain contract charges and fees. The NAV per unit is used as the practical expedient to estimate fair value.

Purchases and sales of investments are reported on a trade date basis. Interest income is recognized on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.



## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the employer and are excluded from these financial statements. Fees related to the specific participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**Payment of Benefits** - Benefits are recorded when paid.

**Credit Losses** - During the year ended December 31, 2023, the Plan adopted the provisions of Accounting Standards Update (ASU) 2016-13, *Financial Instruments – Credit Losses* (Topic 326). This ASU replaced the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. The ASU requires entities to immediately recognize the estimated expected credit losses over the life of a financial instrument, including trade receivables, including employer contribution receivables. The estimate of expected credit losses considers not only historical information, but also current and future economic conditions and events.

The Plan adopted the ASU effect January 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in additional disclosures.

## NOTE 3. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Acensus Trust Company, the trustee of the Plan.

## NOTE 4. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs).

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

## NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV of units of the trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

## NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participant accounts will become fully vested and non-forfeitable.

## NOTE 6. TAX STATUS

The Plan is using a prototype plan approved by the Internal Revenue Service (IRS) and, accordingly, has neither applied for nor received a determination letter from the IRS. The Company believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. Management believes there are no uncertain tax positions requiring recognition in the financial statements.



## **NOTE 7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than direct payment. Notes receivable from participants also qualify as party-in-interest transactions. All of the party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

## **NOTE 8. RISKS AND UNCERTAINTIES**

The Plan's investment options provide participants with a variety of investment alternatives with differing levels of risk and income potential. Investments are exposed to various risks such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **NOTE 9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 10, 2025, which is the date the financial statements were available to be issued. The review and evaluation revealed no material event or transaction which would require adjustment to or disclosure in the accompanying financial statements.
