1. Description of the Plan

The following description of Rhodes Flagging Services, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan sponsor is Taylor Creek, Inc. DBA Rhodes Flagging Services (the Company).

- A. General - The Plan is a defined contribution plan covering substantially all employees of the Company. Employees, except those who are collectively bargained or a non-resident alien, are eligible to participate in the Plan on the first day of the month following the completion of the eligibility requirements and 90 days of service. For purposes of prevailing wage contributions, any government contract employee who is a non-highly compensated employee shall become a participant in the component of the Plan to which the prevailing wage contributions are allocated. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's management oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
- B. Contributions - Each year participants may contribute a portion of their eligible compensation into the Plan, as pre-tax or Roth deferrals, subject to the maximum allowed by the Internal Revenue Code ("IRC"). Participants who have attained the age of 50 before the end of the Plan year end are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans (rollovers). Participants direct the investment of their elective deferrals and Company contributions into various investment options offered by the Plan. The Company may make discretionary matching or profit-sharing contributions to be determined each year by the Company. During the year ended December 31, 2024, the Company did not make a discretionary contribution. The Company is required to make prevailing wage contributions based on prevailing wage laws to satisfy the fringe benefit requirements of the law. For the year ended December 31, 2024, the prevailing wage contribution was \$177,479. Contributions are subject to certain statutory limitations.
- C. Participant Accounts - Each participant's account is credited with the participant's contribution and the Company's discretionary contributions, if any, and allocations of a) the Company's contributions, b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting - Participants are immediately vested in their elective deferrals and prevailing wage contributions plus actual earnings thereon. Vesting in the discretionary matching contributions and earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

- E. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at rates that range from 3.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator at the initiation of the loan. Principal and interest is paid ratably through payroll deductions.
- F. Payment of Benefits - Participants or their beneficiaries are eligible for distributions upon retirement, disability, death or termination. Distributions will be made by lump-sum payment equal to the value of the participant's vested interest in his or her account, or in partial withdrawals. In-service distributions are permitted in some circumstances. A participant becomes fully vested in all contributions upon death, disability, or retirement.
- G. Forfeited Accounts - These accounts will be used to reduce future Company contributions. There were no forfeitures used during the year ended December 31, 2024. As of December 31, 2024 and 2023 there were no amounts available to offset future contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements are presented on the accrual basis.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative fees when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in a default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Payment of Benefits - Benefits are recorded when paid.

Expenses – Some of the expenses of maintaining the Plan are paid for by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Loan initiation, distribution fees, and compliance and reporting service fees are charged directly to the participant's account.

4. Fair Value Measurements

The fair value measurement accounting literature established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No level 1 inputs were available, as all investments were valued using net asset value (NAV) a practical expedient.

Level 1 Fair Value Measurements

Pooled separate accounts: The fair value of the pooled separate accounts is based on NAV of the shares as reported by the fund. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by the underlying investments. These assets are valued at the current value of the underlying investments, using net asset value as a practical expedient.

Gains and losses included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Level 1 and Level 2 or into or out of Level 3.

5. Related Party and Party-in Interest Transactions

Certain Plan investments are held in pooled separate accounts managed by John Hancock. John Hancock is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Company pays certain Plan expenses. The Plan has a number of service providers. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the prototype received its opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Concentrations

At December 31, 2024 and 2023, approximately 99% of the Plan's investments were held in the BlackRock Life Path Index Target date series of funds as of each date.

10. Subsequent Events

Subsequent events were evaluated through September 4, 2025, which is the date the financial statements were available to be issued.
