Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Perc Engineering, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

General

The following description of the Perc Engineering, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the *Plan Document* for a more complete description of the Plan’s provisions.

The Plan, established on January 1, 2013, is a defined contribution plan covering generally all employees of Perc Engineering, LLC (the “Company” or “Employer”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was most recently amended and restated on January 1, 2022.

Plan Trustee, Custodian and Recordkeeper

Reliance Trust Company (the “Trustee”), is the Plan’s investment trustee and T. Rowe Price Retirement Plan Services, Inc. (the “Custodian”) serves as the Plan’s Custodian and retains SS&C GIDS Systems Inc. to provide certain recordkeeping services for the Plan.

All employees of the Company, except for union and nonresidential alien employees, are immediately eligible to participate in the Plan upon hire. Eligible employees are automatically enrolled in the Plan at 5% of the employee’s eligible compensation, as defined. Employees may elect a different percentage or elect not to participate by notifying the Company or the Custodian.

Contributions

The Plan provides for pre-tax and Roth contributions expressed as a percentage of the participant’s eligible compensation or a fixed dollar amount and are not to exceed the limits set by the Internal Revenue Code (the “IRC”), which limits the annual amount of salary deferrals that may be made by a participant. Eligible participants may also make catch-up contributions upon attaining 50 years of age, as defined by the IRC. On the first day of each plan year, participants with an elective deferral percentage of at least 1% will be subject to an automatic deferred percentage increase of 1% annually, up to a maximum of 10%.

The Company makes a safe harbor non-elective contribution of 3% of a participant’s eligible compensation to the Plan each year. All participants who are employed by the Company will receive an allocation of the safe harbor non-elective Company contributions made for that allocation period subject to Internal Revenue Service (“IRS”) compensation and deferral limits. The Company also may make a discretionary matching contribution to the Plan. No such discretionary matching contribution was made in 2024 or 2023.

The Company makes a discretionary non-elective profit sharing contribution of 2% of a participant’s eligible compensation to the Plan each year. All participants who are employed by the Company will receive an allocation of the discretionary non-elective profit sharing Company contributions made for that allocation period.

Additionally, the Company makes a new comparability profit sharing contribution to certain employees. The contribution for the allocation period is determined by calculating the difference between the maximum total employee and employer contributions allowed by the IRS (\$69,000 for 2024 and \$66,000 for 2023, not including catch-up contributions) and all contributions made by and to those employees for the Plan year, provided a gateway minimum contribution is allocated to all non-highly compensated employees, and certain Plan discrimination testing is passed.

Vesting

Participants are immediately vested at 100% in their pre-tax and Roth contributions, rollover contributions, discretionary safe harbor non-elective contributions and non-elective profit sharing contributions plus actual earnings. Participants are graded vested in discretionary Company matching contributions at 20% after one year of service, increasing 20% each year thereafter, with participants 100% vested after five years.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, and Plan earnings/losses, and at times, charged with an allocation of administrative expenses. Allocations are based on participant contributions, participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participants direct the allocation of their account balance in any of several investment options. Participants can change their investment options among the various investment funds either through direct transfers from one fund to another or by changing the percentage allocation of future contributions.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 from their fund accounts up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The loans are made for terms not to exceed five years unless the loan is used to acquire a principal residence, in which case, the administrator may permit a longer repayment term. Repayments of principal and interest are credited to the funds in which the participant's deferrals and employer contributions are invested.

Principal and interest are paid ratably through payroll deductions. The maximum number of loans that a participant may have outstanding at any one time is one. All notes receivable shall bear a reasonable rate of interest as determined by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances.

Benefit Payments

Participants are eligible for distributions of their vested account balances upon the event of death, disability, retirement, termination of employment, hardship, or the attainment of age 73. In-service withdrawals are permitted on or after participants attain age 59 ½ in accordance with Plan provisions.

Distributions may be made in lump-sum payments or installments. If the value of the participant's account is less than \$5,000, the Company can distribute the entire vested account balance. If the participant's account balance is less than \$5,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account established on behalf of the participant. Active employees who suffer a financial hardship may withdraw all or part of their vested account balance upon meeting the hardship provisions of the Plan. Any taxable distribution paid by the Trustee directly to the participant will be subject to mandatory federal income tax withholding of 20% of the requested distribution.

Forfeitures

Forfeitures represent excess employer contributions that are reconciled at year-end by the Trustee and reallocated to the forfeitures account. Forfeitures are used to pay Plan administrative expenses and may also be used to reduce future employer contributions. During 2024, forfeitures of \$900 were used to reduce employer contributions. As of December 31, 2024 and 2023, there were \$192 and \$886, respectively, in forfeitures available to be utilized.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make use of estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 regarding fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Unrealized appreciation or depreciation in the fair value of investments held at year-end is determined using the fair value at the beginning of the year or the purchase price if the investment is acquired during the year. The realized gain or loss on the sale of investments is determined using historical cost.

Upon the sale of an investment, the current year unrealized appreciation or depreciation is adjusted for unrealized gains and losses recognized in prior years. Unrealized appreciation or depreciation and realized gains and losses are reported as net appreciation or depreciation in fair value of investments in the statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured as their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants, if any, are reclassified as distributions based upon terms of the *Plan Document*.

Benefit payments

Benefit payments are recorded when paid.

Administrative Expenses

All administrative expenses, unless paid by the Company, are paid by the Plan. Investment related expenses are included in net appreciation in the fair value of investments. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Financial Instruments and Credit Risk

Financial instruments which potentially subject the Plan to credit risk include investments in mutual funds and a guaranteed investment account. Investments are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits. Plan participants bear the risk of any investment losses. As of December 31, 2024 and 2023, there were five investments that represent a concentration of greater than 10% of the Plan's net assets available for benefits.

Subsequent events

Management has evaluated subsequent events through September 10, 2025, which was the date that the financial statements were available to be issued and has determined that there are no subsequent events to be reported.

3. FAIR VALUE MEASUREMENTS

The Plan uses a three-level hierarchy, in accordance with the fair value standard, that establishes a hierarchy for grouping assets and liabilities, based on the significance of inputs. The hierarchy of fair value measurements is described below:

Level 1 - Quoted prices in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of these assets or liabilities; or

Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Money Market Fund and Mutual Funds: These investments are valued daily at the net asset value (“NAV”) of shares or units held by the Plan based on the quoted market prices of the underlying assets.

Collective Trust: This investment is measured at NAV. The NAV is calculated by the fund based on “net assets”, which include a fully benefit-responsive investment at contract value. This NAV represents the Plan’s fair value since this is the amount at which the Plan transacts with the fund. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value for the collective trust. The investment can be redeemed daily, has a daily redemption notice period, and has no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the valuation methods are considered appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. TAX STATUS

The Plan has adopted a prototype plan document, which obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of December 31, 2024 and 2023. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investment.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets would be allocated among participants of the Plan in accordance with the provisions of the Plan.
