Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of *Amkor Technology, Inc. 401(k) Plan* (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

1. Description of the Plan

The following description of the Amkor Technology, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Amkor Technology, Inc. (the “Employer” or “Company”) on the first day of the month following date of hire. The Plan is intended to comply with the applicable requirements of the Internal Revenue Code of 1986, as amended (the “IRC”) and the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Administration

The Company’s 401(k) Advisory Committee (the “Plan Administrator”), comprised of three or more employees, is the designated administrator of the Plan and has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan (excluding the authority and responsibility to invest, manage and control the assets of the Plan specifically allocated to the Plan trustee). The Employer contracted with The Vanguard Group, Inc. (“Vanguard”) and its affiliates to maintain participants’ accounts and to provide certain other record keeping and administrative services for the Plan. Vanguard Fiduciary Trust Company, (the “Plan Trustee”), holds the Plan’s investment assets and executes all investment transactions.

The Employer pays certain expenses incurred in the administration of the Plan. Such expenses are primarily comprised of legal, accounting and auditing fees.

Contributions

Participants may elect to defer up to 50% of their eligible compensation (as defined in the Plan) each year, subject to IRC limits. Participants may also contribute amounts representing eligible distributions from other qualified plans. Employees hired on or after April 2, 2008 have 60 days in which to elect a deferral percentage or opt out of participation in the Plan. If no affirmative election is received after 60 days of employment, Vanguard establishes an automatic deferral level of 4%, as defined by the Plan. Thereafter on each anniversary of the employee’s hire date, the deferral level is increased by 1%, until the deferral level reaches 10%, or the employee makes a different deferral election through Vanguard.

The Employer contributes non-discretionary matching contributions in an amount equal to 100% of each participant’s deferral contributions to the Plan, not to exceed \$10,000. Plan participants are eligible for Employer matching contributions on their date of hire.

Salary deferral agreements shall be made, terminated, or changed according to procedures and limitations set up by the Plan Administrator and the Plan. Participants currently entitled to receive retirement benefits from another qualified retirement plan may elect to transfer that benefit into a rollover contribution amount under the Plan. Participants may designate the percentage of their total contribution, including the Company’s matching portion, to be invested in any of the funds in which the Plan invests. Participants can change investment elections and contributions percentages at any time.

Participant contributions are recognized in the period during which the Employer makes the respective payroll deduction. Employer matching contributions are recognized as matched by the Employer with the participant contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, any qualified rollover contributions, Employer matching contributions and an allocation of Plan earnings or losses and administrative expenses, if applicable. Allocations of Plan earnings or losses are based on participant account balances. The benefit to which a participant is entitled is the balance of the participant’s vested account.

Withdrawals

While employed by the Company, participants must reach the age of 59 1/2 to withdraw Employer matching contributions. Participant contributions may be withdrawn at age 59 1/2; earlier withdrawals are subject to an additional 10% tax unless such withdrawals are made due to death, disability, severance of employment after age 55, or a financial hardship as determined by the Plan Administrator.

Vesting

Effective January 1, 2015, participants are immediately vested in their contributions, plus actual earnings (if any) thereon.

Rollovers

Participants are allowed to rollover balances from other qualified plans into the Plan.

Payment of Benefits

At termination of service, a participant may generally elect to leave their vested account balance in the Plan, or receive a lump-sum distribution of their vested account balance. If a terminated participant's vested account balance is between \$1,001 and \$5,000 the sum of the participant's vested account balance will be rolled over into a Vanguard IRA. If the terminated participant's vested account balance is \$1,000 or less, a lump sum distribution of the participant's vested account balance will automatically be made.

Investment Options

Assets of the Plan are held by Vanguard and are invested in the investment options available under the Plan based on instructions received from participants. The Plan offers a number of options for the investment of participants' accounts, including various mutual funds and a common/collective trust.

Administrative Expenses

Administrative expenses are payable from Plan assets, unless paid by the Employer or offset with revenue sharing payments received by the Plan Trustee from investment fund managers, as provided in the Plan. Revenue sharing payments are made from the total expenses paid by participants investing in the funds offered under the Plan. During 2024 and 2023, administrative expenses incurred by the Plan were \$131,082 and \$334,856, respectively, while those paid by the Employer were \$82,839 and \$80,745, respectively.

2. Summary of Accounting Policies

Basis of Presentation

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("US GAAP").

Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with US GAAP requires management to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants (“Participant Loans”)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses is recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan.

Risks and Uncertainties

As described in Note 1, the Plan provides for various investment options such as mutual funds and other investment securities. Such investments are exposed to various risks, such as interest rate, market, credit risks and increases in defaults. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of certain investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

3. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

Shares of registered investment companies (mutual funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments Measured at NAV

The Vanguard Retirement Savings Trust III (common/collective trust) is valued at NAV as reported by the sponsoring financial institution at December 31, 2024 and 2023. The NAV is determined by reference to the value of the underlying assets owned by the common/collective trust, minus its liabilities, and then divided by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value. The participants transact daily at NAV, with trades settling within two days. There are no unfunded commitments and there are no restrictions on redemption.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line item presented in the statements of net assets available for benefits.

4. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 (less their highest outstanding loan balance during the prior 12 months) or 50% of their vested account balance. Loan terms range from 1-5 years or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing market rates. Outstanding loans at December 31, 2024 carry interest rates ranging from 4.25% to 9.5%. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans are due and payable in full within 90 days of a participant’s termination of employment.

5. Plan Termination

Although it has not expressed any interest to do so, the Employer has the right under the Plan to terminate or modify the Plan at any time and for any reason subject to the provisions of ERISA.

Effective January 1, 2021, the Plan has adopted an amended and restated pre-approved defined contribution plan document (the “Pre-Approved Plan Document”). The Pre-Approved Plan Document received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020 stating that the Pre-approved Plan Document was designed in accordance with the applicable sections of the IRC. The Pre-approved Plan Document has been amended since receipt of the opinion letter. The Plan Administrator and the trustee of the Plan believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator analyzed the tax positions taken by the Plan, and concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Information Certified by the Plan Trustee

The related financial information summarized below and included in the accompanying financial statements and supplemental schedule is certified as complete and accurate by the Plan Trustee.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. 8. Party-In-Interest Transactions

Certain Plan investments were managed by the Plan Trustee in 2024 and 2023, and, therefore, transactions in these investments qualify as party-in-interest transactions. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

During 2024 and 2023, the Plan paid \$131,082 and \$334,856, respectively, to the Plan Trustee for administrative expenses.

The Plan also uses the consulting services of Cook Street Consulting, Inc., relating to review of investment offerings in the Plan, therefore these services qualify as party-in-interest. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. Cook Street Consulting, Inc. fees and additional expenses relating to 2024 and 2023 were paid by the Employer.
