## **SCOPE AND NATURE OF THE ERISA SECTION 103(a)(3)(C) AUDIT**

We have performed audits of the accompanying financial statements of Bayhealth Medical Center, Inc. Short-Term Disability Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

## **OPINION**

## **BASIS FOR OPINION**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We draw your attention to Note B of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

### **RESPONSIBILITIES OF MANAGEMENT FOR THE FINANCIAL STATEMENTS**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan's document for a more complete description of the Plan's provisions.

**General** - The Plan is a welfare benefit plan covering substantially all employees of Bayhealth Medical Center, Inc. ("Employer", "Plan Sponsor"). Full-time employees are eligible to participate in the Plan after completion of 90 or more days of active employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Matrix Trust Company (the "Trustee") is the trustee of the Plan during the plan years. Bayhealth controls and manages the Plan.

**Benefits** - The Plan provides short term disability benefits to employees determined to be eligible for benefits by the administrator of the Plan. Eligibility for benefits is based entirely on the criteria established in the Plan document and review of the medical records provided by the employee to the Plan's third-party administrator. Claims are paid to the eligible employees at the rate of 60% of their weekly earnings, up to an annual compensation rate of \$160,000. Claims are paid by the Plan's Trustee.

**Contributions** - The Plan is funded by after-tax employee ("Participant") contributions, deposited into the trust established for the Plan. The Employer, in its sole and absolute discretion, shall determine the amount of any required Participant contributions under the Plan. The Employer may require different contribution levels for different classes of employees. The Employer may change the amount of required contributions at any time. The contributory rate for the majority of participants was \$.70 for every \$100 earned. This rate is \$.75 for every \$100 earned for members of the Bayhealth Emergency Physicians Group, during 2024 and 2023.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Bayhealth Medical Center, Inc. Short-Term Disability Plan (the "Plan").

**Basis Of Accounting** - The accompanying financial statements are prepared on the modified cash basis whereby contributions are recognized when received rather than when earned, and expenses are recognized when paid rather than when the obligation is incurred. However, income on investments is accrued in the period in which it is earned and investments are reflected at fair value. Presentation of these financial statements is on the modified cash basis and is not intended to present the net assets or changes in net assets of the Plan in accordance with accounting principles generally accepted in the United States of America.

**Investment Valuation And Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Plan investments are recorded at fair value which is determined by the Trustee. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE B - SUMMARY OF ACCOUNTING POLICIES - CONTINUED

**Use Of Estimates** - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting periods. Actual results could differ from those estimates.

**Administrative Expenses** - Administrative expenses of the Plan are paid by either the Plan or the Plan sponsor, as provided in the plan document.

**Claims Payable And Claims Incurred But Not Reported** - The Plan's liability for claims is determined by the claims administrator and the plan administrator.

**Subsequent Events** - The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through August 28, 2025, the date the financial statements were available to be issued.

NOTE C - INVESTMENT INFORMATION CERTIFIED BY TRUSTEE

All information on investments in the Plan's financial statements and supplemental schedule was obtained or derived from information prepared by Matrix Trust Company.

NOTE D - BENEFIT OBLIGATIONS

Under the modified cash basis of accounting, benefits are not recorded as Plan deductions until paid. The estimated amounts of claims currently payable are as follows:

NOTE E - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

- Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 - Quoted prices in markets that are not active, or inputs which are observable, either directly or indirectly, for substantially the full term of the asset or liability;
- Level 3 - Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e., supported by little or no market activity).

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

**Registered Investment Companies (Mutual Funds)** - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE F - ADMINISTRATIVE EXPENSES

Fees paid by the Plan to the Trustee for investment management services were nominal in 2024 and 2023. Benefit claims were calculated by Matrix Absence Management and AON Group during 2024 and 2023, respectively. Fees paid by the Plan for benefit claims processing in 2024 and 2023 were approximately \$105,000 and \$93,000 in 2024 and 2023, respectively.

NOTE G - PLAN TERMINATION

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to amend and terminate the Plan subject to the provisions set forth in ERISA. In the event of termination, the Plan Sponsor will contribute the necessary amounts to fund all claims incurred prior to the date of termination.

NOTE H - TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant of Section 501(c)(9) of the Internal Revenue Code, and, accordingly, the Trust's net investment income is exempt from income taxes. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE I - RISKS AND UNCERTANTIES

The Plan invests in investment securities. These securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with these securities and the level of uncertainty related to changes in the value, it is at least reasonably possible that changes in the various risk factors will occur in the near term that could materially affect the amounts reported in the accompanying financial statements.
