## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Delap LLP Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Delap LLP Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

### 1. Description of the Plan

The following description of the Delap LLP Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established for the benefit of eligible employees of Delap LLP (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Fidelity Management Trust Company ("Fidelity" or "the Trustee") is the appointed custodian of the Plan's assets. Participants may direct their contributions into various investment options offered by the Plan. The Plan is administered by the Employer's partners and by a committee designated by the Employer's partners (the 401(k) Committee).

#### Eligibility

Employees who are at least 21 years of age – other than those who are covered by a collective bargaining agreement; "leased employees" as defined in the Internal Revenue Code (IRC); non-resident aliens; and certain temporary employees who have not completed 1,000 hours of service – are eligible to participate in the Plan. Qualifying employees may make elective deferrals to the Plan immediately upon meeting the eligibility requirements. Qualifying employees are eligible for Employer matching and profit sharing contributions on the first January 1 or July 1 after completing one year of service and 1,000 hours. In addition, participants must be employed on the last day of the Plan year to receive an allocation of Employer profit sharing contributions.

#### Contributions

The Plan includes a salary deferral provision which provides for both pre-tax contributions and after-tax Roth 401(k) contributions. Participants may elect to defer up to 60% of their eligible compensation, subject to current IRC limitations. Participants may make voluntary, non-deductible, after-tax contributions up to 5% of their eligible compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e., rollover contributions). In addition, participants have the option to make in-plan Roth rollover contributions.

The Employer is required to match 100% of each participant's contributions up to a maximum of 3% of the participant's eligible compensation, plus 50% of each participant's contributions that exceed 3% of the participant's eligible compensation up to a maximum of 5% of the participant's eligible compensation (i.e., the Employer's maximum safe harbor matching contribution is 4% of each participant's eligible compensation) as determined on an annual basis. The Employer, at its discretion, may make additional matching contributions. In addition, at the Employer's discretion, the Employer may also make profit sharing contributions. Discretionary profit sharing contributions are allocated to each participant's account on a proportionate basis of eligible compensation for the Plan year. Effective January 2023, the Employer began contributing the employer matching contribution after each pay period for participants who are not partners. Employer matching contributions for partners were completed by the end of April following the Plan year-end. Profit sharing contributions continue to be contributed by the end of each April following the Plan year-end.

#### Participant accounts

Each participant's account is credited (charged) with the participant's contributions and allocations of (a) the Employer's contributions, (b) Plan earnings (losses), and (c) administrative expenses. Earnings (losses) for each investment fund are allocated to participants' accounts based on the individual participant's account balance as compared to the total balance of the related investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately 100% vested in their voluntary salary contributions, rollover contributions, Employer safe harbor matching contributions, and the actual earnings (losses) thereon. Vesting in the Employer's discretionary matching and profit sharing contributions is based on years of service as follows:

In addition, upon death, disability, or retirement (later of age 59½ or fifth anniversary of the participant's employment commencement date), participants will immediately become 100% vested in their share of the Employer's discretionary contributions and the actual earnings (losses) thereon.

### Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts were approximately \$45,000 and \$104,000, respectively. At the Employer's discretion, forfeited accounts may be used to reduce future Employer contributions and/or to pay Plan expenses. During the years ended December 31, 2024 and 2023, approximately \$125,000 and \$30,000, respectively, were used to reduce Employer profit-sharing contributions. No forfeitures were used to pay Plan expenses.

### Notes receivable from participants

Participants may elect to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding participant note balance in the preceding one-year period. Notes receivable from participants are secured by the balances in the respective participants' accounts. Terms of notes receivable from participants range from one to five years, unless used to acquire the participant's principal residence, in which case the term may be extended up to 10 years. The notes receivable from participants bear interest at rates commensurate with local prevailing rates as determined by the Trustee. Interest rates on notes receivable from participants outstanding as of December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

### Benefits

On termination of service due to death, disability, or retirement, a participant (or their beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a specified period of time. For termination of service for other reasons, if a participant's vested account balance is \$1,000 or less, and the participant does not elect to receive a distribution, the Employer may direct the Plan to automatically distribute the participant's vested account balance in a lump-sum. Also, upon certain financial hardship conditions, participants may elect to withdraw part or all of their elective contributions, exclusive of the related earnings (losses). Upon reaching age 59½, participants may make in-service withdrawals of part or all of their vested account balance, including the related earnings (losses).

### Hardship and other withdrawals

Participants who are still employed by the Employer are permitted to take withdrawals from their accounts under certain financial hardship conditions, as described in the Plan document.

On July 16, 2024, the Plan elected to implement an optional withdrawal provision of the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0, that was effective on January 1, 2025. The new withdrawal types that may be elected by eligible participants include domestic abuse, emergency expense, qualified declared disaster, and qualified birth or adoption.

### Administrative expenses

At the Employer's discretion, administrative expenses of the Plan may be paid directly by the Employer; certain other administrative expenses may be paid by the Plan. Expenses that are paid by the Employer are excluded from the accompanying financial statements. Fees related to the administration of notes receivable from participants are charged directly to the related participants' accounts and are included in administrative expenses in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are offset against net appreciation or included in net depreciation in fair value of investments in the accompanying statements of changes in net assets available for benefits.

## 2. Summary of Significant Accounting Policies

### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment valuation

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's Trustee and investment adviser. See Note 4 for discussion of fair value measurements.

### Investment income recognition

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment is recorded.

### Payment of benefits

Benefits are recorded when paid.

### Subsequent events

The plan administrator has evaluated, for potential recognition or disclosure in the financial statements, subsequent events that have occurred through August 8, 2025, which is the date that the financial statements were available to be issued.

### 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by Management and agreed to or derived from information certified as complete and accurate by Fidelity.

### 4. Fair Value Measurements

GAAP defines fair value, establishes a framework for measuring fair value, and requires certain disclosures about fair value measurements. The hierarchy of fair value valuation techniques under GAAP provides for three levels: Level 1 provides the most reliable measure of fair value, whereas Level 3, if applicable, generally would require significant management judgment. The three levels for categorizing assets and liabilities under GAAP's fair value measurement requirements are as follows:

- Level 1: Fair value of the asset or liability is determined using unadjusted quoted prices in active markets (that the Plan has the ability to access) for identical assets or liabilities;
- Level 2: Fair value of the asset or liability is determined using inputs other than quoted prices that are observable for the applicable asset or liability, either directly or indirectly, such as quoted prices for similar (as opposed to identical) assets or liabilities in active markets and quoted prices for identical or similar assets or liabilities in markets that are not active; and
- Level 3: Fair value of the asset or liability is determined using unobservable inputs that are significant to the fair value measurement and reflect the Plan's own assumptions regarding the applicable asset or liability.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for the Plan's assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds* – The fair value of mutual funds is based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common and collective trust fund* - The Fidelity Managed Income Portfolio Fund is a common and collective trust fund and consists of fully benefit responsive investment contracts. The fair value of the common and collective trust fund is based on the NAV as a practical expedient calculated based on the quoted market prices of the underlying assets comprising units owned by the Plan. The Plan was not invested in the Fidelity Managed Income Portfolio Fund as of December 31, 2023.

### 5. Related Party Transactions

Certain of the Plan's investments are invested in funds offered by Fidelity. In addition, the Plan contracts with Human Investing for investment advisory services. Therefore, these transactions qualify as party-in-interest. The Plan made direct payments to Fidelity for administrative services of \$27,693 and \$29,478 for the years ended December 31, 2024 and 2023, respectively. The Plan made direct payments to Human Investing for investment advisory services of \$47,938 and \$40,307 for the years ended December 31, 2024 and 2023, respectively. Notes receivable from participants also qualify as party-in-interest transactions.

The Employer is the sponsor of the Plan and paid certain administrative expenses of the Plan during each of the years ended December 31, 2024 and 2023. In addition, the plan administrator and members of the 401(k) Committee are participants in the Plan.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

### 7. Tax Status

The Plan adopted a volume submitter defined contribution retirement plan (the Volume Submitter Plan) developed by Fidelity Management & Research Company (FMR) (an affiliate of the Trustee). The Internal Revenue Service (IRS) has determined and informed FMR by a letter dated June 30, 2020 that the Volume Submitter Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment instruments which are exposed to certain risks such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements and supplemental schedules.

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside trustee's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

The Plan invested in two mutual funds that accounted for approximately 33% and 29% of total Plan investments as of December 31, 2024 and 2023, respectively.

### 9. Differences from Form 5500

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are the result of different classification between line items. Total Plan assets are in agreement.
